Item # 5: [CONS 19-201](#) Approval of FY 2020 Measure B/BB Annual Paratransit Program Plan

Was the proposed Paratransit plan reviewed by the Paratransit Advisory Committee?

Yes. In addition to review by the Paratransit Advisory Committee, the FY 19-20 Program Plan was developed in consultation with the following community organizations: the Hayward Senior Center; the San Leandro Senior Center; the Castro Valley Senior Center; the Area Agency on Aging; Community Resources for Independent Living; Eden Housing; Kaiser medical social workers; St. Rose medical social workers, and; (5) Hayward Senior Mobile Home parks.

Has there been consideration of utilizing the Police Department's faith communities email group and/or the Chamber to get out the word about the City's paratransit services?

No, that is an excellent suggestion. The HOP is planning an expanded marketing campaign and will include the suggested organizations for outreach.

Are the expanded services for the proposed senior housing slated for Mission Seniors?

Yes. As the Mission Senior Paradise project is developed, the plan review will include consideration of paratransit services and site mobility.
