RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH THE PRESBYTERY OF SAN FRANCISCO TO ACT AS FISCAL SPONSOR TO FIRST PRESBYTERIAN CHURCH OF HAYWARD TO OPERATE THE YEAR-ROUND SHELTER AT SOUTH HAYWARD PARISH FOR FISCAL YEAR 2025-2026 FOR A NOT-TO EXCEED AMOUNT OF \$339,190

WHEREAS, beginning on December 1, 2018, First Presbyterian Church of Hayward (FPCH) offered emergency shelter services at its South Hayward Parish (SHP) location with funding support from the City; and

WHEREAS, from 2018 through 2021, the Winter Warming Center provided 18 nightly shelter beds during the fall and winter months, when temperatures fell below 45 degrees or there was a high chance of rain; and

WHEREAS, During these months, the shelter operated from 7 p.m. until 7 a.m. and provided dinner and breakfast services for its clients; and

WHEREAS, in support of this important work, Council awards a non-competitive annual allocation of \$25,000, through the Community Services Division's (CSD) operating budget; and

WHEREAS, On April 27, 2021, Council accepted American Rescue Plan Act of 2021 (ARPA) funds in response to the ongoing impacts of the COVID-19 pandemic and directed staff to develop a Federal Stimulus Expenditure Plan; and

WHEREAS, on July 13, 2021, Council approved the City of Hayward Federal Stimulus Expenditure Plan and Let's House Hayward (LHH) Strategic Plan, which detailed goals for reducing homelessness in Hayward and strategies and action steps required to achieve those goals, and

WHEREAS, one key action identified in both the Hayward Federal Stimulus Expenditure Plan and LHH Strategic Plan was expanding services at the Winter Warming Shelter to operate year-round and to open a day center so residents were not displaced during the day; and

WHEREAS, in October 2021, the shelter began offering expanded service hours to offer year-round shelter in South Hayward; and

WHEREAS, the shelter is a vital resource, and the Hayward Evaluation and Response Teams (HEART) routinely utilize SHP's shelter services; and

WHEREAS, to support the frequent collaboration between HEART and SHP and the need to provide shelter services to HEART clients who would otherwise be sleeping outside overnight, the HEART team budgeted \$250,000 to reserve four nightly shelter beds for HEART use as part of the FY 2025-2026 operating budget; and

WHEREAS, this guarantees four out of 23 shelter beds for City use at the only drop-in emergency shelter serving single adults experiencing homelessness in Hayward, with the beds becoming available to other clients after a daily cutoff time to avoid vacant beds; and

WHEREAS, through the Community Agency Funding process, the Community Services Commission recommended, and Council approved a competitive award to FPCH in the amount of \$169,190 for FY 2025-2026 emergency shelter operations; and

WHEREAS, FPCH continues to pursue funding options and is planning to leverage the City's contribution and other committed funds to request additional grant funding and apply for foundation and philanthropic funding sources to close the funding gap in FY 2025-2026; and

WHEREAS, the Presbytery of San Francisco is able and willing to be a fiscal sponsor and agent for FPCH to pass through funds to SHP's year-round shelter program;

NOW, THEREFORE, BE IT RESOLVED THAT, the City Council of the City of Hayward hereby authorizes the City Manager or their designee to negotiate and execute a professional services agreement with the Presbytery of San Francisco to act as fiscal sponsor to First Presbyterian Church of Hayward to operate the year-round shelter at South Hayward Parish for FY 2025-2026 for a Not-to-Exceed amount of \$339,190.

Dear Hayward City Council,

In the abundance of communication you receive from our community, we wanted to be sure this was in your pile - our collective and complete gratitude.

In 2024, South Hayward Parish ensured we had 21 fewer neighbors having to sleep outside each night, sheltering 416 unique individuals during the year. We served an additional 3,839 to-go meals to those we didn't have capacity to shelter each night. In total, we served 559 unique individuals in our shelter and resource center, and an additional 4,110 households through our food pantry. Our garden is thriving, the need for our pantry is persisting, and volunteers have been steady to help carry the work.

The beginning of this year has been one of transition for us. With new senior leadership and our operational priorities not being consumed with pandemic response, we are able to begin looking towards the future. We are restructuring our staff, professionalizing our systems, and in collaboration with our Presbytery, beginning to imagine a much-needed facility upgrade/building redevelopment at South Hayward Parish. In a time when community concern around Weekes Park continues, we're invested in this property being a hub for community care – for both our housed and unhoused neighbors.

Here we believe that no good work is carried alone. We could not serve our neighbors without your partnership, funding, collaboration, and care. We're grateful for your leadership of our city, and thank you for being in the work with us.




#### FROM OUR SENIOR PASTOR

### **Public Comment**



Subject: Urgent Safety Concerns – Underpass Area and Ongoing Vandalism

Dear Mayor and City Council Members,

I am writing to express serious concerns regarding the safety of our community due to repeated acts of vandalism and dangerous activity near our homes.

Recently, our families have experienced the following:

- Windows broken by rocks thrown from the underpass and nearby railroad tracks
- Fires intentionally set across the tracks, posing a threat to our homes and lives

These incidents endanger residents and could lead to serious injury due to:

- Shattered glass from broken windows
- Fire spreading to nearby homes
- Rocks could strike individuals, including children while walking dogs or children playing

We urgently request the following actions:

- Immediate fencing of the underpass area to prevent further vandalism and trespassing
- Increased police patrols in the neighborhood to deter criminal activity and ensure the safety of our residents

These measures are critical to protecting our community and preventing potential tragedies. We appreciate your prompt attention to this matter and look forward to your support.


