HAYWARD GEOLOGIC HAZARD ABATEMENT DISTRICT (GHAD) BOARD OF DIRECTORS MEETING

The Hayward Geologic Hazard Abatement District Board of Directors held its meeting and adjourned it at approximately 7:15 p.m. Mayor Salinas reconvened into the meeting of the City Council.

CITY COUNCIL MEETING

CLOSED SESSION ANNOUNCEMENT

The City Council convened in closed session on June 24, 2025, at 5:30 p.m., with six members present and no public speakers. Council Member Zermeño was absent, and Council Member Andrews absent after 6:00 p.m. The City Council discussed six items: 1) conference with legal counsel pursuant to Government Code section 54956.9(d) regarding Karina Etcheverry v. City of Hayward, et al. Alameda County Superior Court Case No. RG20068444; 2) conference with legal counsel pursuant to Government Code section 54956.9(d)(1) regarding Maria Gomez De Herrera v. Timothy Basilio and City of Hayward, Alameda County Superior Court Case No. 23CV046695; 3) conference with legal counsel pursuant to Government Code section 54956.9 (d)(2) regarding three cases; 4) public employment for Interim City Manager pursuant to Government Code Section 54957(b); 5) public employment pursuant to Government Code section 54957(b) regarding public employee dismissal/release; and 6) conference with legal counsel pursuant to Government Code Section 54956.9 (d)(1) regarding Jose Angel Nava, et al. v. City of Hayward, et al., Superior Court of the State of California, County of Alameda, Case No. 23CV048998.

Acting City Attorney Vigilia reported that the City Council discussed all items and took no reportable action, except for Items 2 and 5. Regarding Item 2, the City Council voted unanimously, with Council Member Syrop moving, Council Member Goldstein seconding and Council Member Zermeño absent, to approve settlement in the amount of \$150,000. Concerning Item 5, Dr. Ana Alvarez has resigned from her position with the City of Hayward

effective June 24, 2025. The City Council voted unanimously, with Mayor Salinas moving, Council Member Roche seconding, and Council Members Zermeño and Andrews absent, to accept the resignation. Dr. Alvarez will receive five months of severance which amounts to \$171,148.43, less applicable withholdings and deductions. The parting of ways was amicable and without cause.

Council Member Andrews joined the City Council meeting at approximately 7:24 p.m.

PRESENTATION

Mayor Salinas read a proclamation declaring June 2025 as LGBTQIA+ Pride Month in the City of Hayward. The following individuals received proclamations on behalf of their respective organizations: Dr. Jacob Miranda with CSUEB LGBTQ+ Staff and Faculty Association; Robert Lopez, Lead Prevention Specialist with Project Eden's Lambda Youth Project; Jesus Torres-Canales, Program Manager with LGBQIA+ Youth and Young Adult Drop-In Center; and Jayanti Addleman representing the City of Hayward.

PUBLIC COMMENTS

Irene Cruz, Hayward resident, shared she has incurred over \$5,000 in costs involving a tree on her property that was mistakenly classified as a City-owned; and requested that the City dismiss the notice of violation.

Carrie Oldes, Program Manager for Spectrum Community Services' Meals on Wheels, requested volunteer support for their Senior Meals Program, and encouraged those interested to contact them via their website - www.spectrumcs.org.

Christina Alves, Hayward resident, expressed concerns about ongoing vandalism involving windows broken by rocks thrown from nearby railroad tracks and fires set across the tracks; and requested the City consider installing fencing of the underpass area to prevent further vandalism and trespassing.

Novella Hicks, a neighbor of Ms. Alves, echoed similar concerns about property damage and safety due to repeated disturbances; and asked the City for support in addressing the situation.

Council Member Syrop made two announcements: 1) the South Hayward Market on June 26, 2025, at the newly renamed Stack Center (Matt Jimenez Community Center); and 2) the Hayward Night Market on June 28, 2025, at St. Rose Hospital with more information via Instagram.

Acting City Manager Lawson made three announcements: 1) the San Francisco Opera will present *Boheme Out of the Box*, an abridged one-hour version of *La Bohème*, and children's program at Heritage Plaza on June 28 and 29, 2025, 2) City commissions applications are being accepted through August 1, 2025, for City residents interested in serving the community with more information through the City Clerk's Office; and 3) the EarthCapades program aimed at inspiring children to connect with the earth on June 18, 2025 at the Hayward Library.

In response to Council Member Roche's inquiry about the training for the new energetic breaching equipment, Police Chief Matthews clarified that the training is included in the \$8,300 cost estimate, which covers both the tool and the necessary training.

In response to Council Member Syrop's inquiry about the most recent public input session, Police Chief Matthews responded that it took place during a Council Public Safety Committee meeting in May but had limited attendance and public feedback despite being promoted online.

Council Member Syrop raised concern over the high number of carbine rifles (113) given their cost and Police Chief Matthews explained that the number accounts for operational needs, training, annual maintenance, and replacements.

In response to Council Member Bonilla Jr.'s inquiry about the function of the energetic breaching tool, Police Chief Matthews explained that it uses a minimal amount of explosive material, typically plastic, cardboard, and detonation cord, tailored to breach various types of doors, enabling safe, remote entry without officers being physically present at the breach point.

Council Member Bonilla Jr. received confirmation that the federal government has no authority to direct Hayward PD's use of the energetic breaching tool. Police Chief Matthews emphasized the importance of local control and preparation for worst-case scenarios.

In response to Council Member Andrews' inquiry about the drone program and how Access Hayward is used to handle questions or complaints related to drone activity, Police Chief Matthews replied that no complaints have been received regarding the drone program, noted that all drone usage is publicly documented on the website, and added that many drones are privately owned and commercially available, encouraging the public to ask the department directly if they have concerns.

Mayor Salinas opened the public hearing at 8:44 p.m.

Theresa Rezendez, with Hayward Concerned Citizens, expressed support for the continued use of police equipment, including drones and the armored personnel carrier, noting their 100 uses over the past year as a positive indicator; and noted she specifically supported the acquisition of the energetic breaching equipment, citing the Uvalde, Texas school shooting as an example of why rapid and safe breaching capabilities are critical.

Suzanne, with Hayward Concerned Citizens, also voiced support for all the tools being proposed for use by the Hayward Police Department; highlighted the 40-hour training requirement for the energetic breaching tool; and reinforced the need for effective tools and resources.

Mayor Salinas closed the public hearing at 8:47 p.m.
