Updates Following Work Session Feedback







✓ Preservation of Native Trees on Private Property

- Ensure that removed native trees are mitigated
- Reduce replacement tree costs with 2:1 ratio for 2 trees or less removed
- Create sliding scale to reduce permit fees
- Add exemptions to waive permit fees for dead/dying or hazardous tree

✓ Heritage Tree Designation

- Defined a Heritage Tree (Meet 2 or more criteria): Native, Habitat, Horticulture, Historical or Cultural Significance
- Require Site Plan Review process for removal, allowing public notification and comment
- Additional findings added for removal

Ordinance Highlights

✓ Mitigation for Development Projects

- Maintain existing appraised value for mitigation
- Incorporate canopy replacement as part of development plan review process

✓ In Lieu Fees

- 125% of the appraised value
- Allow City to plant trees in underserved areas
- Fees could be used to plant new trees and maintenance of existing trees

✓ Tree Removal Penalty

- Double the Tree Removal Permit (sliding scale)
- Mitigation based on the estimated appraisal value

✓ Reduce Permit Duration

✓ Addition of a Guiding Appendix & Website

• 2 or less \$196

• 3 or more \$588

HQL-8.4: Urban Heat Island Effects.



• The proposed Text Amendments are categorically exempt from the CEQA per Section 15307 (Class 7) & 15308 (Class 8) of the CEQA Guidelines.


<u>Class 7:</u> actions taken by regulatory agencies as authorized by local ordinance to assure the maintenance, restoration, or enhancement of a natural resource where the regulatory process involves procedures for protection of the environment.

<u>Class 8</u>: actions taken by regulatory agencies as authorized by local ordinance to assure the maintenance, restoration, enhancement, or protection of the environment where the regulatory process involves procedures for protection of the environment.


• Class 7 and Class 8 Exemptions apply to the project because adoption of the updated TPO represents action taken by the City to maintain and enhance natural resources and the environment and establish procedures for protection.

Environmental Review - CEQA

- That the Planning Commission recommend City Council approval of the proposed Text Amendments of the Hayward Municipal Code Chapter 10, Article 15 to update the City's Tree Preservation Ordinance; approval of amendments of the 2026 Master Fee Schedule and Findings that the proposed amendments are exempt from the CEQA pursuant to Guidelines Section 15307 and Section 15308
- Following the Planning Commission public hearing and recommendation, staff will present the proposed Amendments to the City Council for consideration later this Summer. If adopted, staff will launch an extensive public outreach process to make the community aware of the updated requirements.
