Thence along a curve to the right having a radius of 29.00', with a radial line through said point bearing North 47°56'09' West, a distance of 18.51 feet through a central angle of 36°33'59" to a point on a non tangent curve to the left with a radius of 286.00 feet, with a radial line though said point bearing South 51°18'45" East;

Thence 39.97 feet along said curve through a central angle of 8°00'28" to a reverse curve to the right with a radius of 23.00 feet;

Thence 2.14 feet along said curve through a central angle of 5°19'25" to the centerline of Whitesell Street as shown on said Tract Map 3213 this point also being the POINT OF BEGINNING,
