

One-third of Hayward residents notice secondhand smoke in their homes at least weekly.


How frequently do you notice secondhand smoke drifting into your home?

Have you been exposed to secondhand smoke in common areas where you live, such as the laundry room, elevator, stairs, courtyard, lobby, or balcony?






Residents are primarily exposed to tobacco and marijuana smoke.

(Asked if Smoke Drifts Into Home Only; Multiple Responses Accepted; n=231)






A majority of those who experience secondhand smoke in their homes are extremely or very concerned about it.

(Asked if Smoke Drifts Into Home Only; n=231)






Attitudes Towards Multi-Unit Housing Protections

Four in five support the city taking action to protect multi-unit housing residents from secondhand smoke.




Q9. Would you support or oppose your city government taking action to protect people who live in multi-unit housing from secondhand smoke?

Conclusions

Conclusions

- Secondhand smoke is a prevalent problem, with a third of Hayward residents noticing secondhand smoke in their homes at least weekly. Close to half of residents say they are also exposed to secondhand smoke in common areas. Residents say the secondhand smoke in their homes is mainly coming from marijuana and tobacco products.
- A majority of those who experience secondhand smoke in their homes are extremely or very worried about it.
- Four in five support their city taking action to protect residents who live in multi-family residences from secondhand smoke. Three-fourths support action requiring all units to be 100% smoke- and vape-free.
- Majority support cuts across gender, age group, and ethnicity, and is strongest among homeowners, those who experience secondhand smoke most frequently, and those with medical conditions.
