RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT AND APPROPRIATE \$100,000 IN CALIFORNIA FOR ALL ANIMALS GRANT FUNDING AWARDED BY THE UNIVERSITY OF CALIFORNIA DAVIS, KORET SHELTER MEDICINE PROGRAM FOR USE BY THE HAYWARD POLICE DEPARTMENT'S ANIMAL SERVICES BUREAU

WHEREAS, the California for All Animals grant, administered through the UC Davis Koret Shelter Medicine Program, has made funds available for programs to reduce the euthanasia of healthy and treatable animals in shelters; and

WHEREAS, the UC Davis Koret Shelter Medicine Program awarded the Hayward Police Department's Animal Services Bureau funding in the category of Intake Management and Community Support, which includes keeping animals in their homes and communities of origin; and

WHEREAS, the UC Davis Koret Shelter Medicine Program previously awarded the Hayward Police Department's Animal Services Bureau \$55,000 to support Trap, Neuter, Return (TNR) activities that will help to reduce the number of cats born on the streets, stabilizing and eventually reducing cat populations, and keep feral community cats out of the shelter where they would be euthanized; and

WHEREAS, the UC Davis Koret Shelter Medicine Program has awarded the Hayward Police Department's Animal Services Bureau an additional \$100,000 in grant funds to further support the department's Trap, Neuter, Return (TNR) program; and

WHEREAS, using the additional awarded funds from the California for All Animals grant, the Hayward Animal Services Bureau will provide free TNR services for Hayward residents participating in TNR of community cats in their neighborhoods.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that the City Manager is hereby authorized and directed to accept and appropriate \$100,000 in California For All Animals grant funding awarded by the University of California Davis, Koret Shelter Medicine Program for use by the Hayward Police Department's Animal Services Bureau.
