RESOLUTION APPROVING AWARD OF CONTRACT FOR FY 2017 & FY 2018 PAVEMENT REHABILITATION PROJECT, PROJECT NO. 05205, 05207, 05209, 05266, 05212, 05245, & 05215 TO DESILVA GATES CONSTRUCTION LP

WHEREAS, by resolution on May 2, 2017, the City Council approved the plans and specifications for the FY 2017 & FY 2018 Pavement Rehabilitation Project, Project No. 05205, 05207, 05209, 05266, 05212, 05245, & 05215 and called for bids to be received on May 30, 2017; and

WHEREAS, by Addendum No. 1 the Engineer's Estimate was corrected to amount \$8,800,000.00 and the Project Description on the Notice to Contractors of the Specifications.

WHEREAS, on May 30, 2017, five (5) bids were received ranging from \$7,894,079.70 to \$9,539,823.90; DeSilva Gates Construction LP, of 11555 Dublin Boulevard, Dublin, California submitted the lowest bid in the amount of \$7,894,079.70, which is 10.35% below the Engineer's Estimate of \$8,805,411.73;

WHEREAS, this project is categorically exempt under Section 15301(c) of the California Environmental Quality Act Guidelines for the operation, repair, maintenance, or minor alteration of existing facilities; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that DeSilva Gates Construction LP, is the lowest responsible bidder whose bid complies with the specifications and is hereby awarded the construction contract for the FY 2017 & 2018 Pavement Rehabilitation Project, Project No. 05205, 05207, 05209, 05266, 05212, 05245, & 05215, for the amount of \$7,894,079.70, and in accordance with the aforementioned plans and specifications on file in the office of the City Clerk of the City of Hayward. All other bids are hereby rejected.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized and directed to execute the contract with DeSilva Gates Construction LP, in the name of and for and on behalf of the City of Hayward, in a form to be approved by the City Attorney.
