Proposal to Subdivide an Existing 0.15-acre site to allow for the construction of a 14-Unit Condominium building at 1289 Russell Way, for which a corresponding Site Plan Review and Density Bonus Application (Application No. 202205806) was previously approved in 2023, Requiring Approval of a Vesting Tentative Tract Map (VTTM) for Condominium Purposes (Tract No. 8762) and Finding that the Project is Categorically Exempt from the California Environmental Quality Act (CEQA) Pursuant to Section 15332 of the CEQA Guidelines. Applicant/Property Owner: Horacio Woolcott, 4WR LLC.
