### **PUBLIC COMMENTS**

Evelyn Oliveira, president of SEIU 1021 Clerical Chapter, expressed disapproval of the Council's decision to approve a CalPERS contribution increase in September 2024, which she stated violated prior agreements to delay the increase until January 2025; and urged Council to reconsider the implications of the action taken.

The following individuals urged the Council to implement a 100% smoke-free multi-unit housing policy, highlighting its benefits for air quality, fire risk reduction, community health including pets, and alignment with the City's 2024 Strategic Priorities; noted readiness among community partners to support drafting, implementation, and evaluation of the policy; and highlighted the impact of secondhand smoke on vulnerable populations.

Council Member Bonilla Jr. suggested that staff explore partnerships with AC Transit to manage ongoing maintenance while the City focuses on initial investments such as building benches or shelters.

Council Member Syrop clarified that AC Transit covers most of the costs associated with the City's bus shelters, with delays in improvements due to the need to secure an advertising partner to subsidize repair costs; highlighted that during the City's bus bench pilot, AC Transit funded an accessibility study while the City covered materials and labor for the benches, illustrating a partnership with shared responsibilities; and noted he would voice feedback at the next AC Transit meeting.

Staff report submitted by Director of Finance Gonzales, dated November 19, 2024, was filed.

Mayor Salinas noted the item was heard in the Council Budget and Finance Committee where Council Members Bonilla Jr., Syrop and himself serve, and waived staff's oral presentation.

Council Member Andrews expressed gratitude to the Economic Development team for their creativity in maximizing limited resources; acknowledged the impactful effort through social media and small business programs; and thanked all departments for effectively utilizing funds to keep the City moving forward.

Council Member Bonilla Jr. echoed earlier remarks, highlighting the City's effective use of over \$38 million in American Rescue Plan Act funds; emphasized the Council's commitment to rebuilding reserves to prepare for future emergencies; supported staff's recommendation, approved by the Council Budget and Finance Committee (CBFC), to allocate funds for this purpose; and expressed gratitude to staff and CBFC for their efforts in ensuring the City's financial resilience.

Council Member Syrop highlighted the importance of allocating \$4 million to rebuild City reserves; noted that transferring funds to the General Fund not only replenishes reserves but also provides greater flexibility by removing time constraints on their use; and acknowledged that \$2 million of the funds originally came from a housing program and urged the Council to prioritize housing needs and homelessness solutions with these funds in future projects.

Staff report submitted by Council Members Syrop and Andrews, dated November 19, 2024, was filed.

Council Member Syrop highlighted the idea of a StackPass Education Discount Program, an inclusive citywide discount program for students from various educational institutions, including colleges, vocational schools, and apprenticeship programs, was to stimulate Hayward's economy and reinforce its identity as an education city; emphasized the untapped potential of engaging students and their families as customers; raised concerns about the staff's analysis, arguing it overcomplicated the project, which was a simpler request requiring fewer resources; defended the role of members of City Council in engaging businesses for initiatives and shared positive feedback from business owners; and noted he would continue to find a way to develop the idea independently.

Council Member Andrews expressed support for the discount program, commending its inclusivity of businesses across the city and its recognition of diverse educational institutions, including apprenticeship programs; noted she was interested in reviewing the alternatives identified by staff; and encouraged revisiting the program during the City's
