

MINUTES OF THE CITY COUNCIL MEETING OF THE CITY OF HAYWARD

Council Chambers 777 B Street, Hayward, CA 94541 Tuesday, June 6, 2017, 7:00 p.m.

The City Council meeting was called to order by Mayor Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Council Member Mendall.

CITY COUNCIL REPORTS, REFERRALS, AND FUTURE AGENDA ITEMS

In response to Council Member Márquez's inquiry about an e-mail in opposition to the Trump administration's withdrawal from the Paris Agreement, the Council concurred for the Mayor to send a letter.

CLOSED SESSION ANNOUNCEMENT

Mayor Halliday announced the City Council convened in closed session regarding two items: 1) a conference with labor negotiators pursuant to Government Code 54957.6, regarding all groups; and 2) public employment pursuant to Government Code 54957 regarding performance evaluation for City Manager, City Attorney, and City Clerk. There was no reportable action.

PUBLIC COMMENTS

Mr. Jim Drake, Hayward resident, expressed concern about the City's budget deficit.

Mr. Luis Reynoso, Hayward Unified School District Board Vice President, was distraught about the inappropriate taco illustration in an official City tweet that announced a Council meeting to discuss the sanctuary city designation.

Mr. Charlie Peters, Clean Air Professionals representative, spoke about various items and submitted a document for the record.

Ms. Wynn Grcich, Hayward resident, announced the Children's March for Humanity on June 17, 2017 in Oakland, and spoke about an article regarding the atrazine herbicide.

Ms. Lyanne Mendez, Assembly Member Quirk's Senior District representative, distributed information about the 2017 legislative proposed package bills and summer mobile "Pop-Up" office hours.

Mr. S.J. Samiul (aka Citizen Sam), Hayward resident, spoke about a road rage incident and they solution to global warming.

LEGISLATIVE BUSINESS

1. Adoption of a Resolution Declaring the City of Hayward a Sanctuary City and Review of Proposed Administrative Rule 1.10 (Report from City Manager McAdoo) **LB 17-021**

Staff report submitted by Assistant City Manager Hurtado, Assistant to the City Manager Korth, Management Analyst Davis and Management Analyst Thomas, dated June 6, 2017, was filed.

Mayor Halliday and City Manager McAdoo addressed the unintentional taco illustration posted in an official City tweet to announce a Council meeting to discuss a sanctuary city designation, and apologized for the inappropriate tweet. Council Member Márquez noted that the Council had spoken with the City Manager about holding an unconscious bias training.

City Manager McAdoo provided a synopsis of the staff report.

Discussion ensued among Council Members and City staff regarding: grants that could potentially be jeopardized by a sanctuary city designation such as the One Bay Area Grant (OBAG); federal rule 8 U.S.C. 1373; the term "Americans" in the first clause of the resolution; unincorporated areas of the county and how they would not be impacted by the sanctuary city designation; the Hayward Unified School District declaration of sanctuary district; and the recommendation proposed by The Hayward Collective and staff's analysis.

Mayor Halliday opened the public hearing at 7:52 p.m.

Alameda County Board Supervisor Richard Valle read a letter on behalf of Bishop Macklin, and announced there was about \$1.5 million geared towards a 24/7 free hotline (510) 241-4011 for individuals facing deportation with no legal representation.

Mr. Frank Burton, Community Taskforce member, noted the Hayward Area Democratic Club passed a resolution in favor of declaring Hayward a sanctuary city; and clarified that the Taskforce recommended on April 19, 2017, that the Council declare Hayward a sanctuary city.

The following individuals spoke in firm support of the proposed resolution declaring Hayward a sanctuary city because it represented solidarity, it was a symbolic action, and it would protect a vulnerable population.

Mayor Halliday closed the public hearing at 9:38 p.m.

The City Council thanked the public for their attendance and participation, the Community Taskforce and City staff for their work around the sanctuary city designation, and the Hayward Police Department for its current immigration policies and practices.

Council Member Márquez offered a motion per staff recommendation with the following amendments: (1) amend the fifth clause on page five of the resolution by inserting the word "in" before "jail"; (2) amend the resolution per the recommendations offered by The Hayward Collective that were approved by staff as follows: a) change "shall not actively" to "shall not" on page two of line one, b) remove line five on page three, and d) include the following language in the resolution where appropriate, "The City will mobilize local resources and utilize respective bodies to host and sponsor immigrant rights workshops, legal counseling for paths to citizenship and immigrant workers rights"; and (3) ask current Community Taskforce members if they want to continue serving on a subcommittee to monitor the sanctuary city designation and give new members (four) the opportunity to serve on the subcommittee.

Council Member Zermeño seconded the motion and offered a friendly amendment to change the first clause of the resolution by changing the term "Americans" with "people."

Council Member Salinas supported the motion, and asked that the Community Taskforce recommendations regarding the Anti-Discrimination Action Plan ensure that incidents such as the inappropriate tweet do not occur again.

Mayor Halliday, Council Member Mendall, Lamnin, and Peixoto supported the motion and the friendly amendments.

It was moved by Council Member Márquez, seconded by Council Member Zermeño, and carried unanimously, to adopt the resolution with amendments as follows: (1) amend the fifth clause on page five of the resolution by inserting the word "in" before "jail"; (2) amend the resolution per the recommendations offered by The Hayward Collective that were approved by staff as follows: a) change "shall not actively" to "shall not" on page two of line one, b) remove line five on page three, c) include the following language in the resolution where appropriate, "The City will mobilize local resources and utilize respective bodies to host and sponsor immigrant rights workshops, legal counseling for paths to citizenship and immigrant workers rights"; (3) change the term "Americans" with "people" on page one of the first clause; and (4) ask current Community Taskforce members if they want to continue serving on a subcommittee to monitor the sanctuary city designation and give new members (four) the opportunity to serve on the subcommittee.
