RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH FIRST PRESBYTERIAN CHURCH OF HAYWARD FOR FISCAL YEAR 2021-2022 WINTER WARMING SHELTER EXPANSION AND DAY-RESOURCE CENTER AT SOUTH HAYWARD PARISH FOR AN AMOUNT NOT-TO-EXCEED \$1,644,314

WHEREAS, the bill from the House of Representatives (H.R. 1319) was passed by the Senate of the United States on March 6, 2021 as the “American Rescue Plan Act of 2021” (ARPA); and

WHEREAS, ARPA provides \$350 billion to help states, counties, cities, and tribal governments cover increased expenditures, replenish lost revenue and mitigate economic harm from the COVID-19 pandemic; and

WHEREAS, local Governments (City and County) shall receive \$130 billion in entitlements under ARPA, with City Funding estimated at \$65 billion in total entitlements; and

WHEREAS, the City of Hayward is estimated to receive an entitlement in the amount of \$38,232,335, received in two equal tranches of payments over the next 12 months; and

WHEREAS, the Hayward community has suffered significant impacts related to the COVID crisis, including COVID-related illness and deaths, temporary and permanent business closures, loss of jobs, increased crime, blight, and illegal dumping, and increased housing instability and homelessness; and

WHEREAS, the City of Hayward, in partnership with Alameda County, funds First Presbyterian Church to operate the South Hayward Parish Winter Warming Shelter which, at present, provides nightly (7pm – 7am) winter shelter services from November through June and has a nightly capacity of 18 individuals; and

WHEREAS, expanding the Winter Warming Shelter to a year-round shelter with day-resource center at South Hayward Parish was identified as a high priority through the Let’s House Hayward! Community engagement process and best practice research; and

WHEREAS, providing winter temporary shelters and expanding emergency shelter sites in Hayward is a strategic project as identified in the City of Hayward Strategic Roadmap.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward hereby authorizes the City Manager to negotiate and execute the FY21-22 agreement between the City and First Presbyterian Church of Hayward for Winter Warming Center Expansion and Day-Resource Center at South Hayward Parish for an Amount Not-to-Exceed \$1,644,314.
