


Project Site




- Existing 1,220 square foot vacant commercial building on a 0.51-acre site



Hayward Automobile Rental Businesses



- Rental vehicles may only be parked in the designated rental vehicle display parking spaces show on project plans.
- Vehicle cleaning is limited to hand washing and vacuuming of inventory vehicles only, conducted exclusively within the enclosed wash pad.
- No vehicle detailing, automotive repairs, or painting will be performed on site.
- Install a six-foot decorative metal fence along the eastern and southern property lines.

Conditions of Approval



General Plan Conformance



- ✓ Economic Development Policy ED-1.11: The City shall encourage the establishment and expansion of commercial businesses that increase local spending within Hayward and provide needed goods and services to local residents and businesses.
- ✓ **Land Use Policy LU-1.4:** The City shall encourage property owners to revitalize or redevelop abandoned, obsolete, or underutilized properties to accommodate growth.
- ✓ **Land Use Policy LU-1.6:** The City shall encourage the integration of a variety of compatible land uses into new and established neighborhoods to provide residents with convenient access to goods, services, parks and recreation, and other community amenities.
- ✓ **Land Use Policy LU-3.2:** The City shall encourage the development of neighborhood amenities and complimentary uses in central locations of the neighborhood whenever feasible.

STAFF RECOMMENDATION:

That the Planning Commission approve the proposed Conditional Use Permit with Site Plan Review to operate an automobile rental business with a car washing operation based on the draft findings and subject to the recommended conditions of approval
