RESOLUTION APPROVING ADDENDUM NO. 1 AND NO. 2 FOR THE FIRE STATIONS 2-5 LANDSCAPE IMPROVEMENTS PROJECT, PROJECT NOS. 07476, 07477, 07478, AND 07480 AND AWARDING THE CONTRACT TO LOS LOZA LANDSCAPING

WHEREAS, by resolution dated May 21, 2019, the City Council approved the plans and specifications for the Fire Stations 2-5 Landscape Improvements Project, Project Nos. 07476, 07477, 07478, and 07480, and called for bids to be received on June 18, 2019; and

WHEREAS, on June 6, 2019, Addendum No. 1 was provided to make clarifications to the plans and specifications; and

WHEREAS, on June 12, 2019, Addendum No. 2 was provided to make clarifications to the plans and specifications; and

WHEREAS, on June 18, 2019, four bids were received, ranging from \$198,569 to \$359,416.80; Los Loza Landscaping, of Hayward, California submitted the low bid in the amount of \$198,569, which is 13.7% below the Engineer's Estimate of \$230,000; and

WHEREAS, the Administrative Change Order (ACO) or contingency budget of \$19,856.90 was not disclosed; and

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Hayward that Los Loza Landscaping is hereby awarded the contract for the Fire Stations 2-5 Landscape Improvements Project, Project Nos. 07476, 07477, 07478, and 07480, in an amount not to exceed \$198,569, in accordance with the plans and specifications adopted therefore and on file in the office of the City Clerk of the City of Hayward at and for the price named and stated in the bid of the hereinabove specified bidder, and all other bids are hereby rejected.

BE IT FURTHER RESOLVED, by the City Council of the City of Hayward that the Director of Public Works is authorized to expend up to \$282,426 for project design, construction, construction contingency, construction administration, permit fees, inspection, and testing to complete the project.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to execute the contract with Los Loza Landscaping in the name of and for and on behalf of the City of Hayward, in a form to be approved by the City Attorney.
