City of Hayward: Mayor Salinas shared his story about how he ran for mayor in 2014. It was a big risk for him because if he did not win, he would lose his seat in his commission. On election night, he thought he would win but was sadly met with a loss by 724 votes. He had to go upstairs and clean out his office. He ran again in 2016, got back on the city council, and then eventually became Mayor of Hayward.

Mayor Salinas shared another agency report on how an attorney recently sued the city, school district, and park district, claiming it was problematic that an Asian American person could run for a seat in the Hayward City Council seat and win. Because of this lawsuit, Hayward has had to move from at large elections to district elections. The goal of attorneys like these is to make money through frivolous litigations, which are bad motions that ultimately make money for case maker. Luckily, Hayward has settled for around 100k while other cities like Santa Monica have let the case run to 22 million dollars.

HUSD: Advisor Maya Hernandez spoke about a new anti-hate speech board policy that will be passed soon. This policy is based on hate speech, mainly focusing on the N-word. She shared that there will be meetings where students can share their point of view regarding the policy. Another topic she spoke about was that a Healthy Kids survey will soon be sent out to sense the level of safety and well-being in HUSD schools. 9th and 11th graders will be given the opportunity to participate in this survey.

HARD: Advisor Jen Tibbetts shared upcoming events available for all members. This Saturday, there will be a volunteering event called Make a State Park in Meek Park from 9-12. There will also be an upcoming pumpkin patch event at the Plunge on October 19 from 1:30-3:30. There is also a HARD outdoors event where commissioners can expect to ride on bikes and explore the outdoors. Email Jen for details.
