Esther's store will not only bring convenience but also peace of mind, knowing it's operated by someone who genuinely cares about helping people in a safe, responsible, and educational way.





To Whom It May Concern:

The size of the former Walgreens located at 21463 Foothill Boulevard represents what is commonly referred to as an "in-betweener" space which is to say that it is too large for small retailers and too small for large retailers. This reality coupled with the dual impact of e-commerce and security concerns manifested in a very difficult quest for a new tenant to back fill the Walgreens vacancy.

The rise of online retail, particularly through Amazon and similar platforms, has significantly reduced demand for traditional retail spaces nationwide. Within Hayward the CVS has remained vacant for quite some time, with no viable tenants emerging. This trend is not isolated, national retailers such as Rite Aid filed bankruptcy, Walgreens, Dollar General, Advance Auto Parts, Family Dollar, Boot Barn, and LL Flooring to name a few have announced plans to reduce their brick-and-mortar-locations across the country. The resulting oversupply has placed additional strain on the local commercial real estate market. Case in point we vetted numerous small retailers and food markets but were never comfortable with their ability to meet the obligations of a long-term lease.

While we were initially cautious about leasing the site for cannabis-related use and in fact had turned down offers from other dispensary tenants, our extensive due diligence determined that Phenos the prospective tenant had a strong record of successful operations in many other cities. Based on their track record, we believed their presence would significantly improve the foot traffic of the property and their additional security would help control some of the issues Walgreens was experiencing with the homeless and vagrants loitering around the center which negatively affected other tenants in the center.

It is our understanding that the tenant has already invested more than \$100,000 in advanced video surveillance and security systems, which has noticeably reduced loitering and improved safety in and around the property.

Should this tenant not receive approval, it is our professional opinion that the site will likely remain vacant for an additional extended period.

Given these realities it would seem to be in the best interest of the City of Hayward to approve the Phenos CUP. Approval would have significant economic and community benefit to the City and would ensure that the property does not sit empty causing blight on one of the heaviest trafficked thoroughfares in Hayward.

Hayward has encouraged women entrepreneurs to bring their dreams of being business owners to our city. In 2017, Esther Lopez applied for a permit to open a Cannabis dispensary in Hayward, CA which would bring a significant amount of revenue to our city. Hayward granted that permit in 2017. Ms. Lopez secured a location on B Street between Foothill Blvd. and Second Street. Hayward approved that location. Unfortunately, the Landlord of that building attempted to gouge Ms. Lopez by raising the rent and had the audacity to expect a percentage of the profits because of the type of business it is. Ms. Lopez decided to seek an alternative location. None of the other locations were obtainable nor were they suitable due to reasons such as not being in the areas designated by the City of Hayward, too close to schools, excessive rental costs (due to attempted gouging) and so on.

During the process of attempting to establish and open her dispensary, Ms. Lopez complied with every requirement to satisfy the city. Some of those requirements were Traffic Surveys, Security, and Permits. She also hired consultants to assist in the process to comply with local requirements to be able to open. She did this at her own expense.

Here we are in the latter part of 2025, yet Ms. Lopez hasn't been able to open the dispensary due to the reasons stated above. During this lengthy process, Ms. Lopez has partnered with a well-established dispensary, Phenos. With the help of that team, she has been able to secure the location of the former Walgreen's located at 21463 Foothill Blvd. However, there are the concerns of the community that have halted her progress to become the first woman owned and operated cannabis dispensary in Hayward.

Let's address some of those concerns.

- 1. The Children: Ms. Lopez takes the safety and well-being of our youth very seriously. There will be no obvious signage indicating that this location is a cannabis dispensary. Security guards will be located outside to keep foot traffic moving from the premises. No underage people can enter the building unless they have a legitimate prescription from a medical provider. It is up to us as parents to be honest and educate our children about the many uses and benefits of marijuana especially the medicinal use, not just the recreational use. Not everyone is a recreational pothead.
- 2. Homeless/Transient: Our homeless residents will most likely not patronize the dispensary for the simple fact that they do not want to be tracked. To enter the dispensary, consumers will be required to present California photo identification. Also, due to the security systems already set in place, there has already been a decline in loitering at that location.
- 3. Crime: Ms. Lopez has established a relationship with local law enforcement and has implemented a high-quality security team that would be on the premises as well as a high-quality security monitoring system to deter criminal activity.
- 4. The Line to get in: People will not be lined up on the sidewalk to get inside. This location is big enough that upon entering the building, patrons will go to a reception area to have their I.D scanned. After that they will go directly inside where an "airport security" type line is formed. After purchase clients leave the building and parking lot. Security will enforce this.
- 5. Parking and Traffic: These concerns will most likely be like what Walgreen's had except that the dispensary patrons won't be spending a

long amount of time at the dispensary. It's, go inside, get your product and leave.





I was president of the Hayward Chamber of Commerce when Hayward initiated its cannabis business approach to include licensing for distribution, cultivation, laboratory, and retail. The chamber in Hayward, as well as the state chamber in Sacramento, warned about the unrealistic expectations for revenue from this industry and those predictions were bome out. As I'm sure you know, in LA County, alone, more than \$400 million in back taxes is owed by cannabis businesses as the result of over regulation, over taxation, and resentment over lack of support. My counterpart in Mendocino County told me that legalization there has caused the black market to thrive.

Hayward's initial idea was to issue 20 business licenses in the various categories, and only one of them, Hayward Station (now Cookies) had an individual who lived here who they found to be their representative. Having evaluated dozens of prospects (because most of them came to the chamber), no other cannabis-related business applicant has a Hayward connection except for that of Esther Lopez, originally proposing an enterprise known as Aunty Honeys.

As I testified before the Hayward City Council and you can affirm with Jeremy Lochirco, none of these other applicants were known to anyone in Hayward except for Esther, who runs a business center on Tennyson and a fiscal help enterprise, Top Tier Financial. She also had an extraordinary record of philanthropy here, especially to young students preparing for the school year.

The council's original intent was to encourage cannabis businesses with a Hayward connection and, so far, she has been the only local resident to step forward, with a true record of service to our city. I encourage you to do all you can to help this local investor with what she needs to fulfill the original intent of the city's cannabis ordinances to find someone locally that could bring this type of retail business to Hayward.
