To the Honorable Members of the Hayward Housing Policy & Resource Committee:

I grew up in Hayward and spent much of my adulthood there as well, living in various parts of the city much of my life with my entire core family. I've also spent many years since law school working to mitigate the societal damage of the tobacco industry. In more recent years I've been working in Alameda and other Bay Area counties to make the quality of life healthier for our neighbors.

I am writing to express my unequivocal support for the proposed Smoke-Free Multi-Unit Housing (SFMUH) ordinance under consideration on September 18, 2025. This policy is not only overdue—it is essential. Hayward residents deserve the basic human right to breathe clean air in their own homes, free from the toxic intrusion of secondhand smoke, whether from tobacco or marijuana.

The science is irrefutable: secondhand smoke is a deadly pollutant. It seeps through walls, ventilation systems, and shared spaces, placing children, seniors, and individuals with chronic health conditions at constant risk. In multi-unit housing, one resident's smoking habit becomes every neighbor's health hazard. Hayward's current lack of protections is a glaring public health failure—and this ordinance is the remedy.

We urge the Committee to adopt a comprehensive policy that includes:

- 100% smoke-free coverage of all types of smoke—tobacco and marijuana alike
- Protections for individual units, patios, balconies, and all indoor/outdoor common areas
- Applicability to both rental and owned properties, including apartments, condos, and townhomes

This is not a matter of personal preference—it is a matter of public safety, equity, and environmental justice. Residents in multi-unit housing, often those with the fewest housing options, should not be forced to choose between shelter and respiratory health. **The onus should never be on the victims of passive smoke to relocate. They may be wheelchair bound, young children, seniors and/or immune-compromised. They're entitled to fresh air, especially when smokeless options for both tobacco and cannabis abound, if neighbors must consume it.**

We call on Mayor Salinas, Councilmember Syrop, and Councilmember Goldstein to lead with courage and clarity. Pass this ordinance without delay, without dilution, and without compromise. Hayward must join the growing number of California cities that recognize smoke-free housing as a cornerstone of community wellness.

Dear Mayor Salinas and members of the Housing Policy & Resource Committee,

Americans for Nonsmokers' Rights is writing to express our support for a 100% smokefree multi-unit housing ordinance to protect the health and safety of Hayward residents. **Taking action on this important public health issue will help ensure everyone's right to a smokefree living environment.**

Hayward has the opportunity to be a public health leader by protecting your residents from the harmful effects of secondhand tobacco and marijuana smoke by prohibiting smoking in all multi-unit residences, including apartments and condominiums. Smokefree multi-unit housing is a powerful way to have a broad, positive community impact by reducing secondhand exposure where people spend much of their time—especially children, elderly people, and people with disabilities—and can suffer from persistent levels of exposure.

An effective ordinance includes a definition of smoking that is inclusive of cannabis and the use of vaping products, which is very important given that exposure to all types of secondhand smoke, and aerosol from vaping products, poses health risks to residents. Likewise, a comprehensive definition of smoking facilitates compliance because it is easier to understand, communicate, implement, and enforce a policy when all types of smoking and vaping are treated equally.

In particular, 2025 survey results show that **Hayward residents** who live in multi-unit housing and experience drifting secondhand smoke, **55%** are exposed to secondhand tobacco smoke and **59%** are exposed to secondhand marijuana/cannabis smoke. This data confirms that Hayward should treat the smoking and vaping of tobacco and cannabis equally, given that your multi-unit residents are suffering from both types of exposure in their homes.

Likewise, an effective ordinance should regulate smoking in both rental and owner-occupied properties, because drifting secondhand smoke does not discriminate based on whether residents rent or own their unit. Everyone living in multi-unit residences, regardless of their financial situation and ownership status, deserves to breathe smokefree air at home.

Hayward would be in good company by joining more than 100 California cities and counties that have enacted laws restricting smoking in multi-unit housing. We hope Hayward will join your neighbors Berkeley, Emeryville, Albany, Alameda, and unincorporated Alameda County, in **following the best practice language** of requiring all multi-unit properties with 2 or more units to be 100% smokefree indoors—both rental units and condominium/owner-occupied units—including vaping and cannabis.

Action needs to be taken on this issue because secondhand smoke does not stay in the unit of a person who smokes. **Secondhand smoke can drift through multi-unit buildings** and enter common areas and units occupied by non-smokers, where it becomes a nuisance and health risk to other residents. Research shows that up to 65% of the air in an apartment unit can come from other units in the building, and that secondhand smoke drifts under doors, through windows, hallways, and ventilation ducts, and through gaps around outlets, pipes, fixtures, and walls.

The 2024 U.S. Surgeon General's Report found that "tobacco-related health disparities are a social injustice, in addition to an economic and health burden" and that **inequitable smokefree protections for people living in multi-unit housing contribute to disparities** in exposure to secondhand tobacco smoke. The report also found that exposure to secondhand tobacco smoke remains disproportionately high among children, African Americans, families in lower income groups, and adults without college diplomas, and concluded that **smokefree policies for multi-unit housing would reduce disparities** in smokefree protections and reduce exposure to secondhand tobacco smoke.

The U.S. Surgeon General has long confirmed that there is **no risk-free level of exposure to secondhand smoke**, and that exposure can have both short and long term health risks, especially for people with health conditions like asthma and other respiratory conditions, heart disease, and cancer. Studies show high rates of exposure to secondhand smoke in low-income multi-unit housing, and lower-income individuals are also more likely to have health conditions that are exacerbated by secondhand smoke.

Taking action to adopt a local ordinance for smokefree multi-unit buildings creates a healthier living environment for all residents, including people who smoke and their families. It's important to note that a smokefree building does not mean that people who smoke have to quit and it does not require people who smoke to move out. People simply need to go outdoors to appropriate areas to do so.

All multi-unit residents in Hayward deserve a stable and healthy living environment, including the right to breathe smokefree air at home.

Dear Hayward Smoke-Free Multi-Unit Housing Committee,

I am writing to formally bring to your attention an ongoing and extremely burdensome issue with secondhand smoke exposure in my housing community on Craven Court. For over 15 years, my next-door neighbor has continuously smoked on their property, and because our doors are only about six feet apart and our back patios are joined, this activity directly affects my household in an unavoidable and harmful way.

The impact on my family has been severe:

Health Concerns: I have asthma and a heart condition, both of which are aggravated by exposure to secondhand smoke. My children are also forced to inhale this harmful and unpleasant cigarette odor, which raises serious concerns for their long-term health and well-being.

Loss of Comfort and Use of My Home: During hot summer and spring days, I am unable to open my doors or windows without cigarette smoke entering my home. This has made my living environment suffocating and uncomfortable, depriving me and my family of fresh air and peaceful enjoyment of our residence.

Violation of Law: As you are aware, Alameda County law prohibits smoking within 25 feet of doors, windows, and common areas in multi-unit housing. This law has been consistently broken for years by my neighbor, with no regard for the health and rights of surrounding tenants.

This is not a minor inconvenience—it is a persistent violation that has become an overwhelming burden. I believe there must be stronger enforcement, including fines and penalties for violators, to ensure compliance with existing smoke-free housing laws. Without proper enforcement, families like mine are left without protection, suffering year after year from exposure to toxic and disgusting cigarette smoke.

After more than a decade of enduring this, I respectfully urge your committee to take immediate action to address this violation and fully prohibit smoking in all multi-unit housing. Such a measure would finally allow families like mine to live in peace and health within our own homes.

Thank you for your time, attention, and commitment to protecting the health and well-being of Hayward residents. I look forward to your response and to seeing these laws upheld for the safety of my family and community.

Dear Mayor Salinas, Mayor Pro Tempore Julie Roche, and Hayward City Council,

I am endorsing the following positions regarding a smoke-free multi-unit housing policy in Hayward:

SUPPORT protecting the health of Hayward multi-unit housing residents via an 100% smoke-free multi-unit housing policy that includes:

- Tobacco, vaping, and cannabis secondhand smoke
- Inside multi-unit housing units, on exclusive use patios and balconies, and in indoor/outdoor common areas
- Rented and owned multi-unit housing

The 2023 Census data for Hayward shows the need for a comprehensive smoke-free multi-unit housing policy for residents with 34% of the city's households live in complexes with 2 or more housing units (not including mobile homes).

In Hayward, no child, immune-compromised person, person with respiratory conditions or a family history of cancer should be forced to endure smoke in their environment, especially not in their home. In fact, everyone has a right to breathe clean air in their home.

The public health community's stance is that "smoke is smoke"; both secondhand smoke from cannabis and tobacco use are harmful and exposure should be prevented, especially in multi-unit housing where shared walls facilitate drifting secondhand smoke and 65% of the air is shared between units.

In addition, no amount of ventilation or filtering can eliminate the health risks of secondhand smoke either from tobacco or cannabis. **The only known way to reduce the risks associated with secondhand smoke is with a 100% smokefree environment.** This is affirmed by all leading health agencies, including the Office of the Surgeon General.

A comprehensive policy goes hand-in-hand with a robust implementation plan that includes both education and enforcement. Landlords and Homeowners Associations already have the ability to pass smoke-free multi-unit housing policies; they need the support of the City of Hayward to ensure residents comply with the policy as eviction should not be the consequence for non-compliance. The goal is to protect Hayward families from continued secondhand smoke exposure, not housing instability.

We hope Hayward will join its neighbors, Berkeley, Emeryville, Albany, Alameda, and unincorporated Alameda County, in protecting all multi-unit housing residents from smoking and vaping of cannabis and tobacco.

Hello, good afternoon to everyone, to Mayor Salinas and the City Council,

It is a pleasure to share with you my experience regarding the smoke, whether from cigarettes or marijuana, that I am involuntarily forced to breathe due to my neighbors or the community. This secondhand smoke clings to my clothes and my furniture. From my balcony, I breathe in what they consume, and it all comes into the apartment, from the living room to the bedroom.

From 2023 to 2025, I have not been able to go so long without taking action regarding this law. It affects me constantly. Even on the street, I have found myself breathless, as these individuals show no respect. Some even find it funny to blow smoke near or directly in front of someone who is walking by. How can I explain that my lungs are being harmed? That my clothes are soaked with the smell? That my throat and eyes are affected?

If smoking continues to be allowed in multi-family housing, it won't only affect me, it will also affect children and pets. Secondhand smoke seeping into homes is the most common complaint received by the American Lung Association, Americans for Nonsmokers' Rights, and the Tobacco Control Program of the Alameda County Public Health Department.

Mayor and City Council, I respectfully ask you to implement a 100% smoke-free policy in multi-family housing.

Hi! My name is Icela Velazquez, I go to Mt. Eden High School and I'm currently in 11th grade. I live here in Hayward and I am the president of the Youth Advisory Council.

I would like to raise concerns about a problem in which I think affects all of us. It is well known that Hayward has yet to implement Smoke Free Multi-Unit Housing policy. It is critical that these policies cover nicotine, or cannabis use that may be used within residential areas.

As we know, secondhand marijuana smoke also contains the same cancer-causing substances and toxic chemicals as secondhand tobacco smoke, putting residents at the same risk that comes from first-hand smoking.

This is important to me because as a teenager who goes to a public high school here in Hayward, I have definitely seen an increase in underage smoking which includes mostly both cannabis and vapes. Seeing how these substances are so easily used and accepted into our society knowing that there is so many outcomes that come from usage makes me empathize more on the matter of Smoke Free Multi Unit housing including Tobacco and Nicotine because it's important we prioritize the health and safety of citizens and decrease their amount of exposure to harmful chemicals.

Additionally, in Hayward, 6.7% of adults smoke, which is the 4th highest city in Alameda County. This percentage could increase if we don't address the root causes of these issues. Adopting a 100% Smoke Free Multi Unit Housing would greatly benefit us as a community because we could reduce residents' exposure to harmful chemicals which could cause asthma, heart disease, and cancer.

Not only that, but adapting a housing policy would also greatly benefit property values which protects both the environment, benefits the landlord, and keeps dwellings up to date.

In conclusion, establishing a 100% Smoke Free Multi Unit Housing which involves Nicotine and Cannabis would have a very positive impact on our community and would improve the livelihood and wellbeing of residents' lives, which is something all cities want for their communities, and something we could accomplish by prioritizing the health of all people.

To the Housing Policy and Resource Committee,

Hello, My name is Aero Regacho, and I live in Hayward. I serve as a board member of the Youth Advisory Council, where I help represent the voices of youth within our community. I would like to share my concerns and personal experiences related to a 100% Smoke Free Multi-Unit Housing Policy in Hayward.

I have observed that residents in multi-unit housing our community can be exposed to second-hand and third-hand smoke, which is incredibly harmful, especially for children, seniors, and people with respiratory conditions. I often hear from my friends who live in apartments share these concerns. Exposure to second and third-hand smoke is common, and has been shown to increase the risk of disease and cancer.
