RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH BAY AREA COMMUNITY SERVICES (BACS) FOR FISCAL YEAR 2025-2026 HAYWARD NAVIGATION CENTER (HNC) OPERATIONS FOR AN AMOUNT NOT-TO-EXCEED \$2,500,894

WHEREAS, the City of Hayward opened the HNC on November 18, 2019; and

WHEREAS, the City issued a Request for Information (RFI) from nonprofit social service providers interested in operating a HNC on January 23, 2019; and

WHEREAS, a panel of reviewers was convened, comprised of staff from Community Services, Police Department, Planning, and Finance; and

WHEREAS, staff unanimously recommended BACS based on their relevant experience operating the similar Berkeley STAIR Center and providing a number of services to homeless individuals at locations in Hayward, the quality of their application, positive working relationship and flexibility in approach to service delivery, and their ability to quickly staff and operate the Navigation Center; and

WHEREAS, BACS has been operating the HNC since November 2019; and

WHEREAS, since November 2019, BACS has successfully moved 356 individuals experiencing homelessness into permanent housing through the Hayward Navigation Center; and

WHEREAS, the Hayward City Council has approved the City of Hayward's FY 2025-2026 Operating Budget, allocating General Fund and Measure C funding to support HNC operations; and

WHEREAS, the City has received Opioid Settlement funding and said funds are available to support HNC operating costs, and HNC operations is an eligible use; and

WHEREAS, the City's Community Development Block Grant fund balance has sufficent funding from unspent prior year awards to support HNC operations, which is an eligible use.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Hayward authorizes the City Manager or their designee to negotiate and execute the FY 2025-2026 agreement between the City and BACS for an amount not-to-exceed \$2,500,894.
