RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE THE SOUTH HAYWARD PROMISE NEIGHBORHOOD (SHPN) ONE (1) YEAR CONTRACT TOTALING \$100,000 OVER FISCAL YEAR (FY) 2025; AND AUTHORIZE THE CITY MANAGER TO ACCEPT AND APPROPRIATE UP TO \$100,000 IN FUNDING FROM HAYWARD PROMISE NEIGHBORHOODS OVER FISCAL YEAR 2025

WHEREAS, The Promise Neighborhoods Initiative was established under the federal legislative authority of the Fund for the Improvement of Education Program (FIE) started during the Obama administration; and

WHEREAS, The SHPN initiative is led by California State University, East Bay, in collaboration with 12 agencies, including Hayward Unified School District (HUSD), the City of Hayward, and Chabot College; and

WHEREAS, In January of 2023, Council was made aware that the U.S. Department of Education awarded the Hayward Promise Neighborhoods (HPN) consortium a new \$30 million grant (\$6 Million per year for five [5] years) to expand their decade-long initiative to serve Downtown Hayward and the surrounding communities along the A St. and Mission Blvd. corridors; and

WHEREAS, The City of Hayward was awarded an additional \$100,000 from SHPN from funding allocated to SHPN through CA Department of Social Services (CDSS) for partners to continue or sustain their existing SHPN solutions over one (1) fiscal year (FY) 2025. Funding will be used to purchase furniture for the Weekes Branch Children's Area and Meeting Room which are eligible expenses directly related to the SHPN programs.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward authorizes the City Manager to execute the Hayward Promise Neighborhood (SHPN) one (1) year contract over fiscal year (FY) 2025 with no match requirement.

FURTHER, BE IT RESOLVED, that the City Council of the City of Hayward authorizes the City Manager to appropriate up to \$100,000 in funding from Hayward Promise Neighborhood (SHPN) over FY 2025.
