

Action Being Considered

Approve Resolution 24-01 adopting the Hayward GHAD Budget for the 2024-2025 Fiscal Year and Reinstate the Levy of the GHAD Assessment for the residential units within The Reserve development





- Supplemental real property tax assessments approved by the GHAD Board in 2016 and adjusted annually for inflation are used to fund the GHAD
- Residences, all 179, are subject to the levy of the approved assessment

Assessment levy is proposed to be \$931.00 per residential unit



Overview – Hideaway Development (formerly Ersted) for FY 2024/25

- Supplemental real property tax assessments approved by the GHAD Board in 2019, and adjusted annually for inflation are used to fund the GHAD
- Residences, all 59, within the Hideaway development are subject to the levy of the approved assessment
- Assessment levy is estimated to be \$1,141.15 per residential unit
- Development is currently in the developer-supported period for GHAD Plan of Control responsibilities for 3 years from issuance of first building permit (December 10, 2020)



Overview – Hayward SoMi Development for FY 2024/25

- Supplemental real property tax assessments approved by the GHAD Board in 2022, and adjusted annually for inflation are used to fund the GHAD
- Residences, 57 of the 189 total, were subject to the levy of the approved assessment and it is anticipated that 130 residences will be subject to the assessment
- Assessment levies are estimated to be \$641.67 per townhome unit and \$513.79 per condominium unit
- Development is currently in developer-supported period for GHAD Plan
 of Control responsibilities for 3 years from issuance of first building
 permit (initial permits were issued before June 30, 2022)




Target Reserve for FY 2024/25



Sidewalk Vendor Ordinance

Strategic Roadmap Priority: Sidewalk Vendor Ordinance Amendments

Project Background

- <u>"Grow the Economy"</u> adopted as one of six strategic priorities in FY 2024-25 Strategic Roadmap
- <u>"Invest in City Facilities & Property"</u> included as one of four projects identified under "Grow the Economy" Priority
- <u>"Final Sidewalk Vendor Ordinance"</u> included as one of these programs

Current Enforcement Framework Sidewalk Vendor Ordinance

An alternative procedure to that of the administrative citation procedure set forth in Section 1-3.07 of the Hayward Municipal Code:

- <u>First Incident</u>: A verbal warning is given along with educational materials to the vendor.
- <u>Second Incident</u>: A written warning is issued, which includes a timeline for compliance.
- <u>Third incident</u>: The administrative citation procedures would apply:

Current Enforcement Framework Sidewalk Vendor Ordinance

If a sidewalk vending permit is required and the vendor is operating without a permit, the following fine amounts would apply:

Proposed Amendments to the Sidewalk Vendor Ordinance

- Amend Section 6-16.70 "Enforcement". Changes the title of this section from "Enforcement" to "Penalties and Administrative Citations".
- Add Section 6-16.80 "Impoundment". This section is added to give the City the authority to impound "vending devices, food, goods, and/or merchandise."
- <u>Add Section 6-16.90 "City Manager Authority"</u>. Creates a new section for "City Manager Authority".

Proposed Impoundment Process

The impoundment process entails the following:

- Code Enforcement will contact Hayward Police for immediate standby.
- The physical condition of all impounded goods shall be documented.
- Code Enforcement staff shall issue to the offending party a receipt for any property removed.
- All items will be stored in an available abatement trailer and transport.



Recommendation

That the City Council introduces an Ordinance amending Chapter 6, Article 16 (Sidewalk Vendor Ordinance) of the Hayward Municipal Code regulating the enforcement of Sidewalk Vendors, by amending Sections 6-16.70 and 6-16.80 and adding 6-16.90.

Sales Tax



Proposed Ballot Language

To continue providing essential City of Hayward services, including firefighting, emergency-medical response, police protection, pothole repair, street improvements, general City maintenance, and modernization of aging City facilities, including for police, public works, and South Hayward community and library services; shall a City of Hayward measure to continue (without increasing) an existing half-cent sales tax for 20 years, providing \$20,000,000 annually that cannot be taken by the State, requiring annual audits and public disclosure, be adopted?

Revenue Generated

- Staff estimates a 20-year extension will generate approximately \$187-\$204 million in financing debt capacity to fund capital projects through 2054
- Assumes that the half-cent sales tax continues to support the current annual operating services with normal annual growth
- The financing debt capacity would be reduced if any new services are added to the annual operating expenses

- August 26: Deadline to submit direct arguments and rebuttal arguments to the Registrar of Voters
