

## ORDINANCE NO. 18-\_\_

AN ORDINANCE AMENDING CHAPTER 10, ARTICLE 1 (ZONING ORDINANCE) OF THE HAYWARD MUNICIPAL CODE BY REZONING CERTAIN PROPERTY TO PLANNED DEVELOPMENT DISTRICT IN CONNECTION WITH ZONE CHANGE AND VESTING TENTATIVE MAP APPLICATION NO. 201705848 TO ACCOMMODATE 59-TOWNHOMES AT A SITE SOUTH OF THE NEW TENNYSON ROAD EXTENSION BETWEEN MISSION BOULEVARD AND VISTA GRANDE DRIVE

WHEREAS, On October 16, 2018, the City Council held a public hearing and adopted findings in support of the requested zone change as set forth in the companion Resolution (No. 18-\_\_);

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF HAYWARD DOES ORDAIN AS FOLLOWS:

Section 1. Provisions.

Chapter 10 of the Hayward Municipal Code is hereby amended to rezone the property located south of the new Tennyson Road extension between Mission Boulevard and Vista Grande Drive (APNs 078C-0461-001-13 & 078C-0461-001-14) from RM, Medium Single Family Residential and AB10A (Agriculture) to PD, Planned Development District, to allow for the subdivision of a 17.23-acre site to accommodate the construction of 59 new townhomes with common open space and bioretention areas, as well as related site improvements, subject to the findings and conditions of approval set forth in the companion Resolution (No. 18-\_\_) to this Ordinance.

Section 2. Severance.

Should any part of this ordinance be declared by a final decision by a court or tribunal of competent jurisdiction to be unconstitutional, invalid or beyond authority of the City, such decision shall not affect the validity of the remainder of this ordinance, which shall continue in full force and effect, provided the remainder of the ordinance, absent the excised portion, can be reasonably interpreted to give effect to intentions of the City Council.

Section 3. Effective Date.

This ordinance shall become effective immediately upon adoption.
