### **CSC Commissioner Biographies**

Dr. Cole-Bloom provided an overview stating that biographies were provided in the staff report by those commissioners interested in providing the commission a little background about themselves. No action required.

# CAP / CSC Ad Hoc Formal Recommendation to Council

Dr. Cole-Bloom provided background information on this item in consideration of the new commissioners. The presentation included: background on the CAP, formation of the Ad Hoc Committee, and breakdown of the CSC proposed items for consideration for council for the

CAP. Staff recommendation is to bring the ad hoc committee preferences to Council for Work Session on 10/24/2023 in memorandum form.

City staff provided answers to commissioner questions of clarity regarding this item. Additionally, CAP member Sara Prada provided public comment regarding her concerns and the current role of the CAP. Ms. Prada expressed her concerns and frustrations regarding the CAP's lack of power and the utilization of the body as reassurance to Council although the membership was not in agreement with was reported back to Council. All the work the membership was performing to provide structured feedback felt useless, which provides no transparency, that was the original goal of the CAP.

A motion was moved by Commissioner Collin Thormoto with a second by Commissioner Jesse Gunn for the CSC to make the following recommendations to the Council regarding the CAP:

- 1. Make the CAP a Brown Act body.
- 2. Require all CAP members to complete a Form 700 Statement of Economic Interest
- 3. Adjust the CAP appointment process to be as follows:
  - a. Council makes nominations for CAP applicants.
  - b. Applicants are interviewed confidentially by an appointment panel consisting of the Police Chief, the City Manager, the Mayor, and a member of Council appointed by the full Council.
  - c. Council holds a public vote on the appointment panel's recommended appointments with the full list of applicants made public.

The motion was approved unanimously. See *Figure 1: Action Item Votes* for roll call vote.

# CSC Agenda Planning Calendar
