RESOLUTION APPROVING THE FINAL MAP OF TRACT 8670, ACCEPTING THE EASEMENTS AND MOHR DRIVE RIGHT OF WAY DEDICATED THEREON FOR PUBLIC USE AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE SUBDIVISION IMPROVEMENT AGREEMENT AND RELATED OTHER DOCUMENTS

WHEREAS, Vesting Tentative Tract Map No. 8670 for Eden Village III was approved by the City Council of the City of Hayward on January 23, 2024; and

WHEREAS, the Final Map for Tract 8670 has been presented to the City Council of the City of Hayward for development of twelve (12) detached single-family small lot detached residential units with a private street and other site improvements located on two existing parcels (Assessor's Parcel Numbers 441-0074-009-00 and 441-0074-009-00), 24764 and 24656 Mohr Drive; and

WHEREAS, the City Engineer has determined the map substantially complying with its Vesting Tentative Map and the City Surveyor has determined the map technically correct; and

WHEREAS, the City Engineer has also determined the Tract 8670 Improvement Plans acceptable and conforming to the City's Conditions of Approval of the Vesting Tentative Map for Tract 8670; and

WHEREAS, Subdivider has requested the Council approval of Tract Map 8670 before its required improvements are completed and has agreed to complete the same within the time limits specified in an agreement with the city and post securities required therefor; and

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Hayward does hereby find that the Final Map for Tract 8670 is in substantial compliance with its approved Vesting Tentative Tract Map and does hereby approve the said Final Map and accepts on behalf of the public all easements dedicated for public use thereon, subject to the subdivider entering into a subdivision agreement for the completion of improvements and other obligations, as required by the conditions of approval of the Vesting Tentative Tract Map for Tract 8670, and that the approval of the Final Map for Tract 8670 shall not be effective until and unless and such agreement is entered into.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to negotiate and execute, for and on behalf of the City of Hayward, a subdivision agreement in a form approved by the City Attorney
