RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENTS TO THE PROFESSIONAL SERVICES AGREEMENTS WITH THE FRIENDS OF CHABOT COLLEGE AND CALIFORNIA STATE UNIVERSITY EAST BAY FOUNDATION INC FOR PROGRAM MANAGEMENT SERVICES FOR THE TUITION ASSISTANCE PROGRAM EACH FOR A TOTAL ADDITIONAL NOT-TO-EXCEED AMOUNT OF \$200,000 THROUGH DECEMBER 31, 2024

WHEREAS, on July 13, 2021, Council adopted a Resolution approving the City of Hayward ("City") Federal Stimulus Expenditure Plan for the American Rescue Plan Act stimulus funding including funding for the Tuition Assistance program as identified by the Economic Development Division; and

WHEREAS, the Tuition Assistance Program is designed to help residents and businesses of Hayward recover from labor hardships associated with the COVID-19 pandemic; and

WHEREAS, in June 2023, the City entered into separate initial agreement with California State University East Bay Foundation Inc. and The Friends of Chabot College, for \$75,000 each, to provide assistance with tuition and educational expenses to Hayward residents that attend Chabot College, Cal State East Bay, Eden Area Regional Occupational Program, and other technical schools.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that the City Manager is hereby authorized to execute a first amendment to the agreement with The Friends of Chabot College, in a form approved by the City Attorney, for program management services for the Tuition Assistance Program in an amount not-to-exceed \$200,000, for a total contract amount of \$275,000 with a termination date of December 31, 2024.

BE IT FURHTER RESOLVED that the City Manager is hereby authorized to execute a first amendment to the agreement, with the California State University East Bay Foundation Inc., in a form approved by the City Attorney, for program management services for the Tuition Assistance Program in an amount not-to-exceed \$200,000, for a total contract amount of \$275,000, with a termination date of December 31, 2024.
