

# MINUTES OF THE CITY COUNCIL MEETING OF THE CITY OF HAYWARD Council Chambers 777 B Street, Hayward, CA 94541 Tuesday, January 19, 2016, 7:00 p.m.

The City Council meeting was called to order by Mayor Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Council Member Peixoto.

### **COUNCIL REPORTS, REFERRALS, AND FUTURE AGENDA ITEMS**

Council Member Zermeño asked when the City would begin enforcing the policy related to chain link fences.

#### **CLOSED SESSION ANNOUNCEMENT**

City Attorney Lawson announced that the Council convened in closed session concerning four items: 1) Conference with legal counsel pursuant to Government Code 54956.9 regarding S.E.I.U., Local 1021/City of Hayward, P.E.R.B., Case Nos. ### **PUBLIC COMMENTS**

Ms. JoAnne Lauer, representing Castro Valley Matters (CVM), asked the City Council to support the CVM's Board of Directors in asking the Alameda County Board of Supervisors to pass a resolution changing the Castro Valley Municipal Advisory Council to an elected body or place a measure on the June or November 2016 ballot. The Council concurred to direct staff to do an analysis and bring the matter at a future agenda meeting in February.

Ms. Wynn Grcich, Hayward resident, announced she will be filing nomination papers to run for City Council; and provided a document for the record.

Mr. Benjamin Goulart, Hayward resident, representing the Prospect Hill Neighborhood Association, urged the City to consider upcoming projects such as the Maple and Main project having the community's interest in mind. Mr. Goulart suggested turning parking lot areas into parks for the community.

The following Service Employees International Union (SEIU) Local 1021 speakers urged the City Council to not appeal the Administrative Law Judge (ALJ) decision to the Public Employee Relations Board (PERB) and asked to move forward with the ALJ recommendation.

Ms. Louise Ann Santucci Bargagliotti was born in Hayward, grew up in Russell City on a hog ranch, graduated from All Saints Catholic School and Bishop O'Dowd High School, and was a Hayward Chamber of Commerce volunteer and its 2013 Volunteer of the Year.

Mr. Douglas Goldsbury Sprague, was a longtime professor and onetime departmental chair of the Educational Psychology Department at California State University Hayward, helped create the Marriage and Family Therapy course, served as a mediator in landlord-tenant disputes for the City of Hayward, and was a member of the Starr King Unitarian Universalist Church in Hayward and also served as its President from 1989 to 1991.

Mayor Halliday asked staff to work with the Bargagliotti and Sprague families and plant trees in memory of Louise Ann Santucci Bargagliotti and Douglas Goldsbury Sprague.
