Good evening, Mayor, Councilmembers, and staff.

My name is Karen Moore, I live in the Spanish Ranch one Mobile Home Park, I moved to Hayward in the late sixties, left and came back to retire here, and I'm a resident who watched your June 17th meeting live from my home on YouTube. I want to thank you for making your meetings accessible to the public—that transparency matters.

At that meeting, one of the agenda items addressed the City's budget deficit. I attend many city council meetings across different cities because I believe it's essential for residents to stay informed and engaged in how local government makes decisions that affect our daily lives.

Hayward, like many cities, is facing difficult choices. But I urge you tonight to continue seeking solutions that protect essential services, especially for our most vulnerable residents. Budget deficits should not mean cuts that harm public safety, housing programs, or environmental initiatives that are crucial to our community's future.

I also encourage you to expand public outreach. Many residents are concerned about the budget but may not know how to participate. Please consider holding community workshops or town halls focused specifically on the budget process. Give people more opportunities to be heard before decisions are finalized. As I watched it I thought if more citizens followed the laws we could reduce police overtime, if we were aware of safety around the home we could reduce fire response cost. There are many ways the citizens actions create cost or save cost for our public servants. I think public service messages need to be created because so many need to do our part in helping our city thrive. We also can shop local so those taxes Improve our city. My concern is that a recession is coming and citizens need to get ready to pull up their sleeves and help you help us make Hayward the city I've always seen it to be. Tap into the retired even more for volunteer opportunities we have skills and we can be a valuable resource.

Finally, I appreciate the thoughtful discussion you've had so far and ask that you continue balancing fiscal responsibility with compassion and equity. The decisions you make today will shape Hayward's resilience for years to come.
