RESOLUTION ACKNOWLEDGING RECEIPT OF CERTIFICATE OF ELECTION RESULTS AND STATEMENT OF RESULTS BY THE CITY CLERK OF THE GENERAL MUNICIPAL ELECTION HELD NOVEMBER 5, 2024, AND DECLARING THE RESULTS THEREOF

WHEREAS, a General Municipal Election was held in the City of Hayward, California, on Tuesday, November 5, 2024, as required by law; and

WHEREAS, the General Municipal Election was authorized to be made by the Alameda County Registrar of Voters in accordance to Resolution No. 24-130, Resolution No. 24-131 and Resolution No. 24-137; and

WHEREAS, the Alameda County Registrar of Voters canvassed the returns of the election and has certified the results to the City Council, the results are received, attached and made a part hereof as Exhibit A; and

WHEREAS, the total number of vote by mail ballots cast in the City was 43,088 (52.03 percent turnout), the total number of election day ballots cast in the City was 7,592 (9.17 percent turnout), making a total of 50,680 (61.20 percent turnout) ballots cast of Hayward's eligible voters; and

WHEREAS, the names of individuals voted for at the election for Member of the City Council are as follows:

WHEREAS, that the number of votes given in the City to each of the individuals named for the Office of City Council for which the individuals were candidates are as listed in Exhibit A attached; and

WHEREAS, that the number of votes given at each precinct and the number of votes given in the City for and against Measure K1 (City’s Transactions and Use (Sales) Tax) was listed in Exhibit A attached.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that the City Council does declare and determine that the following have been elected as members of the City Council for full terms of four years each; and that a majority of voters voted in favor of Measure K1 and that the measure carried and shall be deemed adopted and ratified.
