

# Methodology

- √ 663 interviews with registered voters in Hayward, weighted to reflect the adult population of the city per the US Census American Community Survey
- ✓ Conducted April 7-17, 2019, online and via landline and cell phones in English and Spanish
- ✓ Margin of sampling error of +/-4.0% at the 95% confidence interval
- ✓ Due to rounding, some percentages do not add up to 100%
- ✓ Selected comparisons to prior surveys conducted by Godbe Research





# Three-quarters of Hayward residents are satisfied with quality of life, though less intensely than they were a few years ago.


I'd like to get your overall opinion of living in the City of Hayward. Generally speaking, are you satisfied or dissatisfied with the overall quality of life in Hayward?






# Seniors are the most likely to say they are "very satisfied" with quality of life.

# More than seven in ten are satisfied across ethnic groups, though intensity varies.


Hayward Satisfaction by Ethnicity






## More than two in five are concerned about traffic on local freeways; homelessness and housing costs are also intense concerns.



Overall, are you satisfied or dissatisfied with the job the City of Hayward is doing to provide resident services?






## Those who are dissatisfied with City services want to see traffic, police, homelessness and housing costs addressed.

#### Reasons for Dissatisfaction with City Services

The resident services seem more targeted to wealthy areas than lowincome areas.

People are on the streets because it's too expensive to live.

I don't think we have enough police patrolling. There are a lot of packages stolen, mailboxes being broken into, and stealing of cars.

Bowling alleys, a skating rink, and theaters were closed years ago and weed-covered lots remain.


There are streets that are not lighted. It's scary to walk at night in those areas.

Renegotiate the Waste Management contract. I'm paying \$70, while San Lorenzo is paying around \$26. Seems like someone is lining their pockets.


Improve access for those who don't use cars. There are too many sidewalks with mud/grass at the curb, interfering with wheelchair access at bus stops.

## A declining share feel they have the opportunity to voice their concerns about major community issues.


Overall, as a resident of the City of Hayward, how much of an opportunity do you feel that you have to voice your concerns on major community issues that affect your life?





### **Assessing City Services**

- Respondents were asked to rate the importance of 28 aspects of local life: is it extremely, very, somewhat or not too important to making Hayward a good place to live?
- Then they were asked whether they were satisfied or dissatisfied with the a list of 26 services and programs that largely corresponded with these aspects.
- We also looked at the interaction of importance and satisfaction levels to show areas of strength and areas for improvement.








# Satisfaction with City Staff

In the past 12 months, did you contact a City of Hayward department for any reason other than an emergency?




With which City department did you have contact? (Open-Ended; Asked of Those with Contact Only, N=188)







How safe do you feel in Hayward \_\_\_\_\_? Do you feel safe, unsafe, or neither safe nor unsafe?






### Three in five are satisfied with courtesy and traffic safety maintenance of officers.



### More than seven in ten residents believe the City has at least some need for additional funds.


In your opinion, do you think there is a great need, some need, a little need, or no real need for additional funds to provide the level of City services that Hayward residents need and want?






### A slim majority supports the idea of increasing taxes to fund a public safety center.











How likely are you to participate in the Census?






#### Younger residents are much less likely to say they will participate.






#### Lower-income residents are also less likely to say they will complete the Census.






## Those with less than a high school education are less likely to complete the Census.

# Conclusions

## **Conclusions**

- ✓ While three-quarters are satisfied with Hayward's quality of life, the share who are "very satisfied" has declined relative to several years ago.
- ✓ Sources of dissatisfaction mirror trends in the broader Bay Area: concerns about rising cost of living (particularly housing), homelessness, and traffic congestion are broadly shared.
- ✓ Residents largely say they feel safe in the City, giving the Police Department good marks.
- ✓ They believe the city is diverse, welcoming and a good place to live and raise a family.
- ✓ Safety, efficient traffic movement, a clean city, disaster preparedness and affordable housing are among the most important aspects to quality of life.
- ✓ There is room for improvement on traffic and housing affordability.
- ✓ More than seven in ten say the City has a need for additional funding, though a general proposal to increase taxes for a public safety building had slim majority support. Further research should explore a ballot question and potential mechanisms.

## **Zoning Code**

Allow up to 173 ft. at existing office tower location

Reduce rear setback requirements to 0' or 15' if adjacent to residential

Allow commercial cannabis dispensary with CUP, consistent with current regulations

## **Labor Apprenticeship**

Add new policy and program to implement Building and Construction Trades Council recommendations to encourage applicants for residential and non-residential projects Downtown to use contractors who hire apprentices and provide health care.

- Clarified description of Downtown mobility and "the Loop"
- Modified Code to allow accessibility/ADA adjustments

# **CEQA Overview**

The California Environmental Quality Act (CEQA) is the State's primary environmental protection law.

 CEQA requires that public agencies disclose environmental impacts of projects that have a physical effect on the environment.







## What is an EIR?

- An informational document
  - Discloses information about the effects a proposed project could have on the environment
  - Identifies mitigation measures
  - Described feasible alternatives to the proposed project
- Must be certified prior to project approval and adoption







# Program-level EIR


■ Program-level environmental review documents are appropriate when a project consists of a series of actions related to the issuance of rules, regulations, and other planning criteria (CEQA Guidelines section 15168)


■The EIR does not evaluate the impacts of specific, construction-level developments that may be allowed under the proposed project





# Mitigation Measures

- Air Quality
  - Avoid air quality standard violations (construction and operation)
  - Reduce criteria air pollutant emissions & toxic air contaminants to acceptable levels
- Greenhouse Gas Emissions
  - Reduce GHG emissions (construction and operation) to acceptable levels
- Noise
  - Reduce noise (construction and operation) to acceptable levels







# Mitigation Measures

- Transportation & Circulation
  - Improve level of service at impacted intersections and roadway segments to acceptable levels

- Utilities & Service Systems
  - Ensure adequate water supplies during multiple dry years







# **Alternatives to the Proposed Project**

- Four alternatives were evaluated in the Draft EIR:
  - No Project Alternative (General Plan 2040)
  - General Plan with Circulation Changes Alternative
  - Specific Plan without Circulation Changes Alternative
  - Specific Plan with Lower Intensity (30% Less) Alternative

# Alternatives to the Proposed Project

- CEQA section 15126.6 requires the identification of an Environmentally Superior Alternative:
  - informational procedure
  - may not be the alternative that meets project objectives
- The Specific Plan with Lower Intensity (30% Less)
   Alternative is the Environmentally Superior Alternative
- No alternative fully achieves all of the project objectives





## Statement of Overriding Considerations

- The City may approve the project with significant and unavoidable impacts by issuing a "Statement of Overriding Considerations" that identifies how the benefits of the project outweigh the potential adverse environmental effects.
- The "Statement of Overriding Considerations" must be included in the record of project approval







# Response to Comments

- 45-day public review period of Draft EIR (January 7 to February 20, 2019)
  - Two comment letters from public agencies
  - Four comment letters from members of the general public
  - Most comments did not pertain to adequacy of Draft EIR
- Error correction, language edits, and clarifications were made, but no substantial revisions.
- No late comments were received.
