RESOLUTION AUTHORIZING THE TRANSFER AND REAPPROPRIATION OF \$1,000,000 FROM THE SAFE ROUTES FOR SENIORS PROJECT, PROJECT 05309 TO MAIN STREET COMPLETE STREET PROJECT, PROJECT 05283, WITHIN THE MEASURE BB PARATRANSIT CAPITAL FUND (FUND 219)

WHEREAS, on October 27, 2020, the City Council approved Resolution 20-187, authorizing the City Manager appropriate \$2,700,000 from the Measure BB Paratransit Fund (Fund 214) for the Safe Routes for Senior (SR4S) Program; and

WHEREAS, these funds have been appropriated to support engineering design, construction and related services of SR4S Projects on the intersections of A Street and Foothill Blvd., A Street and Mission Blvd., B Street and Montgomery Avenue, A Street and Main Street, C Street and Main Street, and Hazel Avenue/City Center Drive and Foothill Blvd; and

WHEREAS, the intersections of A Street and Main Street, and C Street and Main Street can most efficiently be improved if incorporated in the Main Street Complete Street Project, Project 05283; and

WHEREAS, the cost to implement SR4S Projects at these intersections is estimated to cost \$1,000,000; and

WHEREAS, on February 23, 2021, the City Council approved Resolution 21-027, authorizing the establishment of Measure BB-CIP Paratransit Capital Fund (Fund 219) and the transfer of Project 05309 budget funds in the amount of \$2,700,000 from Fund 214 to Fund 219 as part of the FY2021 Mid-year process.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward hereby approves that \$1,000,000 be transferred out of the Safe Routes for Seniors Project 05309 and that these funds be reappropriated into the Main Street Complete Street Project, Project 05283 within the Measure BB-CIP Paratransit Fund (Fund 219.)
