### **CLOSED SESSION ANNOUNCEMENT**

The City Council convened in closed session on May 6, 2025, at 5:30 p.m., with all members present and no public speakers, regarding three items: 1) public employment pursuant to Government Code section 54957(b)(1) regarding City Clerk; 2) public employment pursuant to Government Code section 54957(b)(1) regarding City Attorney; and 3) conference with legal counsel pursuant to Government Code section 54956.9(d)(1) regarding Ghali et al v. City of Hayward, US District Court - Northern District of California Case 3:25-cv-01116. City Attorney Lawson noted the City Council discussed Item 3, but there was no reportable action. Mayor Salinas noted there was no reportable action related to Items 1 and 2.

Mayor Salinas read a proclamation declaring the week of May 4 to May 10, 2025, as Public Service Recognition Week in the City of Hayward. Assistant City Manager Youngblood, Deputy Police Chief William Deplitch, Captain Daniel Olsen and Svetlin Radev accepted proclamations on behalf the City of Hayward, Hayward Police Management Union (HPMU), and SEIU 1021 Maintenance.

## PUBLIC COMMENTS

The following City employees expressed: disappointment at the return-to-office policy implementation which ignored collaboration, data, and transparency; removal of Human Resources Director Frye undermining staff morale and trust during Public Service Recognition Week; concern at the City Manager's disregard for organizational values such as caring, openness, and integrity; described the City Manager's leadership style as authoritarian, fostering fear and distrust among employees; resident survey results reflect resident satisfaction of service delivery during the period that remote work has been allowed; and emphasized that work-life balance should be available to all staff, not just those who disclose medical conditions.

Staff report submitted by Police Chief Matthews, dated May 6, 2025, was filed.

Mike Katz-Lacabe, Research Director for Oakland Privacy, urged the City Council to vote against the proposed addition of 30 license plate readers, citing concerns about surveillance overreach, potential violations of state law; and asked for data analysis on the effectiveness of the existing license plate readers before approving the item.

TJ, Hayward Concerned Citizens' representative, expressed support for the addition of license plate readers, stating they have effectively reduced vehicle theft and aided in solving crimes; and encouraged continued use of the technology as a public safety tool.

Council Member Syrop used his prerogative to continue the item for further analysis; expressed concerns about increased surveillance and potential cooperation with Immigration and Customs Enforcement (ICE) following a recent federal executive order affecting sanctuary cities; raised privacy issues related to audio recording capabilities in newer license plate reader models; and requested further clarification on items raised before proceeding.

Council Member Andrews noted the technology had previously been reviewed by the Council Infrastructure Committee and the Police Department with reference to American Civil Liberties

Union (ACLU) guidelines; and suggested that this information be shared with the City Council when the item returns.

The item was continued to the City Council meeting on May 20, 2025.

Ro Aguilar commended the City Council and staff for the list of capital projects but urged them to prioritize addressing homelessness, which was identified as a top concern by residents; and requested a list of capital projects that specifically address homelessness before the appropriations are approved in June.

Mayor Salinas closed the public comment section at 8:35 p.m.

Members of the City Council thanked staff for the presentation on capital projects, and the enhancement of the capital project website and overall presentation quality.

Council Member Syrop emphasized the importance of aligning the budget with the City's strategic roadmap priorities; inquired about the possibility of combining phases two and three of the Stack Center project, to which staff confirmed it could be considered if funding is identified; and requested that future iterations reflect strategic goals.

Council Member Roche acknowledged the importance of ensuring all departments have the support needed to implement the City's capital projects effectively; asked about the status of Phase II of the Recycled Water Project with staff confirming it is being planned to secure future funding; and reiterated the need for improved senior pedestrian crossings, particularly near new senior living developments on Second Street.

Council Member Bonilla Jr. expressed support for the Capital Improvement Program, praising its user-friendly digital format, strategic priorities, and transparency; noted his excitement for the completion of La Vista Park; and appreciated the City's responsiveness to the community's evolving needs.

Council Member Andrews emphasized partnering with organizations supporting children with autism to integrate public art into City projects, such as high-visibility crosswalks, potentially helping reduce maintenance costs; highlighted the importance of investing in unseen but essential infrastructure such as water and sewer systems; and advocated for continued State support to meet regulatory mandates.

Council Member Zermeno expressed enthusiasm for all the proposed projects, while wishing for full funding availability; and supported incorporating public art into capital projects.

Mayor Salinas emphasized the importance of continued collaboration with the school district and potential cost-sharing related to infrastructure impacts such as the relocation of Bret Harte Middle School; and expressed support for the City's ongoing investment in road safety improvements, including pedestrian-friendly configurations, reaffirming the City Council's commitment to safer streets.

## LEGISLATIVE BUSINESS

13. Transient Occupancy Tax (TOT): Adopt a Resolution Adjusting the City's Transient Occupancy Tax Rate from 8.5% to 14.0%, Effective July 1, 2025; and Finding that the Action is Exempt from CEQA Review (Report from Interim Finance Director Etman) **LB 25-012**

Staff report submitted by Interim Finance Director Etman, dated May 6, 2025, was filed.

Interim Finance Director Etman provided a synopsis of the staff report.

Discussion ensued among members of the City Council and City staff and the following clarifications were offered: the City Council has the discretion to set the Transient Occupancy Tax (TOT) at any rate up to 14%, as authorized by voters; the effective tax rate for hotel guests would be 16% due to the combination of the proposed 14% TOT and an existing 2% excise tax; the City Council could consider a phased increase if desired; the phased approach to the TOT increase was not recommended by the Council Budget and Finance Committee but was discussed previously; while the Council Economic Development Committee had not been directly involved, Economic Development staff noted that visitors to Hayward, are not particularly price-sensitive and similar TOT rates exist in neighboring cities; the TOT increase would primarily affects non-residents; the current analysis only considered base TOT rates and did not include special district taxes; clarity on whether the TOT percentages listed for comparable cities include a 2% excise tax is important for accurate comparison; and while there was no cost analysis, the average hotel rate was estimated at \$150 per night including the increase from the current TOT to the proposed 16% (including excise tax) which would raise costs by approximately \$12 to \$15 per night.

Mayor Salinas opened the public hearing at 9:02 p.m.

Sajit Khatri expressed concern over the proposed 16% tax rate, noting that the average daily hotel rate in Hayward has dropped from \$143 in 2019 to \$101 today; noted other cities do not have excise tax; and warned that raising taxes could drive customers to neighboring cities, reduce occupancy, and hurt local employment.

Rajesh Khatri echoed similar concerns to Sajit Khatri, stating that the hospitality industry has not recovered since 2019, with decreased corporate and convention business; and suggested a smaller increase of 1–2% would be more appropriate given the economic conditions.

Mitesh Solanski warned that the proposed 5.5% tax hike would place a heavy burden on price-sensitive customers, many of whom already struggle to pay; stressed that Hayward lacks major tourism appeal; and stated increasing costs would likely drive guests to other cities, reducing overall TOT revenue.

Mayor Salinas closed the public hearing at 9:10 p.m.

Interim Finance Director Etman clarified that the proposed budget for the upcoming year is based on a 12.5% TOT rate, not the full 14%, acknowledging that the City Council had not yet made a final decision; emphasized that the intention is not for Hayward to stand out with a significantly higher rate; and suggested the City Council consider aligning the total tax, including the 2% excise tax, with neighboring cities to remain competitive while still addressing the City's budget deficit.

Mayor Salinas made a motion to table the item and refer it to the Council Budget and Finance Committee for further analysis, particularly on the feasibility of a phased approach, comparisons with other cities including excise taxes, and the financial impact on hotel operators and guests.

Council Member Roche seconded the motion.

Interim Finance Director Etman confirmed that while the draft budget assumes a 14% TOT rate, the City Council has discretion, and changes would be reflected accordingly.

Council Members Zermeno voiced support for postponing a decision, emphasizing the importance of economic development.

Council Member Goldstein noted that cities, such as San Francisco, rely more on events than tax rates to drive hotel stays.

Council Member Andrews reinforced the need for Hayward to invest in public art, attractions, and sustainability to support its hospitality sector.

It was moved by Mayor Salinas, seconded by Council Member Roche, and carried unanimously, to table the item and refer it to the Council Budget and Finance Committee for further analysis.

Staff report submitted by Council Members Bonilla Jr., Syrop and Zermeño, dated May 6, 2025, was filed.

Council Member Syrop provided a synopsis of the referral, expressing a preference for agendizing a work session related to the City's voluntary expenditure limit and individual contributions limits after the City Council recess.

Council Member Bonilla Jr. expressed appreciation for Council Member Syrop's leadership.

Council Member Zermeño supported delaying discussion of the item until after the summer recess, citing a busy agenda through July and the benefit of having more time for thorough consideration.

Council Member Roche also supported postponing the item, agreeing that it is not urgent for the current fiscal year, and noting that previous staff research could reduce the workload once the discussion resumes.

Council Member Syrop made a motion to agendize the work session for review after the City Council's recess.

Council Member Bonilla Jr. seconded the motion.

Mayor Salinas acknowledged Hayward's progressive campaign finance history but cautioned against premature adjustments; and suggested the City allow one full election cycle under the new system before making changes.

Council Member Syrop clarified that the intent was not to make immediate changes but to open space for a future conversation, offering to bring examples from other cities that have seen significant spending in small districts; and reiterated the value of discussing the topic.

There being no public comment, Mayor Salinas opened and closed the public comment section at about 9:30 p.m.

It was moved by Council Member Syrop, seconded by Council Member Bonilla Jr., and carried, to agendize a City Council work session after the City Council recess for review of the City's voluntary expenditure limit and individual contribution limits.
