RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE ALAMEDA COUNTY TRANSPORTATION COMMISSION TO ADVANCE THE INTERSTATE 880/A STREET INTERCHANGE IMPROVEMENT PROJECT AND ALLOCATE \$1,350,000 FROM FUND 212 TO THE PROJECT

WHEREAS, the I-880 interchanges at Winton Avenue and A Street are recognized in Alameda Transportation Commission's (CTC) 2014 Transportation Expenditure Plan under the I-880 Local Access and Safety Program; and

WHEREAS, a Project Study Report – Project Development Support (PSR-PDS) for the I-880 Interchanges improvements for Winton Avenue and A Street was approved on October 3, 2019; and

WHEREAS, a Draft Project Report was approved on May 27, 2022 and circulation of the Draft Environmental Documentation was held from June 1, 2022 to June 30, 2022; and

WHEREAS, the Project Development Team, comprised of Alameda CTC, Caltrans, and the City of Hayward, received feedback and reviewed the comments by various agencies and selected a five-lane configuration at A Street on September 14, 2022; and

WHEREAS, due to the challenges of funding both the Winton Avenue and A Street interchanges improvements as one project, Alameda CTC and City staff recommend advancing the Interstate 880/A Street Interchange as the most feasible project in a phased approach; and

WHEREAS, federal and state procedures require commitment of funds for the Plans, Specifications, and Estimates (PS&E) phase to receive project approval, and that a total not-to-exceed \$1,350,000 of City Measure BB funds from Fund 212 combined with Alameda CTC contributed funds would fully fund the PS&E phase for the Interstate 880/A Street Interchange Improvement project.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby authorizes the City Manager to execute an agreement with the Alameda County Transportation Commission to advance the Interstate 880 A Street Interchange Improvement Project and allocate \$1,350,000 from Fund 212 to the Project, in a form approved by the City Attorney.
