The Meeting of the Hayward City Council was called to order by Mayor Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Council Member Salinas.

CLOSED SESSION ANNOUNCEMENT

City Attorney Lawson announced the City Council convened in closed session at 5:00 p.m., and unanimously voted to add two items to the closed session agenda pursuant to Government Code 54954.2 (b)(2) related to (1) public employment regarding the City Clerk's and City Attorney's annual performance evaluations; and (2) one anticipated litigation. City Attorney Lawson noted that the City Council also discussed three items on the agenda: (1) conference with property negotiators pursuant to Government Code 54956.8 regarding City owned properties and easements located at 22300 Foothill Boulevard; APNs: 415-0250-112-00, 415-0250-111-02, and 415-0250-113-00; and 22549 Foothill Boulevard; APN: 428-0061-044-00; (2) conference with labor negotiators pursuant to Government Code 54957.6 regarding all groups; and (3) public employment pursuant to Government Code 54957 regarding the City Manager's annual performance evaluation. City Attorney Lawson indicated there was no reportable action related to Items 1, 2, and the anticipated litigation. Mayor Halliday noted there was no reportable action related to the annual performance evaluations for City Manager, City Attorney and City Clerk.

PRESENTATIONS

Mayor Halliday read a Proclamation declaring June 2018 and every June thereafter as Elder Abuse Awareness Month in the City of Hayward. Mr. Kevin Dunleavy, Chief Assistant District Attorney with the Alameda County District Attorney's Office, and Ms. Stephanie Marsili, representing Director of Alameda County Adult Protective Services, Alicia Morales, each accepted a proclamation.

PUBLIC COMMENTS

Ms. Peggy Guernsey, Hayward resident, asked that Spectrum Community Services be denied CDBG and City funding because they provide defective smoke detectors; and spoke about the condition on her street with no wheelchair access.

Ms. Amanda Guernsey, Hayward resident, spoke about the new low-income level mark for the Bay Area and expressed frustration that she cannot afford to live in Hayward.

Mr. Jim Drake, Hayward resident, spoke about forcible rape statistics in Hayward and the need for more Police officers.

Ms. Lesly Avendano, Chabot College student, spoke about the need for public transportation, and was concerned that bus route changes are made without taking students' needs into account.

The following speakers asked the City to renew the Water Service Agreement for twenty-five property owners in the Castro Valley Five Canyons area with the new developer, City Ventures; and noted that if water is provided to the developer there will be trail access.

Mr. Zachariah Oquenda, Hayward resident, noted that on June 26, 2015, the Supreme Court ruled on Obergefell v. Hodges that the Constitution guarantees a right to same-sex marriages; and noted that Oakland is moving forward with using its public land to support the public good.

Consent Item No. 6 was removed from the Consent Calendar for separate vote. Mayor Halliday noted she would be recusing herself from voting on Item No. 6.

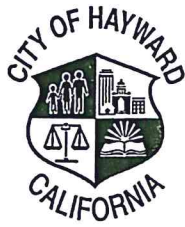

Mayor Halliday closed the public hearing at 8:01 p.m.

There were clarifications related to the percentage increase and conversations between Maintenance Services' staff and homeowner's associations.

Council Member Lamnin offered a motion per staff's recommendation.

Council Member Mendall seconded the motion.

Staff report submitted by Management Analyst II Stefanski, dated June 26, 2018, was filed.

City Manager McAdoo announced the staff report and introduced Management Analyst II Stefanski who provided a synopsis of the staff report.

Discussion ensued among Council Members and City staff about: score threshold for applications by business type; score criteria for labor and employment practices; nontransferable permits; sites for business operations; evaluation and selection of applications; community benefits component and plans for implementation; and anticipated number of employees.

Mayor Halliday opened the public hearing at 8:41 p.m.

Mr. Richard Fierro, Hayward resident, expressed concern about the scoring report not being available, and requested that moving forward more information be made available for public review.

Regarding the Labor and Employment Practices criteria, the following non-retail applicant indicated the company has a labor peace agreement in place.

Mr. Joseph Polyak with Mijosa, LLC – Cultivation and Manufacturing

Mr. David Bennett, with CBRA, Inc., noted his company received the highest score for distribution type, but received a score of 615 out of 650 points for delivery type, and requested that his application be reconsidered and move forward as a microbusiness type.

Regarding next steps, City Manager McAdoo noted that businesses with twenty or more employees would need to comply with labor agreements, businesses that are below the twenty-employee threshold would need to address local hire, living wage, and other priorities, and compliance with labor requirements could be part of the annual license monitoring.

Council Member Márquez offered a motion per staff's recommendation.

Council Member Mendall seconded the motion.

In response to Council Member Márquez's inquiry related to the community benefit component, City Manager McAdoo spoke about the Hayward Community Foundation concept as an opportunity to help fund art local organizations.

Council Member Mendall appreciated that staff would provide score results to all applicants, expressed he was hoping to see more high-quality delivery type applications, suggested setting a minimum threshold amount for the community benefit proposals and allowing flexibility for distribution of funds, and encouraged applicants to review their labor practices before permits are issued.

Council Member Salinas noted he continued to remain hesitant about the cannabis industry because it does not support community and family values.

Council Member Zermeño advised the eleven companies to hire locally and follow-up with community relations, and added that Hayward voters voted in favor of cannabis in 2016.

Mayor Halliday spoke about cannabis use in the past and currently, and noted the State legalized its use with regulations.

City Manager McAdoo noted the City had received a report from StopWaste indicating that 70 properties in Alameda County have earned Bay-Friendly Rated Landscapes designations, and Hayward represented one third of the entire acreage reported.

COUNCIL REPORTS AND ANNOUNCEMENTS

Council Member Salinas announced the Hayward Promise Neighborhood's Words for Lunch Program started today, June 26, 2018, and will continue through August 2, 2018 on Tuesdays and Thursdays, at Weekes Park, and thanked all partners involved.

Council Member Mendall noted that East Bay Community Energy (EBCE) became the electricity provider for commercial and municipal operations in Hayward, and the EBCE Board had approved the City's request to provide Brilliant 100 as the default for residential customers, except for low-income and CARE program customers.

Council Member Zermeño and Council Member Márquez announced the 5th Annual Tennyson All America Festival on June 30, 2018, at the Mt. Eden Mansion in South Hayward, and invited all to participate.


