Staff report submitted by Budget Officer Barton, dated June 21, 2016, was filed.

City Manager David announced the report and introduced Acting Director of Finance Claussen who provided a synopsis of the report.

Discussion ensued among Council/HRSA/HHA Members and City staff regarding the responses to Council queries from budget work sessions presented as Attachment I: Fund 405 Capital Projects and additional funding for fire equipment; consistent blight in South Hayward; conversion rate of Police Explorers into Police Officers; the California Air National Guard Hangar; the Small Business Revolving Loan Program; street sweeping, ticketing policy, and enforcement; audio video system and Comcast; grey water and rain catchment; Old Highland Association; tracking and addressing concerns raised by the public; and incorporating some changes at midyear.

There being no public comments, Mayor/Chair Halliday opened and closed the public hearing at 8:10 p.m.

Mayor/Chair Halliday noted that the adoption of the budget was scheduled for June 28, 2016 and the Council would take action at that time.
