14. Community Agency Funding: Fiscal Year 2021 Community Agency Funding Recommendations for Social Services; Arts & Music; and Infrastructure, Economic Development, and Public Services; and Overview of the FY 2021-2025 Consolidated Plan and FT 2021 Annual Action Plan **WS 20-019**

Staff report submitted by Deputy City Manager Ott, dated May 19, 2020, was filed.

Community Services Manager Davis provided a synopsis of the staff report.

Mayor Halliday opened the public hearing at 7:47 p.m.

Public speakers participated by calling the City Clerk's office at (510) 583-4400.

Ms. Lolita Morelli, Hayward Municipal Band representative, sought clarification on when the band would be able to begin its concerts. She was advised to contact the Alameda County Health Officer.

Ms. Arzo Mehdavi, Community Services Commission (CSC) Chair, supported CSC's funding recommendations.

Ms. Lisa Malul, Rebuilding Together Oakland-East Bay representative, praised the City for the COVID-19 testing and spoke about her agency's business plan in assisting seniors.

Ms. Alicia Lawrence, a CSC member, spoke about the challenges making funding decisions and noted the recommendations were vetted and supported by the CSC.

Mayor Halliday closed the public hearing at 7:57 p.m.

The City Council thanked the Community Services Commission and City staff for the funding recommendations. Council Member Lamnin was acknowledged for her service as the CSC Council Liaison.

Council Member Márquez disclosed that she had previously served on the advisory committee to Love Never Fails and would be recusing from participating when the item comes back for a vote at a later Council meeting.

Discussion ensued among City Council members and City staff regarding: funding recommendations; the current need in the community; Eden I&R's non-competitive award of \$50,000 from the General Fund to operate the 211 line; Cannabis tax revenue and East Bay Community Foundation funds; agencies eligible for COVID-19 funds that are not able to provide services during the pandemic; Community Development Block Grant (CDBG) funding; and CDBG Economic Development/Infrastructure funding category and allocations.

Council Member Márquez recommended considering East Bay Community Foundation funds to supply agencies that do not receive requested funds, and funding agencies at the same level as in prior years.

Council Member Wahab recommended extending the housing moratorium, redirecting funding initially designated for onsite school purposes and prioritizing agencies providing housing and homelessness services, encouraging agencies to collaborate with one another when supplies and services are limited, and ensuring that funds be used to benefit the neediest residents.

Council Member Salinas requested to see the list of stakeholder groups that were interviewed for the Community Needs Assessment, recommended that recovery funds be directed to neighborhood restaurants that deliver and connect families to quality food and invest in neighborhood retailers that hire Hayward residents and serve the community daily.

Council Member Lamnin asked staff to make the link to the Consolidated Plan available for public view, encouraged everyone to complete the 2020 Census questionnaire, recommended having a joint City Council/CSC meeting in the fall to address community needs in light of COVID-19 and subsequent recovery, noted the review of outcomes of prior allocations could inform how to prioritize funding moving forward, suggested that CSC members attend a couple of Homelessness/Housing Task Force meetings, and suggested having an additional FY 2022 category for the East Bay Community Foundation.

Council Member Zermeño favored Council Member Lamnin's idea of a joint City Council/CSC meeting, expressed support for CSC's recommendations, favored removing end of year fiscal reports to allow agencies to participate.

Council Member Mendall did not think adjustments to the proposed funding recommendations were necessary, supported removing the audit requirement for agencies receiving less than \$15,000 and suggested staff consider increasing the ceiling amount for next year's allocations to make it easier for agencies receiving small amounts of money, and

disagreed with the need for a joint City Council/CSC meeting as past joint meetings had resulted in the same priorities.

Mayor Halliday supported CSC's funding allocation decisions, noted there might be funds that do not get utilized, especially in the Arts and Music category due to cancelled events, that could be used later, and suggested staff provide a report on the 2020 Census at a future meeting to gauge the need for additional outreach.

PUBLIC HEARING

15. Master Fee Schedule: Adopt a Resolution Amending the FY 2021 Master Fee Schedule PH 20-032

Staff report submitted by Finance Director Claussen, dated May 19, 2020, was filed.

Finance Director Claussen announced the item and introduced Management Analyst Mullins who provide a synopsis of the staff report.

Finance Director Claussen addressed Council Member Salinas' inquiry about the significant increase of Parcel Map and Final Map application deposit fees noting the fees would cover the work needed to produce the maps and developers would be refunded any unused deposit.

There being no public comments, Mayor Halliday opened and closed the public hearing at 8:37 p.m.

In response to Mayor Halliday's inquiry about peep shows fees, City Manager McAdoo estimated the Police Department fee was for staff to monitor and inspect adult bookstores offering peep shows.

Council Member Wahab recommended staff reexamine the tow fee structure and consider placing a cap on the fees as it was unfair for a working-class City to have such high fees for towing and vehicle storage, and brought awareness that with the increase in vehicle crimes, residents would be impacted having to pay high fees to get their cars out of tow yards.

Mayor Halliday recommended setting the effective date of the resolution adopting the FY 2021 Master Fee Schedule to July 20, 2020, instead of the proposed, Sunday, July 19, 2020.

Council Member Salinas offered a motion to approve staff's recommendation and Council Mendall seconded the motion. They both accepted Mayor Halliday's recommendation to set the effective date of the resolution to July 20, 2020.

Council Member Lamnin asked if residents could be eligible for the City's low-income waiver for tow fees and City Manager McAdoo noted staff could review and report back to Council.

LEGISLATIVE BUSINESS

City Manager McAdoo recused herself from participating on Item 16 due to her employment agreement and left the Microsoft Teams meeting.

16. Adopt Resolutions Amending the Employment Agreement Between the City Manager and the City of Hayward to Eliminate the City Manager's July 2020 Scheduled 2% Cost of Living Adjustment and Authorizing the Mayor to Execute the Agreement and Reducing the Mayor and City Council's Salary by 2% and the Mayor and Council's Travel and Miscellaneous Budget by 50% for Fiscal Year 2021 **LB 20-022**

Staff report submitted by Assistant City Manager/Interim Human Resources Director Hurtado, dated May 19, 2020, was filed.

Assistant City Manager/Interim Human Resources Director Hurtado provided a synopsis of the staff report.

Mayor Halliday noted that members of the City Council do not receive annual cost-of-living (COLA) increases and a salary reduction and reduction to Council's travel and miscellaneous budget by 50% was the approach to achieve cost savings.

Mayor Halliday opened the public comments at 8:55 p.m.

Public speakers participated by calling the City Clerk's office at (510) 583-4400.

Ms. Angela Andrews, Planning Commission member, thanked the City Council and staff for participating in cost savings, and encouraged them to continue to build reserves and review the use of food tracks, public markets and food hall to meet the demand for app delivery.

Mayor Halliday closed the public hearing at 8:57 p.m.

Members of the City Council applauded City Manager McAdoo's leadership in foregoing her scheduled July 1, 2% COLA, and appreciated labor groups and unrepresented groups that had already agreed to salary adjustments.

Discussion ensued among member of the City Council and City staff regarding the Council's travel and miscellaneous budget, Council dinner meals, and the amount of work and responsibility that entails serving in the capacity of elected official and keeping a salary financially feasible to attract and retain good people. It was noted that Council members had agreed to pay for their own Council dinner meals.

Council Member Wahab expressed she wanted to further reduce her salary by 5% and requested that City staff review her request.

Mayor Halliday suggested that if Council Member Wahab wanted to give more of her salary, she could donate to the Hayward Community Relief Fund.

Council Member Márquez supported the recommended reductions, noted she had made substantial donations to the Hayward Community Relief Fund to support the community, and did not agree to have the Council's salary further decreased.

Council Member Márquez offered a motion per staff's recommendation and encouraged everyone to contribute at any level to the Hayward Community Relief Fund.

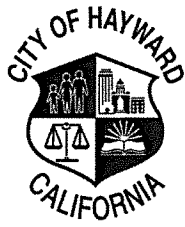
Council Member Salinas seconded the motion.

Council Member Mendall supported the motion, appreciated the City Council had decreased its salary and significantly reduced its travel budget, noted he had also made a substantial donation to the Hayward Community Relief Fund, and encouraged his colleagues to join the effort in helping individuals who are not receiving any support from the federal government.

Council Member Salinas noted the City Council had decreased its salary during the 2010 recession, agreed to pay more for health care costs during a budget deficit in 2014, and was proud it was stepping up again in agreeing to a salary reduction.

Mayor Halliday said that as City leaders were taking a first step, the rest of the organization will follow, and the City will survive the financial crisis as it had done ten years ago.

INFORMATION ITEM

17. Receive Informational Report Addressing Extended Timeframes to Reestablish Nonconforming Uses Due to COVID-19 Crisis **RPT 20-052**

Staff report submitted by Development Services Director Simpson, dated May 19, 2020, was filed.

The item served to inform the public.

Council Member Mendall expressed concerns about allowing blanket extensions for nonconforming uses especially warehouses in the industrial area and suggested sending the item to the Council Economic Development Committee (CEDC) for further discussion unless it needed to come before Council.

Council Member Salinas and Council Member Wahab supported sending the item to CEDC.

The City Council directed City Manager McAdoo to take the informational report to the Council Economic Development Committee for discussion/action.

CITY MANAGER'S COMMENTS

City Manager McAdoo provided an update on the Rent Relief Assistance Grant program administered on behalf of the City by Bay Area Community Services and the Hayward Family

Support Grant program administered by La Familia; encouraged all to make donations to the Hayward Community Relief Fund; provided an update on the commercial area parking program to modify traffic patterns and parking regulations to help support businesses as they resume operations; noted the City was working with the Downtown Hayward Improvement Association and downtown restaurants to come up with a program to help support restaurants as they reopen.

COUNCIL REPORTS AND ANNOUNCEMENTS

Council Member Wahab requested a status update on the feasibility of extending the eviction moratorium; requested more in-depth budget discussion materials; and asked to discuss a Health and Climate Resilience Tax Credit measure. City Manager McAdoo noted the measure would be a good discussion item for the Council Sustainability Committee.

Mayor Halliday noted she had signed a proclamation recognizing Law Enforcement Memorial Week which was sent to the Hayward Police Department, recognized the graduates of the 167th Police Academy, and thanked Council Member Wahab for suggesting a proclamation supporting Asian Pacific Islander Heritage Month and expressing the City's support for a resolution passed in the House of Representatives condemning anti-Asian sentiment. Mayor Halliday further noted such proclamation would be presented at the next Council meeting.

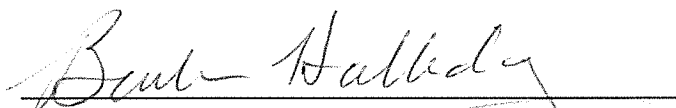

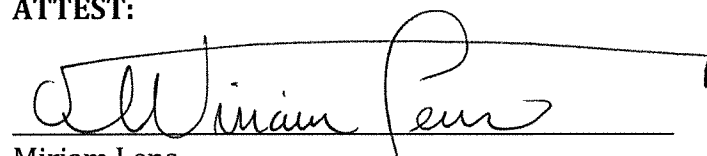
