1. Proposed Amendment to Chapter 10, Article 1 (Zoning Ordinance) of the Hayward Municipal Code related to Retail Sales of Tobacco and Tobacco Related Products.

A motion was made by Commissioner Patton, seconded by Commissioner Roche, to approve the staff recommendation with the added recommendation to have staff create a matrix of Commissioners' suggested amendments such as: stronger enforcement and regulation language, including buffer zones similar to Cannabis regulations; violators will be required to serve environmental community services on par with Keep Hayward Clean and Green Task Force clean ups; address concerns about the tobacco industry targeting certain ethnic groups; prioritize community health; and provide education and resource programs to address youth addiction. The matrix is to include staff response on whether staff would make these recommendations to Council, and to include the matrix as part of the staff report to Council.
