PUBLIC HEARING

8. FY 2022 Mid-Year Budget: Adopt a Resolution Approving the FY 2022 Mid-Year Budget Update and Receiving the General Fund Long Range Financial Model Update **LB 22-007**

Staff report submitted by Director of Finance Claussen, dated February 22, 2022, was filed.

Finance Director Claussen and Deputy Director of Finance Gonzales provided a synopsis of the staff report which included a summary of proposed General Fund Mid-Year changes in expenditures, updated General Fund 5-Year Forecast, long range General Fund reserve projection, and summary of proposed Mid-Year changes for CIP and other funds.



City Manager McAdoo acknowledged the outstanding work of the Finance Department and expressed gratitude for ARPA (American Relief Plan Act) federal funds. Mayor Halliday commended the City Manager, City staff and her Council colleagues for their help with the City budget.

Discussion ensued among members of the City Council and City staff regarding: the real time financial forecasting tool; analysis of staffing levels in every department; a strategic plan for Human Resources to address staffing levels to support the organization; 20% reserve funds; Measure C forecast and unmet capital needs; cannabis tax rate; FEMA reimbursements; cannabis businesses that have not started operating; the estimate for a new Police building which was projected at \$90 to \$110 million; tax as a source of revenue; and reserve projections.

Mayor Halliday opened the public hearing at 7:45 p.m.

Suzanne agreed that it did cost a lot to build a new City building, but noted that the longer the City waited, the more it would cost.

Mayor Halliday closed the public hearing at 7:46 p.m.

Members of the City Council expressed appreciation for the work of City staff, especially during COVID,

Council Member Zermeño made a motion to approve staff's recommendations and Council Member Wahab seconded the motion.

Council Member Wahab recommended increasing reserve levels a couple percentage points in the event of another emergency such as COVID, supported maintaining and improving City infrastructure, wished the City would be strict on licenses, including those for cannabis businesses, that are not operating within two years of obtaining their licenses, opposed raising taxes for residents, appreciated working with her colleagues on the Council Budget Committee and stressed the importance of investing in the Information Technology Department to monitor cyberspace.

Council Member Andrews was concerned about relying on cannabis to generate revenue, expressed she would like businesses to start generating sales tax and find ways to help support further economic development, and recommended locating funds for public art as a preventative measure.

Council Member Márquez wanted to better understand staffing levels as well as outstanding infrastructure needs, reminded all that Measure C and the Utility Users Tax had sunset dates, recommended strengthening the Economic Development team for the high results it yields for the community, and reminded all to continue to shop in Hayward.

Council Member Salinas remarked that the reserve policy and budget policies came out of the economic downturn, and noted thoughtful disciplined actions taken over the years have yielded positive results, including through the pandemic.

Mayor Halliday stressed the importance of striking a balance, noted the City must continue to provide services to the public while noting that this year was the healthiest since she was in office, acknowledged ARPA funds helped during the pandemic, noted the City needed to maintain a healthy staffing level while balancing all needs, and suggested some changes could be revisited based on comments during discussions over the FY23 budget.

Mayor Halliday adjourned the City Council meeting at 8:11 p.m., in memory of Ms. Paulette Arteaga and Ms. Christine Ochoa.

Ms. Paulette Arteaga was a Hayward resident, longtime postal worker, active member of Glad Tidings Church, founder of the annual event - Pink Ribbon Tea - held for those fighting cancer and their families and was the sister of former City Clerk Angelina Reyes.

Ms. Christine Ochoa was a resident of the Southgate neighborhood, wife of educator Anthony Ochoa for whom Ochoa Middle School is named, mother of local author Dr. Maria Ochoa, mother-in-law of former Hayward Mayor Michael Sweeney, Library Commission member, tutor with Literacy Plus, member of the FESCO Board, member of the Kaiser Hospice Program, counselor at a continuation high school, and someone who always had kind words.

Mayor Halliday asked City staff to work with their families to plant trees in their memories. Mayor Halliday also suggested this might be an opportunity to rededicate Anthony Ochoa's plaque at the Heritage Plaza and add Christine Ochoa's name.
