INTERVIEW PROCESS

INTERVIEW TIME

- **Thirty (30) minutes for each applicant**
- **Three (3) minutes to present their qualifications and discuss their candidacy.**
- **Two (25) minutes for Council to ask questions and for candidates to respond.**
- **Two (2) minutes to make closing remarks.**

INTERVIEW PROCESS

INTERVIEWS

- **There are no pre-established questions.**
- **Mayor allows each member of the City Council to ask one question of each applicant.**
- **Mayor will manage the starting order of questions with each candidate, rotating among members and ensuring the same questions are asked of each applicant.**

INTERVIEW PROCESS

NOMINATIONS

- **Mayor calls for nominations.**
- **Nominations do not require a second. A motion and a second are required to close nominations.**

INTERVIEW PROCESS

VOTE

- **Mayor calls for a vote on each nominee.**
- **The first nominee to receive four or more votes will be the new member. Members do not have to vote and can abstain from voting if they wish.**
- **Voting will continue until one nominee receives four votes.**

APPOINTMENT OF NEW MEMBER

APPOINTMENT (LB 23-005)

- **Mayor calls for a motion to approve a resolution appointing a Council Member for the City of Hayward.**

APPOINTMENT OF NEW MEMBER

OATH OF AFFIRMATION

- **Mayor directs City Clerk to administer the oath of affirmation to new member of the City Council.**
