Item # 3: [CONS 19-415](#) Adoption of an Ordinance Amending Chapter 10, Article 1 (Zoning Ordinance) of the Hayward Municipal Code by Rezoning Certain Property to Planned Development District in Connection with Zone Change and Vesting Tentative Map Application No. 201603891 to Accommodate 19 Single-Family Homes at 29080 Fairview Avenue

Agenda item 3, consent item regarding Cavallo Highlands...  
The revised condition of approval number 64 relates to solar ready roofs, but the project is required to have solar installed. Is that a conflict?

Technically, condition number 64 is not needed but there is information in the condition that calls attention to current specific building code requirements for “solar ready” or solar installation on all Cavallo Highlands units’ roofs. Staff kept in the condition to be sure the applicant is aware of the roof design criteria and the installation of solar on each new Cavallo Highland’s residence.

Training explanations:

- Professional Development – Training in leadership through programs like the FBI National Academy, Command College, SMIP, LAPD Leadership, SLI, Inner Perspectives, etc.
- Technical Skills – Training in POST perishable skills (driving, firearms, arrest and control, etc.) as well as new concepts (e.g. Communication, De-Escalation, Use of Social Media, etc.)
- Promotion/Assignment – Training that is required by POST based on an employee’s promotion (POST Supervisory/Management Course) or entry into a new assignment (e.g. Narcotics Investigations, Traffic Collision Investigation, FTO, etc.)
- Updates – Training that is designed to provide procedural/legal updates to employees who are already training in a particular area (e.g. FTO Update, Arrest and Control Update, etc.)

2. Also, is there data about the cause of employee separation from the department (retirement, transfer to another agency, medical retirement, etc...)?

Item # 11: [PH 19-041](#) Adopt Resolutions to Approve the Engineer's Report, Reconfirm Maximum Base Assessment Rate, Confirm the Assessment Diagram and Fiscal Assessment, Order the Levy and Collection of Fiscal Assessments, and Approve Funding Recommendations and Appropriate Revenue Funds for Maintenance District No. 2 - Eden Shores Storm Water Buffer and Facilities, for Fiscal Year 2020 (Report from Maintenance Services Director Rullman)

For the Eden Shores Maintenance District, does the HOA contribute to the District? There is a budget expense for Maintenance - Landscaping - ES HOA (item c under services). Does the HOA cover this cost?

Historically, the HOA paid the contractor directly and the City reimbursed for landscaping expenses. However, after regular inspections revealed inadequate maintenance work being performed by the previous contractor, the City recently conducted an RFP and awarded a new contract for the specified maintenance scope. Under the new agreement, the City will pay the contract expense directly.

Item # 13 [PH 19-053](#) Public Hearing to Consider the Formation of Benefit Zone No. 18 of the Consolidated Landscaping and Lighting Assessment District No. 96-1 for the SoHay Properties (Report from Development Services Director Simpson)

Does the SoHay LLD have any financial responsibility for the creek running through the property? If not, perhaps we should modify the zone's governing documents to include responsibility for the creek? That would give the city a long-term source of funding for improvements and maintenance of the creek. Something that we have struggled to do so far.

The SoHay LLD was not intended to have financial responsibility for the flood control channel. The Alameda County Flood Control & Water Conservation District (ACFCWCD), intends to continue to maintain the flood control channel. ACFCWCD has been a part of the review of the development and did not express any concerns or needs in-terms of additional funding. The land which the flood control channel is on has been reserved to be conveyed to ACFCWCD and the funding for the channel maintenance will continue to be managed by ACFCWCD.

Also, with regards to improvements around the flood channel - the access road and fencing along the south-side of the channel is included as part of the park and will be maintained by HARD through funding received from the LLD and the fencing on the north-side along with the new pedestrian bridges will be funded and maintained by the HOA.

Lastly, since the flood control channel is considered a regional facility that conveys stormwater from areas outside of the development, there is a challenge to make a finding that the channel provides a Special Benefit vs. General for the properties to be assessed within the LLD.
