AN ORDINANCE OF THE CITY OF HAYWARD AMENDING CHAPTER 7, ARTICLE 2 (STREETS)  
CLARIFYING THE DUTY TO MAINTAIN AND REPAIR SIDEWALKS

THE CITY COUNCIL OF THE CITY OF HAYWARD DOES ORDAIN AS FOLLOWS:

Section 1. Chapter 7, Article 2, of the Hayward Municipal Code is hereby amended to read as follows:

Section 2. Severance. Should any part of this Ordinance be declared by a final decision by a court or tribunal of competent jurisdiction to be unconstitutional, invalid, or beyond the authority of the City, such decision shall not affect the validity of the remainder of this Ordinance, which shall continue in full force and effect, provided that the remainder of the Ordinance, absent the unexcised portion, can be reasonably interpreted to give effect to the intentions of the City Council.

Section 3. Effective Date. In accordance with the provisions of Section 620 of the City Charter, the Ordinance shall become effective 30 days after adoption by the City Council.

Introduced at a meeting of the City Council of the City of Hayward, held on the 28<sup>th</sup> day of October 2025, by Council Member Zermeño.

This Ordinance will be considered for adoption at the regular meeting of the Hayward City Council, to be held on November 18, 2025, at 7:00 p.m.
