Re: Public Comments: Public Demand To HPD, HAS & City To Produce Public Record Or Be Sued For Gang Stalking, Privacy Invasion, Conspiracy, Retaliation, CPRA Violations, 1st & 4th Amendment Violations, Crimes, Corruption & Discrimination Etc.

Dear All,

I have made a few public record requests to this City since 2021 at least to date for a number of records by email, orally and by its record request form etc.

As far as I can recall, you have hardly produced those records blatantly and corruptly violating California Public Records Act. You have been anything but helpful or transparent.

City Clerk's Office staff who does this work daily handling public records requests has acted quiet ineffectively, sometimes incompetent, ignorantly, indifferently, untimely and annoyingly and has deliberately frustrated me knowingly I feel. It has been disappointing.

There are by now hundreds of instances to recount on this but I will focus on sharing one recent one.

For example, I had requested Ms. Karen Fung and Ms. Lens multiple times to send me a copy of all the replies of the City on my records requests but for months they failed to do so and even after many voicemails I left for them, they either did not call me on most or when they did they just said they were on a holiday, not in the office, busy with meetings or were calling back without answering on the topic. This way, they kept tagging me along wasting my valuable time I could have used elsewhere. They have showed no respect for my time or care for the urgency of my requests ever. I believe this was their ill intention.

Dealing with them and entire City staff has made me feel like what kind of uncaring people am I dealing with. An animal I deal with shows me more compassion than these indifferent team members of the City and society including the City Council and Mayor Mark Salinas I am utterly disgusted to realize how total frauds end up in these elected positions sometimes when in reality they do not honor the laws, constitution, care for public's safety and act fair at all as proved to me by their inactions and actions.

Then on April 28, 2025, I spoke to Ms. Lens and Ms. Fung again communicating in detail the replies I had been needing them to send me. Also, repeatedly I had advised them to not mail me any signature requested mail as if the mailperson misses me, then I am not readily able to run to get it from the post office for various reasons, one being my car is disable.

They still mailed me certified mail and I missed mailperson. It reached me later than sooner. The fact the staff could not recall or honor a simple request or showed some understanding on it is indicative of their incompetence.

Moreover, days later I received around May 3, 2025, an envelope that had no copies of documents of their replies to my record requests. I spoke to Ms. Lens again yesterday and it took me many minutes to clarify to her what I needed and then she agreed to send it. I mean how on earth sometimes I have wondered she became the head Clerk of this City with this degree of effectiveness. I saw her interact with elected officials at Council Meetings and it made me feel that she can do things there fine so why she acts that way with me. It makes me feel that she and her staff are doing all this drama of calling me late, not calling me, calling me but not answering my queries or not doing as discussed to spin me endlessly to make sure I miss any statute deadline to pursue my legal recourses against the City.

It feels like someone else is calling the shots on how my records requests should be handled or delayed endlesly. Either way it is just wrong. For these officials it is nothing but some records and a job but to me it has greater value and impact on my life. They can stay calm in all of it as their home is not invaded and property is not being stolen daily 400+ times in a row and their animals are not killed. For me to go through such crime spree and make time to keep after getting my records from the staff requires tremendous patience. They cannot and should not instigate me with their delay tactics. First they instigate me and then they cry wolf.

Then what I received from her included few pages of my requests' copies from City's GovQa system. One it confirms City violated my request to not post my requests and its results online and second its font print is so tiny that even with glasses and a magnifier I was having hard time reading it. Why on earth they sent it like that other than being harassing.

Interestingly, City of Fremont's FPD staff Captain Matthew Snelson recently sent me a record printed that tiny too. I do not think it is a coincidence as he with COF is being sued by me for corruption and crimes against me.

The cult of the government corrupt official participate in orchestrated harassment and gang stalking and that entails all this what I go through with the City. I feel since I filed a claim against the COH for its corruption before, the City via its staff is retaliating in railroading me currently. It is doing its best to not produce the records that are helpful in proving its crimes, conspiracy and corruption and of its accomplices like FPD, FBI and others.

It is against the law though to discriminate against me and deprive me of the public records.

My request for records have entailed copies of emails, texts, voicemails, audio recordings, body and dash cams, security cameras footage, 911 and other police calls, police and incidence reports, staff names, titles, contact numbers and emails, addresses, APB & BOLO data, record retention policies and procedures, drones, satellites, planes and military grade equipment records, animal shelter volunteers records, my records request records and more. They surprisingly have withheld most 99.9% of it. If that in itself is not indicative of City's corruption and lack of ethics, I do not what else is.

There has been extensive communication I have had with City Clerk's office. They are either ignorant or sociopaths to not realize what I am going through at the hands of my government's harassment and participate in gang stalking/harassment against me.

Ms. Lens referred me to City Attorney Michael Lawson and Amy Rothman many times to discuss denials, exemptions and redactions of my records. They acted unprofessionally to be unresponsive. Another indication of poor quality of people there that I have to contend with. Like a hypocrite, Lawson seem to act appropriately with City Council, Mayor and other staff, but he called and spoke to me as if I was his inferior or slave. The reality is that you all work for us the public members but you show little respect to those who put you there.

The Hayward Police Department and Animal Shelter staff have been quiet deceptive, corrupt and dishonest. They failed to return most of my calls. I briefly have a few conversations with Ms. Christina Santana and some police staff. She failed to call me back but wrote me a letter that she could not reach me all the while when I was leaving her voicemails to call me. Then some police officer there lied to me that one of my police report and follow up emails were not there. Months later, HPD produced that car vandalism report. HPD also failed to release records of my extensive emails to them. They could not be more corrupt.

A HPD officer Richard McLeod was arrested for sex crimes on children.

Michael Lawson has to be quiet unethical negligent to not prevent HPD, HAS or City Clerk from violating all kinds of laws in connection with my records requests and dealings with them for their services. He himself tried to bully me by dictating to me as if I could not freely associate with the City staff.

Also, when I enter Hayward, HPD and City of Hayward stalks me relentlessly like predators. It is too harassing and unconstitutional. They monitor and record me by street lights and cameras 100%. All that record is there and they want to hide it corruptly. Why?

Even some security guards were rude and were trying to harass me and violate my rights upon visits to the public City Hall. One deliberately disappeared to delay checking me into the building and another hoped to block me from reaching the Clerk's office. When I simply asked on this to Ms. Lens, she even delayed a response on it and were making excuses for the guards clearly showing someone else coaches her how to respond to me.

HPD had illegally asked and obtained my driver's license's copy from FPD in mid 2021. I saw that in written communication between both then. In my being hacked and burglarized my record of it disappeared. Now both FPD and HPD is hiding that record. Mayor Salinas must be out of touch with reality to think HPD is good. They are some there who are predatory, stalkers, hackers, thieves, cats dumpers and killers and vandals that I can establish by their own records. I understand kissing upto police team means more perks and votes but what about having some guts and morals to do the right thing?

So, when I had reported a car vandalism incident in April 2024 online to HPD upon a visit to Hayward, where I suspected 99% of their operatives- involvement in it, they made lame excuses to not have acted on it. There were cameras there that likely had footage of who broke in my car, vandalized it and fitted it with a gps tracker. HPD cannot be considered competent or oh so effective force who could not even investigate such solvable crimes.

Some of their staff are nothing but illegal psycho vultures just like some staff at FPD, UCPD, OPD, NPD, SJPD, SFPD, FBI, CIA, NSA, USAF, DOJ, US Army and Military and others who are part of the "deep state" actors who participate in gang stalking.

What freedoms and benefits you all folks are enjoying today are due to the sacrifices of poineers and brave people like Martin Luther King Jr., Cesar Chavez, Rosa Parks, Thurgood Marshall, Ralph Anernathy and others and not because of ruthless folks who are hypocrites and cannot even act ethical, right, fair and honor the law. You stand there pledging alligance to US Flag but you disrespect US's Constitution when you violate my constitutional rights and scheme with the federal and local government to stalk, destroy and railroad me.

I bet none of you like it if police and FBI put bugs in your home, vehicle, came in your home daily after drugging you to sleep, beat you in your sleep cowardly, kill your animals, lurked over your home in satellites and drones and deprive you of all protections under the law as if you were nothing. However, when they are doing this to me terrorizing me, you sit there and do nothing and support them in their crimes against me sneakily.

I object. In conclusion COH, produce the record, render me services equally, stop this abuse of power and do the right thing or get out of the public office if you cannot effectively represent us public and if you illegally prey upon us.

This is not inclusive of all my concerns and complaints against the City but this would give you some idea of things ongoing to rectify and improve soon or else face the music, a big legal action.

If you still do not get it, I will take legal action against each and every one of you in time on this. Do NOT retaliate for my having expressed here candidly as it is my 1st Amendment right to free speech and expression. If you had acted with integrity, I will have had a different opinion about you. It is only in your hands to change it or futher confirm it.

Dear Mayor, Council Memebers & City,

I have recently raised a few urgent and serious concerns in my public comments emails submitted to your attention in the past few months which I incorporate here as a reference so please take a note of them too in conjunction with this one.

Upon checking with the Clerk Ms. Lens there has been no input or recourse taken by you on them.

My raised concerns and grievances continue to exist as Hayward Police Department, City Attorney's Office and Clerk's Office still is not replying my calls and providing answers timely and as needed. City Clerk missed returning few of my calls in past week and two again.

City staff is paid to reply to public business but clearly they are defying it often especially HPD, City Attorney and Hayward Animal Shelter unprofessional staff.

I have been forced and stressed to invest or waste an amount of time and effort to follow up with the City that could have been avoided if it was handled timely, efficiently, effectively and unbiasedly by the staff. Clearly I am selectively and disparately treated there.

I am a target of gang stalking of HPD and even the City here that is very obvious to me in several ways which I have and will explain later further.

The City needs to do the professional, ethical, non discriminatory and effective thing to handle my public business with it as that also conserves resources and time of the City.

My public records requests have been illegally handled and not fully honored. The City cannot put its self defense tactics over my 1st Amendment rights to free speech, movement and redress my issues there. The California Public Records Act and California Transparency laws require City to produce certain records and they are not. The City Attorney is a joker as he left me voicemails claiming he will produce records legally only then to not do so and then he fails to return my calls also acting blatantly unprofessional. Tell me why City has such an unethical lawyer paid by taxpayers' taxes?

HPA and Hayward Animal Shelter at least have been involved and in conspiracy with others including Fremont Police Department and FBI at minimum in gang stalking me, my being hacked, my cat rescues and pets being stolen, my home, vehicles and storage being burglarized and vandalized and in my attempted murder etc.
