## **CLOSED SESSION ANNOUNCEMENT**

The City Council convened in closed session on May 20, 2025, at 5:30 p.m., with all members present and no public speakers, regarding two matters: 1) public employment pursuant to Government Code section 54957 regarding City Manager; and 2) public employment pursuant to Government Code section 54957(b)(1) regarding City Attorney. Item 3, concerning the conference with labor negotiators regarding Hayward Police Management Unit, was dropped from the agenda and was not discussed.

Mayor Salinas announced that the City Council considered the employment of City Manager Dr. Alvarez and after due consideration, the City Council unanimously approved, with Mayor Salinas moving and Council Member Roche seconding, to place City Manager Dr. Alvarez on administrative leave with pay while the City Council continues the evaluation process. In the interim, City Attorney Lawson will be the Acting City Manager. City Attorney Lawson noted that Item 2 was continued to May 27, 2025, and Item 3 was not discussed.

There was no announcement related to the May 13, 2025, City Council closed session, but the item will be added to May 27, 2025.

#### **PRESENTATION**

Mayor Salinas read a proclamation declaring May 11, 2025, through May 17, 2025, as National Police Week and May 15, 2025, as Peace Officers' Memorial Day in the City of Hayward. Police Chief Matthews accepted the proclamation on behalf of the Hayward Police Department.

## **PUBLIC COMMENTS**

The following employees expressed gratitude to the City Council for recognizing the concerns of City staff, taking action regarding the City Manager, and preserving the organization values of caring, openness, and integrity; spoke on behalf of those who felt intimidated to speak; praised the City Council for demonstrating true leadership characterized by empathy and

responsiveness; asked to ensure that any future leadership recruitment is approached with transparency and scrutiny; noted the decision as a turning point to rebuild trust and strengthen collaboration and accountability between leadership and employees; and reaffirmed HAME's commitment to supporting the City's operations and addressing future challenges such as the budget deficit.

Staff report submitted by Police Chief Matthews, dated May 20, 2025, was filed.

Council Member Syrop clarified that it was not his intention to delay the item from the previous meeting; expressed appreciation for the improved detail in the staff report; noted that many of their earlier concerns, particularly regarding the nature of the surveillance cameras, were addressed; voiced ongoing concerns about the broader implications of expanding surveillance infrastructure, especially in light of Hayward's sanctuary city status; and cautioned against the influence of federal funding potentially compromising the City's values and policies in the future.

Mike Katz-Lacade, Director of Research for Oakland Privacy, spoke in opposition to the proposed addition of 30 license plate readers, citing minimal improvement in vehicle recovery rates since their initial installation, concerns over a one-year data retention policy, and a lack of justification and transparency in the staff report.

Theresa Resendez supported the use of license plate readers, emphasizing their value in tracking data, recovering stolen vehicles and solving crimes like hit-and-runs, and stressed the importance of listening to police input to reduce the City's legal and financial liability.

#### **PUBLIC HEARING**

9. Universal Residential Design: Introduce an Ordinance Amending the Hayward Municipal Code to Add Article 9, Chapter 9 (Building Regulations), Establishing Universal Residential Design and Visitability Standards, and Finding the Amendments Categorically Exempt from CEQA Review Pursuant to Section 15061 (b)(3) of the CEQA Guidelines (Report from Development Services Director Buizer) PH 25-019

Director of Development Services Buizer announced the item and introduced Planning Manager Lochirco who provided a brief presentation of the staff report.

In response to Council Member Roche's request of clarification on the proposed universal residential design features, Planning Manager Lochirco noted that while homes must be designed to allow for future installation of features, such as lower light switches, door levers, wall reinforcements, the elements are not required to be installed upfront; and added that additional construction costs were minimal, intended to support aging in place and accessibility without imposing significant financial burdens.

There being no speakers, Mayor Salinas opened and closed the public hearing at 7:47 p.m.

Council Member Goldstein made a motion to approve staff's recommendation and Council Member Syrop seconded the motion.

Council Member Roche expressed support for universal residential design standards and commended the City's efforts to support aging in place and multigenerational accessibility.

Council Member Syrop echoed support for the initiative, framing it as both senior and disability justice; and acknowledged the significance of embedding universal design into housing ordinance and expressed interest in monitoring developer feedback as the policy is implemented.

Council Member Andrews supported the recommendation emphasizing that incorporating universal design features supports dignity for residents with different needs, similar to past efforts involving lockout units in developments.

Planning Division staff were commended for their continued work with universal residential The Planning Commission and Council Housing Policy & Resource design standards. Committee were acknowledged for their review of the item.

Development Services Director Buizer announced the item and introduced Associate Planner Richard who provided a synopsis of the staff report.

In response to Council Member Syrop's inquiry about the discrepancy between the current General Plan Land Use designation - Medium Density Residential (MDR) and the current Zoning - Low Density Residential (RL) for the project site and why the City had not aligned zoning with the General Plan, Associate Planner Richard clarified that the Hayward Residential Design Study addressed this by allowing to default to General Plan density while maintaining the RL neighborhood form. Council Member Syrop also inquired about ways to

streamline the rezoning process but acknowledged staff's assessment that such cases are infrequent and not currently a barrier to development.

Council Member Roche expressed support for the project, noting it fits the character of the surrounding neighborhood; was satisfied to hear each unit has a two-car garage and additional visitor parking, received confirmation that there was no neighborhood feedback; and expressed appreciation for the architectural design features.
