

The City Council meeting was called to order by Mayor Salinas at 7:00 p.m. The City Council held a meeting in the Council Chambers.

Council Member Andrews joined the City Council meeting at approximately 8:20 p.m.

## **CLOSED SESSION ANNOUNCEMENT**

The City Council convened in closed session on December 17, 2024, at 5:30 p.m., with all members present and Council Member Andrews absent and no public speakers, regarding four items: 1) conference with legal counsel pursuant to Government Code section 54956.9, regarding Jerry Schilling v. City of Hayward, Claim No. 202100103HAY, Workers' Compensation Appeals Board Case No.: ADJ14012944; 2) conference with property negotiators pursuant to Government Code section 54956.8 regarding Caltrans Parcel Group 5, Bunker Hill; 3) conference with legal counsel pursuant to Government Code section 54956.9(d)(2), regarding one anticipated litigation; and 4) conference with legal counsel pursuant to Government Code section 54956.9(d)(1) regarding Terry Ray Gentry, Sr., et al. v. City of Hayward, et al. United States District Court Case No. C24-02593 JD.

City Attorney Lawson indicated that the Council met regarding all items, except for Item 3. Regarding Item 1, the Council gave direction to staff and unanimously approved, with Council Member Goldstein moving and Council Member Syrop seconding, compromise and settlement of the matter; regarding Item 2, the Council gave direction to staff but otherwise took no reportable action; regarding Item 4, the Council approved, with Council Member Zermeño moving and Council Member Goldstein seconding, compromise and settlement of the case in the amount of \$190,000. City Attorney Lawson added that pursuant to Government Code section 54954.2(b)(2), the Council unanimously added, with Council Member Roche moving and Council Member Syrop seconding, discussion of appointment and employment of public employment, to wit: City Manager; and the Council took no reportable action on the matter.

## **PUBLIC COMMENTS**

TJ with Hayward Concerned Citizens expressed gratitude to the Council and City staff, for their responsiveness to the group's questions throughout the year; and praised Access Hayward for its swift responses related to graffiti removal from neighborhoods.

Mayor Salinas exercised the chair's prerogative to announce that Moreau Catholic High School's football team represented Hayward and won the Northern California Division 7-AA championship, congratulated the team, and thanked them for the signed football they gifted him.

Tommy Abdenour, Moreau Catholic High School's Athletic Director and proud 2008 alumnus, expressed pride in the school's football team for making history by winning their first NCS title, followed by Northern California Division 7-AA championship; highlighted the team's dedication to representing Hayward; and thanked the City for its support.

Council Member Zermeño shared a personal connection to Moreau Catholic High School, noting his daughters' success due to their education there and recalling a former student from the school's 1992 state championship women's basketball team; and congratulated the team.

## **CITY MANAGER'S COMMENTS**

Interim City Manager Claussen made two announcements: 1) City Hall and the Library will be closed for the holidays from December 23, 2024 to January 6, 2025, with online library resources and essential services remaining operational; and 2) the Orchard Avenue Traffic Calming Project started, and the City welcomes feedback before making permanent changes.

Mayor Salinas noted the pilot Orchard Avenue traffic calming measures were in response to community concerns related to speeding, reckless driving, and sideshows; and data collected will inform adjustments.

Mayor Salinas opened public comment at 7:12 p.m.

Tom Ferreira, Keep Hayward Clean and Green Task Force Chair, advocated for preserving the historic City Hall building, noting its significance as a community centerpiece and its approaching 100-year anniversary; acknowledged recent vandalism and fire issues and suggested safeguards such as an alarm system; and proposed the building's potential future use as a Hayward Historical Society office, and possible designation as a state landmark.

TJ with Hayward Concerned Citizens acknowledged the building's architectural significance and its documentation by the Historical Society; expressed sadness over its deteriorated state; and questioned the use of funds for minor repairs when full restoration seems unfeasible, and priority is given to other infrastructure projects.

Council Member Roche emphasized the importance of incorporating slightly decorative, nonglass doors to replace the plywood currently on the historic City Hall, balancing functionality with its historical character; and highlighted the necessity of planned safety repairs to protect first responders and prevent further damage.

## WORK SESSION

13. Let's House Hayward Strategic Plan: Implementation Update and Discussion of Next Steps (Report from Assistant City Manager Youngblood) **WS 24-038** 

Staff report submitted by Assistant City Manager Youngblood, dated December 17, 2024, was filed.

Community Services Manager Cole-Bloom provided a synopsis of the staff report.

Mayor Salinas opened the public comment section at 7:32 p.m.

Theresa Rezentes announced the Housing Policy and Resource Committee (HPRC) meeting on December 19, 2024, at City Hall, noting the committee meets quarterly and provides an opportunity to learn more about housing-related matters.

Vasco Jorgov, speaking on behalf of House Hayward Now, highlighted the urgent need to address student homelessness in Hayward; and urged the Council to explore two solutions for inclusion in the Let's House Hayward Strategic Plan: 1) hiring a housing navigator to assist students and their families in accessing resources and navigating housing systems, and 2) providing security deposit assistance to remove financial barriers to housing.

Ro Aguilar commended the Let's House Hayward Strategic Plan implementation accomplishments and suggested to: create hotel conversion projects by community-based entities, prioritizing youth; programs for homeless individuals with no or minimal income; formation of a JPA to hold accountable jurisdiction that are not building affordable housing; implement a security deposit assistance program; refer the one-time revenue use policy to the HPRC for evaluation; and track/report progress on housing homeless individuals.

Aaron Horner, South Hayward Parish Outreach Director, highlighted the urgent need to support unhoused students, increase housing solutions, and to continue the strategic planning and collaboration among agencies and service providers to humanize and address the homelessness crisis effectively.

Sarah Lamnin, Hayward Community Action Network former director, urged continued collaboration with community experts in the implementation of the Let's House Strategic Plan, including voices with lived experience, and leveraging resources such as vacant properties to collectively work toward ending homelessness in Hayward.

Mayor Salinas closed public comment at 7:46 p.m.

Members of the City Council were in general agreement with the City's response to homelessness in the Let's House Hayward Strategic Plan, commended Hayward's coordinated and purposeful approach to addressing homelessness, and thanked City staff for their leadership in this work.

Council Member Syrop emphasized that homelessness remains a top issue for Hayward, urging a focus on addressing root causes rather than short-term solutions; advocated for prioritizing student homelessness within the Let's House Hayward Strategic Plan by implementing dedicated housing navigators to support unhoused students and their families, as well as a security deposit assistance program to remove barriers to housing; and highlighted the importance of better coordination and collaboration between service providers, schools, and the City, noting that addressing student homelessness is critical for improving educational outcomes and tackling broader housing challenges.



Council Member Roche emphasized the importance of coordinating efforts to address homelessness and advocated for prioritizing funding toward programs with proven outcomes; and highlighted the need to focus on prevention and permanent housing, including identifying and supporting families at risk of homelessness.

In response to Council Member Bonilla Jr.'s inquiry about efforts to transition people from shelters to long-term housing, Jamie Almanza with Bay Area Community Services (BACS) indicated they work with landlords to utilize flexible funding for first and last month's rent, embedding employment support services as well as disability assistance. Aaron Horner stressed the importance of shelters as critical "off-ramps" from homelessness, despite their limitations as long-term solutions.

Council Member Bonilla Jr. emphasized the importance of aligning Hayward's homelessness efforts with county and regional partners to maximize funding opportunities and address chronic homelessness; and supported prioritizing student homelessness through collaborative efforts, leveraging local agencies, and ensuring solutions are informed by those with lived experience.

Council Member Goldstein encouraged evaluating how better coordination among service providers, potentially led by the City, could align resources, reduce duplication of effort, and have a greater impact; stressed the importance of identifying and addressing gaps and measuring program effectiveness; and proposed focusing on the 309 unhoused students in Hayward as a starting point and calling for a collaborative plan to provide housing solutions for this vulnerable population.

Council Member Zermeño emphasized the importance of regional collaboration and setting realistic goals to lower, rather than completely eliminate, homelessness; highlighted the need for targeted prevention programs to support at-risk populations, such as low-income residents and students; and advocated for continued investment in affordable housing.

Council Member Andrews disclosed having met with Aaron Horner; suggested exploring whether the working group model at Weekes Park could be expanded citywide; emphasized the need for better engagement with Black-focused organizations to address disparities in service access; advocated for 24-hour mental health support; highlighted the importance of applying a racial equity lens to homelessness programs; and urged the inclusion of amenities in affordable housing projects to benefit residents and surrounding communities.

Council Member Bonilla Jr. supported exploring a housing navigation center for students, potentially in collaboration with the Hayward Area Recreation and Park District (HARD) and Hayward Unified School District (HUSD); emphasized the importance of centering people with lived experience in decision-making roles and suggested requiring funded organizations to

include such voices in leadership positions; urged leveraging City influence to ensure Hayward receives its fair share of Measure W funds; and echoed Council Member Andrews' comments to continue centering the work through a racial equity lens.

Council Member Syrop echoed Council Members Bonilla and Andrews' comments; and received confirmation that the Hayward Evaluation and Response Teams (HEART) program connects the team to the service for homeless individuals.

In response to Council Member Syrop's inquiry about better coordination among housing navigators and service providers, particularly for addressing student homelessness, Community Services Manager Cole-Bloom noted the Council can provide direction in terms of financial support indicating HUSD holds the expertise and resources to lead efforts for student homelessness.

Mayor Salinas concurred with Council discussions on homelessness and emphasized the need to hold HUSD Board and Alameda County Office of Education accountable for supporting unhoused students, given their designated funding and responsibilities; shared examples of innovative housing efforts by the City, including affordable housing projects and potential collaboration with Chabot College for student and family housing, that resulted in missed opportunities due to lack of support.

Community Services Manager Cole-Bloom summarized the Council's feedback, noting there was general agreement to continue with the existing Let's House Hayward Strategic Plan priorities, while focusing on student homelessness in collaboration with policy partners; emphasized the importance of prioritizing impactful solutions, aligning efforts with the county, and continuing to work with the work of the Alameda County Mayors' Conference; and being intentional about centering racial equity in all strategies.

Council Member Syrop, as the Council liaison to the Personnel Commission, made a motion to move the item acknowledging the commissioners' concerns and thanked them for their diligence, while expressing confidence in the City's negotiated terms and updated salary plan.
