RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT AND APPROPRIATE \$186,667 IN HOMELESS HOUSING, ASSISTANCE AND PREVENTION (HHAP) FUNDING TO SUPPORT HAYWARD NAVIGATION CENTER OPERATIONS

WHEREAS, the HHAP grant administered by the State of California Business, Consumer Services, and Housing Agency (BCSH) provides jurisdictions with funds to support regional coordination and expand or develop local capacity to address their immediate homelessness challenges; and

WHEREAS, the City of Hayward entered into an agreement with the County of Alameda for the allocation of \$589,391 in HHAP Round 1 and HHAP Round 2 funds; and

WHEREAS, the funds awarded through this agreement were intended to support operations at the Hayward Housing Navigation Center (HNC); and

WHEREAS, through HHAP Round 3 the County of Alameda was awarded \$11.2 million, and the County of Alameda Continuum of Care was awarded \$12.0 million; and

WHEREAS, through HHAP Round 4 the County of Alameda was awarded \$12.2 million, and the County of Alameda Continuum of Care was awarded \$13.0 million; and

WHEREAS, the County of Alameda amended its agreement with the City of Hayward for HNC operations by adding \$487,981 in HHAP Round 3 and Round 4 funds, changing the total not-to-exceed amount to \$1,077,375;

WHEREAS, through HHAP Round 5 the County of Alameda was awarded \$13.5 million, and the County of Alameda Continuum of Care was awarded \$14.0 million; and

WHEREAS, the County of Alameda amended its agreement with the City of Hayward for HNC operations by adding \$186,667 in HHAP Round 5 funds, changing the total not-to-exceed amount to \$1,264,042; and

WHEREAS, HHAP Round 5 funds have been designated to support the HNC operations, an eligible use.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward authorizes the City Manager to accept and appropriate \$186,667 in HHAP funding from the BCSH through the County of Alameda to support the Hayward Housing Navigation Center operations in FY 2024-2025.

BE IT FURTHER RESOLVED that the City Council of the City of Hayward authorizes the City Manager or her designee to amend the FY 2024-2025 funding sources to include said HHAP funding in the amount of \$186,667 to support the agreement between the City and Bay Area Community Services (BACS) for an amount not-to-exceed \$2,500,894.
