Management Analyst Cole-Bloom provided a PowerPoint presentation on the Residential Rent Stabilization Threshold Analysis that focused on: the background and purpose of the

Residential Rent Stabilization Ordinance (RRSO); the RRSO's current rent increase threshold; the Hayward renters; the rent increase stabilization overview; and the RRSO's fair return standard. Ms. Cole-Bloom also presented two options for the Task Force's consideration: 1) maintain the current threshold as a fixed percentage at 5%; 2) implement a new threshold using 100% of the annual change in the CPI, with a ceiling (5%) and floor (2%).
