- 17:34:08 I like to call this meeting to order today, Monday, April 24, 2023, at 5:34 pm.
- 17:34:12 And before I pass it over to my colleague from HARD, I'd like to remind everybody that this meeting is recorded, and I will be posted for later review.
- 17:34:25 And we also have a catching. With that, said is my honor to introduce to you president of the HARD Board, Rick.
- 17:34:39 Thank you, Mayor. Please all join me for the Pledge of the United States.
- 17:35:02 Okay. Thank you. Also, I would like to acknowledge.
- 17:35:07 You know. I know we're at City Hall today, but we are also joined by the HARD Board and Marian Handa.
- 17:35:19 Oh, she is the City Clerk's equivalent over at HARD.
- 17:35:25 So she is probably the hardest working person in the HARD Building.
- 17:35:30 So with that, Madam City Clerk, can you take the role for the city and then meet?
- 17:35:46 City Council Members Andrews, Bonilla Jr., Roche, Syrop, Zermeno and Mayor Salinas were present.
- 17:36:00 HARD Board of Directors Hatcher, Hodges, Rosen, Andrade and Lamnin were present.
- 17:36:18 Thank you. Next, we have public comments. This is reserved for anybody in the public we would like to make public comment on something that is not on the agenda, and before I go, I see, one hand raised online but before we queue up the person online.
- 17:36:38 I'd like to turn to Debra Johnson. And when you look at my phone, please speak close to the microphone.
- 17:36:51 And I think you might want to hit the button, because that way we can see the bigger.
- 17:36:57 What do you think I have been awards since 1984.
- 17:37:03 I sent us the Sync email addressing my issues. But I don't like to elaborate a little bit on the wise.
- 17:37:07 The Hayward plunge has been around since the 19 thirties.
- 17:37:11 Most of us think of it as a place for kids to learn to swim, and they have them on the weekends the year round.
- 17:37:16 Bread and butter of the fungus are local seniors.
- 17:37:19 They come often as they can, and some it's almost daily.

- 17:37:22 Any of these people are not here at this meeting, because they did not know about it.
- 17:37:26 They are not tech. savvy, and there are no notices.
- 17:37:30 Places in the facilities that they utilize. Can we please put notices up in the senior centers?
- 17:37:35 Maybe on the door of the plunge. So the people who are using these facilities can come and voice their I'd like to share a little of their stories an 82 year old woman who has spent spinal surgery since she comes every day to stay mobile so she can enjoy quality
- 17:37:53 of what their grandkids another lady used to be close to 375 pounds, and the doctor told her to wait if she wanted her knees replaced. It's near impossible.
- 17:38:03 If you can't walk to lose weight, she comes every day, and water walks.
- 17:38:07 She has lost enough weight now that she has for me surgery put on the schedule stroke by survivors, come to regain us of their limbs. It's sad to see a senior with the walker, have to walk across the parking lot in the rain because there aren't
- 17:38:21 enough handicap parking spaces. We need to have the entire front of the plunge.
- 17:38:27 Hey? We're plunge is truly the foundation of youth for our seniors, and it needs to be maintained.
- 17:38:32 Several years ago the owners approved funding for Park, and I haven't seen anything done yet for the plan.
- 17:38:38 I see water running down the walls inside when it brings, and it runs around it over electrical outlets that are currently being used.
- 17:38:46 The paint is drastically peeling the earthquake retrofits that were done decades ago have just about rusted through and are no longer structurally sound.
- 17:38:54 That we were to have a large earthquake. We've had 4.
- 17:38:57 Earthquakes on the Calaveras fault, and 3 in San Lee.
- 17:39:02 Andrew Heyward Fall, recently as reminders. We only need to look out back at the punch, see the offset, Stonewall, to know how close we are to the fault line, keeping the plunge safe.
- 17:39:11 It's literally a matter of life and death to our seniors.
- 17:39:13 We need more upstairs bathrooms, these are supposed to be used by the handicap and seniors, but too often they are overcrowded by the able bodies who don't want to go downstairs.
- 17:39:23 Another issue as senior center in Hayward it used to have about 12 handicap parking spaces next to it.
- 17:39:30 When the law changed to make the handicapped spaces level, 2 spaces and change all the others for the senior center.
- 17:39:38 Only we have 25 to 30 people there on Thursday to play, march on, and there are dozens of people there for the daily lunches.

17:39:45 There are nowhere near enough parking spaces for the handicap.

17:39:49 I'd like I have had to park on the far side of the Mars Theater and walk over, which seems like a short distance to the able body.

17:39:56 But on bad days I have to stop and rest in front of the theater, so I can continue to play March on.

17:40:02 Others are not so lucky as me to have the scooter is Miss Johnson. That's it. Yes, okay. If you have a thought you want to close, I'll let you do that.

17:40:12 Just need to take care of her need to take care of our seniors a little bit better, because they are taxing as well.

17:40:20 Thank you. Thank you very much. Our next speaker is Miss Sandy Frost.

17:40:38 First off I wanted to change the HARD Board.

17:40:45 I wanted to thank the mark for extending stay off and crew to us a week's part.

17:40:52 I'm with the header, and we were able to get good size trees on the ground on Saturday, Thursday, and with more coming we really nice agreement with hard to.

17:41:05 Oh! Re force the parts once they have trees and more trees, so ones that have no trees.

17:41:11 So I wanted to see just really what you say about the importance of partnerships.

17:41:17 Both with the city of and with the hard board, because just for the sake of the use and for all the citizens of Hey, we need to conscious about clean air, clean water, our environment.

17:41:31 Just for the future. That's all I want to say.

17:41:36 Thanks for hearing me out. Thank you, Sandy. Thank you for your continued work in the community.

17:41:41 Signing all those trees. Thank you. And we.

17:41:45 Our next speaker is Randy, and I know I've said it before.

17:41:50 I said it correctly before, and I hope I can do it again today.

17:41:53 And said, Woggie, it is lucky actually, thank you.

17:41:55 So I push the button and start going. Okay? Hello!

17:41:59 I just want to say, hello. Obviously, I live more in San Lorenzo, near the Skyways former Skywest Golf Course.

17:42:10 So I continued to advocate that we look at the Skywest Golf Course, and realize that that would make a great park at a great open space.

17:42:19 So whatever we decide to develop there, we really should keep the open space in our minds.

17:42:23 And since we're all here right now, I know lots of times, hey?

17:42:28 Regrets like, Oh, we don't have the money to do it, but I think future generations would like to see that as a part we need expansion of the park, so I just want to say that my other little thing 1080 park looks great I love it for the longest time we

17:42:44 San Lorenzo used to have food trucks, and I've tried to advocate to get food trucks at Kennedy Park.

17:42:51 Like on a Thursday or Wednesday. We've talked about it quite a few times, truck will be more than happy to do that.

17:42:59 So please, if we could get that going. Thank you. I'm really looking forward to a good meeting.

17:43:03 Thank you very much. I'm going to move to online to see.

17:43:12 I go to Mister Bruce King, if you can go ahead.

17:43:18 And yeah, that would be great.

17:43:24 Hi! This is Bruce King, with friends in San Lorenzo Creek.

17:43:28 First I I wanted to say I appreciate the city and hard, and your ongoing openness and communication when it comes to gathering input on parks, trails and developments.

17:43:41 I also request that Hard and the city do more to protect, enhance, and restore creeks that are included in developments, parks and trails.

17:43:51 We always speak about how much we love our creeks but when it comes to enhancement or restoring the creek bed or the top of bank areas, developers the city and hard often ignore these areas are don't make the needed.

17:44:07 Creek. Habitat. Enhancements. Everyone tries to steer clear of any work in the creek areas.

17:44:14 For example, in the so hey development, we had a creek running right through the middle of the development.

17:44:20 It's in our earthen channel. We built a development all around the creek.

17:44:24 We put the trail along the creek, the foothill trail.

17:44:28 We built a park around the creek but we didn't do anything to enhance the creek at the Carlos B.

17:44:35 Quarry site, that development. We had major sections of the foothill trail.

17:44:41 There, and it took polling teeth to get the developer to put any proposed enhancements in terms of trees and habitat between the trail and the top of bank in areas that were decimated by the quarry.

17:45:00 Okay, and I didn't see a whole lot of input from the city in terms of of making that happen.

17:45:09 That the Bunker Hill Development we've got major segments of the Foothill trail.

17:45:14 There, I propose that we put the foothill trail through one small section of the creek area that would have been beautiful, and instead we got the trail following roadways and the city and the developer ignored the

17:45:34 creek areas which, some of which were decimated over time by past human activities and developments.

17:45:45 At the D and Clay Street. Hey? We're hard, is just getting going on that project hard seems to be in tune with the fact that we got Sulfur Creek and one of its the software for Sulfur Creek running right through the park area there.

17:45:59 We've got fish. We've got California road swimming in the screen. There.

17:46:05 And hopefully, I think hard might be in tune with the fact that we need to do some Creek restoration and get rid of the invasive.

17:46:12 So developer's city and hard, tend to avoid work in.

17:46:17 And near our creeks, but the creeks have been degraded by humans and need our help and resources.

17:46:23 When we are developing parks, trails, and projects.

17:46:28 Thanks, everybody.

17:46:30 Thank you, Mr. King. Next. I'll go to the next person online.

17:46:36 I believe it's Rebecca.

17:46:46 Oh, it's no problem. It's accurate.

17:46:44 I apologize. Accurate. Okay.

17:46:48 Nobody can say it. Thank you for the opportunity.

17:46:53 Speak. I just wanted to quickly mention. I am the mother of a child who is not wheelchair bound, but still has some mobility issues, so I would like to help advocate for our parks to become more and more accessible and inclusive for all children's needs I know that we have Mia's Park.

17:47:13 and Mia's, and I also know that Mia's was a very big project of its own, but I would like to advocate that as much as possible, and I know there's things like Budget and all other kinds of elements that go into this if there is at least just one area where children who

17:47:28 have different mobility. Capacities can access the parks, as we continue to grow and implement new play areas at any future parks.

17:47:38 If we can keep that in mind as we move forward, I would appreciate it, and I know the children would appreciate it too.

17:47:43 So thank you very much.

17:47:44 Thank you very much. I appreciate that. I know HARD is taking notes, so I know Mr.

17:47:52 Wheeler is certainly listening to next, I'd like to call on Jim.

17:48:01 Is it? Denda? Jim is here. There you go, sir.

17:48:09 Yeah. Yeah, I'm just here a real quick. I've been trying to get some speed bumps over at me as Park and you guys worry about kids and guns or something like that.

17:48:20 The clouds travel so fast and there I volunteer there every day, and I watch the car through Bike.

17:48:26 I've been trying to get 2 speed bones.

17:48:29 And I wish somebody do some of but I've been trying to get a hold of.

17:48:32 It. I've come to the city engineers and stuff like that, and they tell me they can't put it.

17:48:37 I don't know why I mean, you know, we're talking about kids here.

17:48:42 So if you guys do that for me, please, because they drive, they try to take your shortcut.

17:48:49 The traffic is back to what would, and they go real fast.

17:48:52 So I don't want to say no kids yet hurt.

17:48:55 So? So 2 speed books I saw. I asked for 2 of that 5.

17:49:04 Well, and I just wanted to clarify before you give our public works.

17:49:09 Director, a heart attack. They're called Speedbox dot books, whatever they are.

17:49:18 We'll put 2. Yeah, 5 years to put the part in.

17:49:24 And okay't get nothing done and keep telling me they're gonna help me.

17:49:27 But nothing. So I've seen this deal. So I'm gonna be here. So I appreciate it.

17:49:31 Thank you. Thank you. Appreciate it. And Jim is not a part.

17:49:35 He's there every day I help out for that. Thanks, Jim for work, and of course no public comment between Hard and the city would be complete if we did not have a public comment from Lita.

17:49:48 Really?

17:49:57 It's very important that we maintain cards for people, young people, older people, boys and girls, men and ladies, people of all ages, all races, all nationalities all religions can join each other apart.

17:50:11 The important thing is parks are free, and that way people, all economic levels.

17:50:14 My parents took me as a little child, and we took our children and now I'm involved with the Hayward van, and, thank goodness, memorial Park is staying open.

17:50:23 I hope people continue to stay up and have concerts here.

17:50:25 The people enjoy it, and they don't pay, and then they come in.

17:50:30 The adults get a picnic. They can basically so little children can run and play if we need to maintain these open areas for people.

17:50:38 Thank you for letting me be here at that's how the Hayward band have concerts this summer, Sony nonprofit.

17:50:45 See, we've already been hired for Memorial Day and Long Tree Cemetery.

17:50:48 I'm very pleased about that. I hope I get to see all of you on father's day in the Park, and David Royal Park.

17:50:53 Thank you. Okay, thank you. Okay, so I'm.

17:51:04 I just have to declare, okay, so our next public commenter is, Angela.

17:51:13 By!

17:51:26 Angela, can you hear me?

17:51:27 Hi! I'm sorry I figured it out finally. Thank you.

17:51:34 So, yeah, my name is Angela Yorga, and I live on Spring, near Spring Grove Park, and I have 4 children and 4 grandchildren, and we go and use the park from time to time.

17:51:49 The park is in bad shape, you know.

17:51:53 I have to say that Parking wreck has done a wonderful job keeping it up as much as they have.

17:52:00 They even have a garbage, can right out outside of the park, which is really good for, like, you know, people throwing garbage and stuff.

17:52:09 So you know that so many good things that they've done they've kept up the trimming of, you know.

17:52:16 Weeds, and you know, just kept it up as much as they possibly can.

17:52:22 But it's time. It's time for that little park to have an upgrade.

17:52:27 It's used by a lot of kids. The problem is, though, is the basketball court has lots of cracks in it.

17:52:35 It's pretty. It's pretty dangerous if you're playing, you're probably gonna trip.

17:52:40 I've tripped a couple of times also, right now there's a pretty bad water leak, and it just it's been leaking for weeks.

17:52:47 Every time I go there the waters running, you know.

17:52:52 I'm not sure where it's coming from. Maybe it's coming from another house, but it's difficult, because there's algae growing, and this is the path that the kids would use to use the park and it's kind of in bad shape.

17:53:03 So I'm asking if somebody could take a look at a Spring Grove park and see if we could fit in the budget to give it a little upgrade.

- 17:53:13 I know a lot of kids, you know, in the area have gone there.
- 17:53:17 You know, there's times where they meet up. They get to know each other, but it's not.
- 17:53:21 It's not that nice of a partner. So you see them meet, and then, you know, another day comes, and nobody's hanging out there again, and this is a park.
- 17:53:31 I think if we got the upgrade it would get people in the community to go access it more.
- 17:53:38 And that's it for me.
- 17:53:41 Thank you very much, and that's how. And of course, thank you for always.
- 17:53:44 It's always good to get bad news, but it's always good to get good news, you know.
- 17:53:52 So, so thank you. So I don't see any more public.
- 17:53:57 Oh, we have!
- 17:54:01 No, I think that's it. There are no public comments.
- 17:54:07 So I like to close public comments and then move on to our work.
- 17:54:09 Session and the work section today is titled, shared visioning and program updates.
- 17:54:17 A joint work session with the Hayward area.
- 17:54:21 Parker. Recreation this Board and the Heyward's

Council, and to kick this item off.

17:54:27 There's only one item on the attendance day, and to kick this off will be what's the hard general manager?

17:54:37 James Wheeler, so you there and good to see everyone here this evening.

17:54:44 I am gonna relatively quickly turn it over to our facilitator team.

17:54:51 We're gonna lead us through the agenda that I just want that call.

17:54:53 Attention to the working agenda. That's the package, which is what we're forward through over the next hour and a half more.

17:55:03 So there's some extended version stuff. And so you know, I think for Jim and I, renegotiating the mass agreement between Hard City for a number of years, and I think, as part of that thought, it would be a good idea for us to get our elected together on a regular basis

17:55:22 I was, how many in my 12 years of the city, and then between the Council and the board somewhere in that so trying to get a sense from all of you?

17:55:33 About? How you all want to work together that's really kind of help.

17:55:41 Facilitate that's some dialogue and some discussion between the 2 agencies.

17:55:46 Who, you know, work in partnership to provide parks, recreation services to the neighborhood as our rescue. So with that, I'm going to.

17:55:58 There we go. Okay, it's a great opportunity to have everybody together.

17:56:07 And something we've been looking forward to for quite some time to think of, as everyone's probably where I took over it was pretty.

17:56:15 It was pretty tough to get pushed up and down, and it was just a challenge, so we've been slowly trying to fight back that my personal role being to have these 2 bodies in her eyes on a much more frequent basis to be able to discuss our common issues.

17:56:35 You are. See, a Hayward is our archives for lack of a better term, 104,000 home is about 144 miles.

17:56:47 About 54% of that actually manage almost 60% of the parts are in.

17:56:52 So we're still some numbers with you. We look forward to answering questions.

17:56:57 We appreciate all the public comment like to remind people. We put on one of our slides.

17:57:01 Our board needs the first and third Monday of every month at our district office.

17:57:05 There's always public comment and these in the future don't save your comments for a joint meeting, for free to come by any time, but by any time, and let us know what you're concerned about what you think we could do better or we're very happy to and then further

17:57:24 ado. I'd like to introduce Judy Brown this this here with us today.

- 17:57:28 She is Covounder and managing partner, civic makers which are counsel and former customer familiar with.
- 17:57:41 They've helped us in the past, facilitate and sell our strategic roadmap to see. But they also have a facilitation team building on their so we're very excited to have her at the firm focus on strategic planning and human center design public sector she'll be
- 17:57:51 facilitating tonight, and the poly Christine back here will be helping and taking notes from today's session and that's preparing our fall of action.
- 17:58:00 So with that I will turn it over to Juneie.
- 17:58:03 Alright. Thank you so much. Thanks so much for having us here.
- 17:58:06 It's really clear hearing the public comments have integrated.
- 17:58:11 These issues are I know that there's some new Council members, and I know that like you all said, it's been a while since you've all been in a room together.
- 17:58:26 So I did want to do some introductions, if I may.
- 17:58:28 Just around the table. Really, just kind of looking at your name, and affiliation, which I can see.
- 17:58:35 Maybe also how many years you've been in your role or stays for weeks, and also like to hear your favorite part for reference.
- 17:58:55 Your favorite parts, or recreational. Can I start with you? Council? Member? Okay.
- 17:59:11 And after we do our introductions, I'm gonna pass it over to you.
- 17:59:13 The staff that's gonna give a little bit of it's just one announcement.
- 17:59:21 So here that the ceiling will pick up your talking if you are allowed soccer.
- 17:59:25 If you know yourself to be a by talker, we ask that you speak into this.
- 17:59:29 You can. I can hear myself seeing explanation. Oh, thanks!
- 17:59:37 Yeah, that's that test. So my name is my favorite park is Spring Road Park.
- 17:59:53 On a big, special place in my heart, and but the whole city in my mind is a recruiter center, as far as that's why you want right that's what we can.
- 18:00:10 Everyone, George, Sarah, I've selected in November this morning in December.
- 18:00:17 I think the topic for me sampled Mark up on a street or college heights upon Parkbo.
- 18:00:24 That's that's hard to choose.
- 18:00:29 Alright Peter Rosen Harris! This is my third year, serving on the board.
- 18:00:38 And it's funny, I think, about that. Which part is my favorite every time we have we roll out a new park.
- 18:00:45 This new element is my newest favorite. Currently, I think I think probably Kennedy Park.

- 18:00:52 There's so much to do there with someone that it's being activated so well, there's so many fun smiles.
- 18:00:59 I'm Julie Roche. I'm like to.
- 18:01:06 Same time this comes for sign up in December, so as well, I as well as far as frequency, I think the one I use the most. Most of my kids was the park in the Twin Bridge, the same, are good. I mean if that's what it's called but my kids come up.
- 18:01:18 With our train work. And then a new favorite. Actually, it's not New York, but it's big. Thank you.
- 18:01:32 Hi, Sarah Lambton! And was on city council for the last 8 years.
- 18:01:38 And then when these guys switched also, I switched and now on a hardboard and the yeah, I have a problem.
- 18:01:48 Thinking, my favorite, but what I think about when I think about the question is kind of, where are the memories?
- 18:01:53 In my most recent actually was my nieces visiting and doing.
- 18:01:56 Zipline, and so I'll go with that.
- 18:02:01 Have to try that or we can push the boundary, bring it to San Diego City Council.
- 18:02:14 I am no longer like to keep on board in January.
- 18:02:20 By heart, still settings one of the things I love about humor is the parts it's hard to pick a favorite, but I gotta say, Kennedy rises to the top.
- 18:02:35 You know I've got great memories. Bring my kids there, you know.
- 18:02:37 They just, you know, full of bullet piles on your face.
- 18:02:41 I love it. Okay. My regular park, the one that I go to the most cause.
- 18:02:46 I live so close to it is park the hike in there, and dog up there.
- 18:03:14 You know, actually, when I think of all of the parts. And so I didn't mean to cause any large twin branch sparks.
- 18:03:20 They lived there for a while. It's love to tray.
- 18:03:26 We won't go there now, that's true.
- 18:03:30 The me is strange. You know what I think about the Hayward community.
- 18:03:34 One of the first thing that comes to mind from me is via stream, playground.
- 18:03:38 It's really does represent you know, the height of consideration of diversity and inclusion.
- 18:03:45 And anyway, it's I could go on.
- 18:03:49 You guys too fetch up sparks, and I just love havery.

18:03:53 Oh, you don't need that stuff. So my name is Marcellus, and I have the honor and the privilege of serving the city as the mayor, and you know my favorite part of first of all, you know card has a very long history of my family you know many of you

18:04:12 have known my sister. My sister worked for HARD for many years, and when she passed away, she was a heart employee, and she always considered hard or hope.

18:04:23 And so I always appreciate that about hard, and you know my favorite.

18:04:32 My favorite part is the raw, rich part, primarily because of the historical legacy that Raul Ranch has, and a lot of folks don't know.

18:04:45 But the very first rodeo in this area was at Burbank Elementary School.

18:04:52 The rodeo parade would go down B Street and end up at the school, and that's where the people would.

18:05:00 You know the ranchers in the account voice with, you know, walk their cows and horses and around in the circle, and show them to so and put a plug in for the radio, it is next month, you know, on a third of third weekend that's right but

18:05:21 anyways yeah. And plus, they just have a lot of memories growing up.

18:05:24 And always alright. Yes, I'm recapture.

18:05:31 I am the current director president with hard, and you know I'm just kid moving now, or front of this nature. Our district.

18:05:39 And I think that was a great example, because we don't have our constituents don't have lines.

18:05:46 They go from park to park, they don't need to reach out to city like county. I grew up in San Lorenzo, so Kennedy and I taught town, which I call these are just powerful pieces of our community, and one of your city studies.

18:06:01 Shows that the loveness of parks is up there with firefighters never get to knock off the fire planning for a little bit of any community.

18:06:10 But it's the unique way to get the diversity of our parts.

18:06:13 Really, it's the tool of this community that's just hearing the public comment.

18:06:18 It's like, we demand this we love hard. We get that all the time.

18:06:21 We need to approve. We need to be creative. But the ability, the love of our parts is something that sorry. I just.

18:06:28 I'd love to hear. But you know, personally, I sent so many people to Japanese gardens over the years young people don't hear.

18:06:36 Take your date over here, check technics this out.

18:06:41 I see people ponder, have the appliance looks on their face, to the Japanese gardens.

- 18:06:48 And so it was a really magical place that our community has so I've been on the board for 9 years, and really appreciate. It's fine.
- 18:06:55 So hi sweetie! Alright, all hatches! I've been on Board for 17 years.
- 18:07:03 My mom's favorite, apart with Kennedy or not.
- 18:07:09 Kennedy. Yeah, not she. And Mrs. Boolard would take 12 kids over there.
- 18:07:17 Dumpl them off, and they would sit there picnic table right?
- 18:07:26 So anyway, they would. Microsoft. We drove the hills for about 3 or 4 h and that's what save my mom's other sound.
- 18:07:37 But my favorite part just one side. Frank and I grew up in frank Google Weeks.
- 18:07:46 Park with the mountain that we first started playing there. Actually, I was a I wish they'd left them.
- 18:07:53 Now I'm a journalist, there's a lot of funny, too, but that's my story.
- 18:08:02 Now. Hello, everyone! My name is Ray Bonilla Jr., and newly pointed to any city council. It will be on Tuesday, so.
- 18:08:20 But not new to certain. Hey, we're, in fact, I can start making you word since about 2,003.
- 18:08:27 So it's been serving the city for almost 20 years.
- 18:08:29 I can't call my entire life my admiration for the city and its partnership with Hard really began when I was on the Radio Commission.

- 18:17:48 Just get some people, some contacts over the work we do, and add up everything that we got going on next slide.
- 18:17:55 Please. Okay. This is the small side of the Hillary district.
- 18:18:02 Is an independent district of the State of California established in 1940.
- 18:18:05 -four, and manages and operates parks and recreation facilities, both in Hayward and our unincorporated communities.
- 18:18:13 San Lorenzo, absolutely Castro Valley. The district provides recreation services to about over 300 300 residents. The 1,000 residents.
- 18:18:26 That's a lot more than 300 and about a hundred, about 50% will more.
- 18:18:34 4% reside within Richard City limits.
- 18:18:45 Starting straight out.
- 18:18:59 The board directors meets on the first and third Monday for the district offices.
- 18:19:07 So we want to hear.
- 18:19:15 I want to go a little bit in terms of our assets and investments.
- 18:19:19 Of measure, F one. So currently the district matches over 1,700 acres of parts within our district, which, as I said, it comes with multiple unincorporated communities.
- 18:19:33 They are about 63 parts within, and 1,669 of those acres are within the city limits of Hayward over 50%.
- 18:19:46 On that 1,069, roughly 871 acres are owned by the city or by the district 198 are owned by this at the city, and then all of those their 9 parts are kind of got a joint agreement where we share space for one
- 18:20:06 larger, part. In 2016 the district pass special F. One for district, wide parks and facility improvements, and they set aside 127 million of those for park improvements renovations, and acquisitions of new park space within the city viewer accounting for 51
- 18:20:28 percent of the total measure average the Max here illustrates no worries.

- 18:20:36 The map illustrates that these measure f. One.
- 18:20:39 Improvements have been spread out throughout the city, and next slide, just a little information on our Rangers.
- 18:20:50 Our rangers have conducted over 6,400 interactions with the public.
- 18:20:57 About 3,742 of those have occurred within the and then Parks and Heywood, and 10% of those.
- 18:21:09 So they're about 300, over 300.
- 18:21:14 Interactions regarding unhouse or trespassing about 10% of those you know occur about 10% of all interaction.
- 18:21:26 Messaging. Heyward, we're recording on house regulation or trespassing on properties.
- 18:21:32 And then let's go on. And 73% of all venture interaction contacts are makes mainly because of the call queues.
- 18:21:43 Once the park is closed that's coming by saying No to participate facility, and then locking up the space.
- 18:21:54 Recreational program participation. So these numbers are specifically for paying customers of our right programs from Fall 2021, through summer, 2022, the district provided classes to over 48,000 residents.
- 18:22:10 They offered over 45,000 h of programming with Vancouver, and then our 45,000 h of programming and 28,000 of programming were offered in Hawaii within the city limits I just say there were 20,000 h.
- 18:22:29 Of community use, hours of fields for games, offering, and participants on average have both point 2 miles for the classes.
- 18:22:39 So that's not 35 according to their local passes.
- 18:22:41 Awesome and scholarships the district provided 2,000 scholarships for fee reduction.
- 18:22:48 In addition to free Agn. Permitting that we have done over this period. This map here illustrates where folks are coming from to attend our classes.
- 18:23:05 Excellent. I'm not gonna read this first slide it's a Tuesday with a lot, but we do a lot of a lot of work, and we're moving forward and thinking really futures so there's a bedroom past is at being in nature education.
- 18:23:20 Our Department has established park, maintenance standards through all parts, and they looked into water.
- 18:23:28 And you know we're going through. Was it still cut back?
- 18:23:33 But making sure that we really think about how we irrigate our parks and make sure that they say green and excellent. Thank you all.

- 18:23:44 I'm still trying to for those who aren't familiar with the Council's strategic priorities.
- 18:23:55 Yeah, you know, I think in our partnership the focus is falls really under enhanced Kdc on this one is the Council's priority.
- 18:24:09 See if a number of, I think actually, parks and okay and Thomas presented sort of which parks paper don't.
- 18:24:22 And I say, this is interesting, or I mean, which parts part of this is an interesting little map that just shows that there are a number of other entities that also have parks within the city other than our.
- 18:24:36 So have, you know green is the hardest parts. Purple ones are the ones that the city owns.
- 18:24:43 But then those are faster. At least 2 hard for operation. Excuse me.
- 18:24:50 And then he would unified school district owns a couple of small parts, you see in red, and then Pgd.
- 18:24:57 Of large screen way that runs through the middle of town, and then we have slender park properties and that'll be the county properties in there as well.
- 18:25:03 So that we have actually experiments focus on there, which is interesting.
- 18:25:08 So that's the one that we best so we're gonna do a few acres up in the hills.
- 18:25:22 But okay. Next I know. There was some question or the context of this work session of how new development interacts with hard, how do we get parts of this work session of how new development interacts with hard, how do we get parts developed when new felt and so we wanted to just share
- 18:25:37 that there is a place on the city's website.
- 18:25:41 Development, Explorer, Webpage. If you put that in the search bar on the front page, you can see this includes most of our major television projects that are over 50 units, and that in the city I believe we didn't change this in our last part, I see update our residential properties
- 18:26:01 pay partner with these to support the acquisition of New Parkland in the city, and so there's a lot of and our plans are rounded to step.
- 18:26:19 Numbers, add bar for review, with comments. When this projects come in, we try to.
- 18:26:26 We try to be working collaboration in terms of what just hard you want? Do we just want fees?
- 18:26:28 Do we need land? What are we trying to publish? Each of these development projects?
- 18:26:33 So next slide that this is another different view of the development dashboard.
- 18:26:38 So you can click on there and figure out what's going on it's also very helpful if you're driving around town.
- 18:26:44 And you're like, Hey, I wonder what's going on in that course on site and figure it.

- 18:26:48 Look at the math also, just one of the other challenges that I think we all face is the city is tasked with creating a plan that shows how we can build enough housing to accommodate the need for it called our regional housing needs.
- 18:27:07 Allocation. It's created every 5 to 8 years, and then there's an allocation for the entire 9 Bay Area counties that's created each city is given a certain number of housing.
- 18:27:21 Give it, to develop as part of that. And so here, from 2015 to 2013, we have allocation, of 3,900 new housing units to build all of those substantial number of those housing units during that timeframe and then from 2024 to 2031
- 18:27:39 we're supposed to build an additional 4,600 on top of that 3,900.
- 18:27:44 That's not. You know that added, if it's you know, cumulative.
- 18:27:49 And so I just it, that creates a lot of impact because that's built those houses that are more desk. People are paid for park benefits, opportunities.
- 18:27:57 So just wanted to share that and that's one of the pressures that comes as we try to meet the regions housing priceless.
- 18:28:07 And that's it. So very brief context setting for hopefully some other discussion that'll happen today.
