FY 2026-2029 Consolidated Plan

- Framework for identifying housing and community development needs and priorities through community engagement
- Guides the City's federal CDBG entitlement investment decisions for FY26 though FY29
- Priority needs:
 - Expand & Improve Public Infrastructure & Facilities
 - Preserve, Protect, and Produce Housing Stock
 - Public Services & Quality of Life Improvements
 - Economic Development

Economic Development and Infrastructure (CDBG)

- 4 full funding
- 3 partial funded
- 1 not recommended funding



Public Services (CDBG)

- 1 full funding
- 5 partial funding
- 1 not recommended funding



Social Services (General Fund)

- 2 full funding
- 19 partial funding
- 13 not recommended funding



Arts & Music (General Fund)

- 3 full funding
- 7 partial funding
- 1 not recommended funding

Identified Challenges









50% of applicants dedicate over 16 hours to the funding process

Weekend interviews are not preferred

Review processes lack consistency and transparency

Unclear priorities in decision-making

Staff recommended changes to CAF

Two main goals: 1) Reduce agency burden and 2) increase transparency and objectivity

- Transition to two-year funding cycle
- Establish a separate Arts & Music funding process
- Align decision-making with City Council priorities and community need
- Increase decision-making transparency and objectivity through rubric use and publication of scores

Water Rate Overview


- Pay for purchase and distribution of water







Fee Compliance



- ► All fees have been reviewed to ensure compliance with:
 - Prop 26 November 2010
 - Assures that taxes are not disguised as fees: taxes must be approved by voters whereas legislative bodies, such as a City Council, can approve fees.
 - ▶ Prop 218 November 1996
 - ▶ Requires voter approval prior to imposition or increase of general taxes, assessments, and certain user fees.
 - **CEQA**

Agreement with Syserco Energy Solutions



BACKGROUND

- Funding opportunity through PG&E pays for 95% of project costs for comprehensive energy conservation measures such as HVAC, lighting/controls, EMS
- "Self-Funding" = Savings pay for all aspects of the project- minimal capital required
- City engaged Syserco Energy Solutions Investment grade audit and assist with final project development
- PG&E has approved the (13) facility project for funding



FUNDING OVERVIEW: PG&E's

"ON-BILL FINANCING" (OBF)





- ✓ Approved funding amount for project = \$2,087,504
- ✓ Funds 95% of project costs for City's energy efficiency project
- ✓ 0% interest, no fees, and the loan balance appears on PG&E bill
- ✓ All aspects of project paid for with the realized energy savings
- ✓ Funds comprehensive projects that have 10-Year simple payback or less




Project Background and Funding Sources

- City's Water Resource Recovery Facility ("WRRF") Administration & Lab Building Project & WRRF Phase II Projects: \$498M cost
 - Including all capital costs, contingencies, and financing costs
- WIFIA Loan funding for 49% of project costs
 - \$244,139,000 maximum loan size (excluding capitalized interest)
 - First draws currently expected to occur in Fall 2026
- City is also funding 26% of costs through 2025 Bonds (approved by Council in February) and ~17% of costs through a future 2027 Bond issuance




2025 Wastewater Bonds – Update


- City Council approved sale of up to \$135,000,000 in 2025 Wastewater Revenue Bonds ("2025 Bonds")
 - Original estimate True interest cost 4.25-4.50% Bond principal \$125,000,000
- Bonds competitively sold on March 11, 2025
 - ▶ 11 bidders; lowest bid <u>true interest cost of **3.96%**</u> (Mesirow Financial)
- ▶ Annual debt service will be ~\$735,000 *lower* than estimated on 2/25/25



WIFIA Loan within Context of the Larger Project Timeline



WIFIA Loan Structure & Repayment



- Standard sewer revenue pledge, on parity with existing 2006 SRF loan and 2025 Bonds
- 2063 final maturity, fixed interest rate, optional prepayment any time after project completion
- Structured to "wrap around" other debt service to target level aggregate debt service
 - Less principal paid in early years – higher principal payments (FY 2055/56 – 2062/63

WIFIA Loan Considerations and Benefits

Interest Rate	 Current (March 2025) 35-year rate ~4.60% Rate is not a function of the credit rating
Interest Rate Reset	•One-time option to reduce the interest rate prior to first loan draw or once the Project exceeds 51% complete
Draw Schedule Loan	•Interest only accrues on the actual amounts drawn
Deferred Start of Repayments	 Not required to make WIFIA payments during Project construction and can defer payments up to 5 years after completion Accrued interest over that period is added to the loan principal; amortized over loan term
Long Term	 Up to 40-years available: must be paid off within 35 years of project completion, after accounting for 5-year construction window
Flexible Structuring	 Loan can be structured in a variety of ways, including back-loading as necessary to wrap around scheduled payments on other debt
Re-Amortization	•City will have the option to re-structure the WIFIA loan after closing should changes in the financing plan occur
Early Prepayment	 City can prepay the WIFIA loan at any time after project completion, with no penalty

Recommendation

▶ That City Council adopts a resolution authorizing the execution and delivery of a WIFIA Loan Agreement in the maximum principal amount of \$244,139,000 to finance capital improvements to the Wastewater System, including the Water Resources Recovery Facility improvements, and approving related agreements and actions
