7. <u>Adopt the Revised Classification Plan and Review and Recommend to Council Adoption of the Revised Salary Plan for Fiscal Year 2025</u>

Human Resources Analyst Valeria Cazares presented this item and answered related questions with assistance from Human Resources Director Brittney Frye. Valeria introduced the revised Salary Plans for FY25, effective July 1, 2024, July 29, 2024, and September 23, 2024. The FY 2025 Salary Plan has been updated to reflect salary adjustments to the classifications in the City's classified service as a result of the four (4) negotiated and mutually agreed upon Memorandums of Understanding between the City of Hayward and 1) the International Federation of Professional and Technical Engineers, Local 21; 2) the Hayward Association of Management Employees; 3) Service Employees International Union, Local 21 – Maintenance; and 4) Service Employees International Union, Local 21 – Clerical. The Salary Plan has also been updated to reflect salary adjustments to Unrepresented (Non-Executive) classifications as well as the addition of one (1) new classification and salary adjustments to nine (9) additional classifications.

(M/S/P) Thompson/Woo – Recommend to Council the Adoption of the Revised Salary Plans – Approved, 4 AYES.
