The Meeting of Special Joint City Council/Hayward Redevelopment Successor Agency/Hayward Housing Authority was called to order by Mayor/Chair Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Council/HRSA/HHA Member Mendall.

CLOSED SESSION ANNOUNCEMENT

City Attorney Lawson announced the City Council convened in closed session at 4:30 p.m., to discuss three items: (1) conference with property negotiators pursuant to Government Code 54956.8 regarding State owned parcels along the Route 238 bypass alignment; (2) conference with legal counsel pursuant to Government Code 54956.9 regarding anticipated litigation; and (3) public employment pursuant to Government Code 54957 regarding the City Manager's annual performance evaluation. City Attorney Lawson noted there was no reportable action related to Items 1 and 2, and Mayor Halliday added that there was no reportable action related to Item 3.

PRESENTATIONS

Mayor Halliday read a Certificate of Recognition and presented a certificate to six Mt. Eden High School students in honor of student participant achievements in the 2018 National Honor Band and National Honor Orchestra of America. Mr. Kevin Cato, Instrumental Music Director of Mt. Eden High School, also accepted the recognition.

Management Analyst Thomas spoke about the collaboration between the City and the Chabot College Student Initiative Center around outreach for the City's Tennyson Corridor Vision Plan. Ms. Thomas noted that the Community Art Exhibit was the culmination of interviews with South Hayward community members and 50 community-based organizations.

PUBLIC COMMENTS

Ms. Jeannette Johnigan, Hayward resident, spoke about rent increases and provided related documents; noted the ramp in the Council Chambers was not wheelchair accessible; and asked that the City consider mobile device accessibility on sidewalks when considering street improvements.

Mr. Kim Huggett, Hayward Chamber of Commerce President, announced the upcoming 2018 Downtown Hayward Street Parties celebration in downtown on June 21, July 19, and August 16, 2018.

Mr. R J Johnson, Hayward resident, expressed concern about building housing on the earthquake fault; and spoke about the lack of affordable rental and ownership housing in Hayward.

Mr. Jim Drake, Hayward resident, spoke about the need for more police officers in Hayward.

Ms. Alicia Lawrence, Hayward resident and The Hayward Community Collective member, spoke about the Collective's proposed tenant protections; and submitted a letter in solidarity with Parcel 5 Route 238 tenants.

Ms. Brenda Gomez, Chabot College representative, spoke favorably of the partnership between the City and Chabot College for the Needles in the HayStack project, and invited all to visit the Art Exhibit.

Ms. Norma De Leon, Hayward resident, reported there was an increase in the cost of rent and water service at his apartment complex.

Ms. Lisa Baskett, Hayward resident, spoke about the lack of affordable housing in Hayward; and added that there were not enough schools to compensate for individuals moving to Hayward.

Consent Items 4 and 7 were removed for separate vote. Item 3 was removed from the Consent Calendar and moved to a date uncertain.

Staff report submitted by Management Analyst Stefanski and Patrick O’Keeffe with Management Partners, dated May 22, 2018, was filed.

City Manager McAdoo provided a synopsis of the staff report.

Discussion ensued among Council Members and City staff regarding the contract with Overland Pacific & Cutler (OPC); the confidentiality of the interviews and the flexibility scheduling the interview appointments; and reverting the properties back to Caltrans.

Council Member Márquez requested that there be flexibility with the interview appointments with OPC and that there be a mechanism for notifying current tenants about future housing opportunities and updating the contact for tenants with additional contact information.

Mayor Halliday opened the public comments section at 7:59 p.m.

Ms. Tracy Asturias, Bunker Hill resident, requested that Route 238 tenants be allowed to stay as long as possible before the properties are sold to allow them to seek legal advice.

Mr. Richard Asturias, Pleasanton resident, thanked the City for the proposed Tenant Transfer Assistance Program (TTAP) and requested that the timeline be reviewed; requested more information about the relocation to other properties owned by Caltrans;

asked the City to reconsider the rent-free assistance; and for the tenants to be allowed to leave furniture and other items.

Ms. Samantha Minor submitted a card but did not speak.

Mr. Kirk De Young, Hayward resident, asked that the City reconsider suspending the rent cost for a period for those committing to move out.

Mr. Richard Reynaga, Hayward resident, asked that the item be delayed because Caltrans tenants were not notified; and alternatively, to vote against staff's recommendation.

Ms. Debbie Frederick, Hayward resident, advocated for the tenants and the suspension of rent during the move-out period.

Mayor Halliday closed the public comments section at 8:15 p.m.

Mayor Halliday offered a motion per staff's recommendation including the financial assistance as outlined in the report. Mayor Halliday noted that the City would be able to provide either the financial assistance to move out or the rent-free assistance; and noted that the financial assistance would be more beneficial to the tenants and more feasible to the City.

Council Member Salinas seconded the motion.

City Manager McAdoo noted that staff would be amenable to provide dumpsters for tenants who needed to leave furniture and other items.

Members of the Council acknowledged the needs expressed by the tenants and thanked staff for the reasonable accommodations.

Staff report submitted by Interim Development Services Director Bristow, dated May 22, 2018, was filed.

Principal Planner Lochirco announced the report and introduced Associate Planner Lee who provided a synopsis of the staff report.

Discussion ensued among Council Members and City staff regarding Covenants, Conditions and Restrictions (CC&Rs), units of affordable housing, and barriers such as trees along Lots 7-9 to preserve the views of the properties adjacent to the proposed project.

Mayor Halliday opened the public hearing at 8:47 p.m.

Mr. John Dutra, Dutra Enterprises representative, addressed questions regarding the status of the Gading I project and affordable housing units and in-lieu fees.

Mr. Bob Schmitz, Hayward resident, expressed the height of the proposal, particularly Lots 7, 8, and 9, would negatively impact his property and the two adjacent homes.

Mr. Zachariah Oquenda, Hayward resident, expressed the proposal was a lost opportunity to incorporate additional affordable and multifamily housing; and suggested having a conversation with developers about the needs for the community.

Mayor Halliday closed the public hearing at 9:01 p.m.

Council Member Mendall offered a motion per staff’s recommendation and Council Member Peixoto seconded the motion.

Members of the Council expressed the need to build more affordable housing, affordable by design, and variety of housing; be clear in communicating with the developers early in the process about the needs for the community; sympathized with the neighbors about the impact of the project on adjacent properties; and concurred that the project would improve the look of South Hayward.

Mayor Halliday recommended a work session be scheduled to discuss housing, what has been built, what needs to be built, how to accomplish adding housing while protecting the character of the neighborhoods and self-guarding current residents, and what can developers/builders offer to minimize impacts.
