Thence along a curve to the right having a radius of 29.00', with a radial line through said point bearing North 47°56'09' West, a distance of 18.51 feet through a central angle of 36°33'59" to the POINT OF BEGINNING,

Thence along a curve to the left having a radius of 286.00', with a radial line through said point bearing South 51°18'45" East, a distance of 39.97 feet through a central angle of 8°00'28" to a point of reverse curve to the right having a radius of 23.00 feet;

Thence 24.44 feet along said curve through a central angle of 60°52'57" to a point of a compound curve to the right having a radius of 40.00 feet;

Thence 19.60 feet along said curve through a central angle 28°04'19";

Thence South 59°54'23" East 7.90 feet to a point on the northeastern right of way line Whitesell Street as shown on said Tract Map 3213;

Thence along said right of way line South 47°56′09" East 209.40 feet to a tangent curve to the right with a radius of 430.00 feet;

Thence 182.68 feet along said curve through a central angle of 24°20'27";

Thence South 23°35'42" 45.00 feet East to a point of a tangent curve to the left having a radius of 20.00 feet;

Thence 1.29 feet along said curve through a central angle of 3°42'07" to a point of a non-tangent curve to the right having a radius of 210.00 feet, with a radial line through said point bearing South 50°20'18" East and leaving the said northeasterly Right of Way line of Whitsell Street as shown on said Tract Map 3213;

Thence 68.94 feet through said curve through a central angle of 18°48'35" to a point of a non-tangent curve to the left having a radius of 20.00 feet, with a radial line bearing South 70°10'58"

East, said point also being on the southwesterly Right of Way line of Whitesell Street as shown on said Tract Map 3213 this line also being the northeasterly line of Parcel 4 of said Parcel Map 4610;

Thence 15.15 feet along said curve through a central angle of 43°24'44";

Thence along said Right of Way line North 23°35'42" West 53.00 feet to a curve to the left having a radius of 370.00 feet;

Thence 157.19 feet along said curve through a central angle of 24°20'27";

Thence North 47°56'09" 213.94 feet to a curve to the left having a radius of 29.00 feet;

Thence 27.05 feet along said curve through a central angle of 53°26'00" to the POINT OF BEGINNING.

Reserving therefrom an easement 30.00 feet wide measured at right angles from the southwesterly Right of Way of the above described portion of Whitesell Street for the purposes of maintenance, repair, operation and use for storm drainage, including all necessary appurtenances thereto, for the conducting, flowing and carrying therein and therethrough of water in, under, along and across that real property located in the City of Hayward, County of Alameda, State of California.

Reserving therefrom an easement 30.00 feet wide measured at right angles from the northeasterly Right of Way of the above described portion of Whitesell Street for waterline purposes, including routing, installation, use, maintenance, service and operation of a waterline, including all necessary appurtenances thereto, in, under, along and across that real property located in the City of Hayward, County of Alameda, State of California.
