



**MINUTES OF THE SPECIAL MEETING OF THE CITY COUNCIL**

The Special Meeting of the Hayward City Council was called to order by Mayor Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Mayor Halliday.

**CLOSED SESSION ANNOUNCEMENT**

City Attorney Lawson announced the City Council convened in closed session at 5:00 p.m., to discuss two items: (1) conference with labor negotiators pursuant to Government Code 54957.6 regarding all groups; and (2) public employment pursuant to Government Code 54957 regarding the City Manager's annual performance evaluation. City Attorney Lawson noted there was no reportable action related to Item 1 and Mayor Halliday added that there was no reportable action related to Item 2.

Mayor Halliday announced there was an English/Spanish interpreter available in the Council Chambers for those in need of assistance.

**PUBLIC COMMENTS**

Mr. Jim Gansemer, Hayward resident, requested assistance connecting with the Alameda County Registrar of Voters to establish in-person voting at Stonebrae.

Mr. Jim Drake, Hayward resident, had concerns about the reserved parking spaces on B Street; and expressed the need for more police officers in Hayward.

Ms. Faith Munn, Hayward resident, was concerned that tenants in her senior apartment complex were going to be evicted, and asked the City for tenant's protection.

Council Member Mendall disclosed he had to stand up during meetings due to a back injury.

Council Member Márquez noted she serves as the President of the Alameda County Mosquito Abatement District Board of Trustees and reported that a dead bird infested with West Niles virus was confirmed in Alameda County.

Mr. Zachariah Oquenda, Hayward resident, announced the South Alameda County Young Democrats was having events in June to address national issues.

## LEGISLATIVE BUSINESS

1. Emergency Ordinances Related to the Residential Rent Stabilization Ordinance (Report from City Manager McAdoo) **LB 18-018**

Staff report submitted by Assistant City Manager Hurtado, dated May 29, 2018, was filed.

City Manager McAdoo and Housing Division Manager Morales provided a synopsis of the staff report.

Discussion ensued among Council Members and City staff regarding Section 19 of the City of Hayward Residential Rent Stabilization Ordinance regarding eviction for cause; a moratorium on rent increases; a system to track and monitor complaints and other housing related issues; and resources for tenants such as Centro Legal de La Raza and Eden Council for Hope and Opportunity (ECHO) Housing.

Mayor Halliday opened the public hearing at 7:43 p.m.

The following individuals spoke in favor of the proposed emergency ordinance enacting a moratorium on decontrolled rental units; the proposed emergency ordinance amending Section 19 of the City's Residential Rent Stabilization Ordinance related to eviction for cause provisions; extending the "just cause" protection provision to all rental units; and considering a moratorium on rent increases for all decontrolled units, with no increases on units that have enacted an increase that is 5% or more in the past 12 months, applied to all notices from May 1, 2018 forward, and enacted for 18 months.

The following individuals expressed concerns with the proposed emergency ordinances indicating the situation did not warrant urgency; future policy needs to be driven by facts and data; the proposal would discourage having units inspected and brought up to safe standards; it would discourage investing in Hayward; it would penalize responsible landlords; it would cause rental units to become owner occupied; the no cause of eviction provision was a mechanism to deal with difficult tenants; and rents in Hayward were below market rate.

Mr. Ralph Morales, South Hayward Parish representative, noted the center distributes food to the needy to help them save for rent.

Mr. Jim Carney submitted a card but did not speak.

Mayor Halliday closed the public hearing at 9:30 p.m.

Mayor Halliday thanked members of the tenant and landlord communities for their input.

Council Member Márquez noted that the title, Paragraph D, and Paragraph F of the Emergency Ordinance amending Section 19 of the City's Residential Rent Stabilization Ordinance (Attachment III) was modified to strengthen its findings

In response to Mayor Halliday's request to address questions posed by public members, staff indicated: 1) the two proposed ordinances would not have an impact on Section 8 housing; 2) units that are not decontrolled would need to be identified and notification on the impact of the ordinance would follow; and 3) there are interventions when tenants are influenced to move to units that are not controlled.

Council Member Márquez offered a motion per staff's recommendation including the amendment to Attachment III. Council Member Zermeño seconded the motion.

There was general consensus among the City Council to adopt the proposed emergency ordinances offering the following: the action was a step in the right direction to address concerns expressed by community members; there was a desire to find a reasonable compromise to protect responsible tenants and landlords while punishing irresponsible landlords; explore having community meetings where stakeholders can address current issues and build a collective foundation to attract responsible investors; there needs to be innovation in creating different housing options, incentivizing and streamlining processes; pause pursuing the development of a mandatory mediation program; and concentrate efforts on a system to track complaints and collect data that would help make future decisions.

Mayor Halliday offered a friendly amendment to the motion directing staff to come back in nine (9) months to provide an update on the evaluation of decontrol of rental units under Section 8 of the City's Residential Rent Stabilization Ordinance.

Council Members Márquez and Zermeño were amenable to the friendly amendment.

It was moved by Council Member Márquez, seconded by Council Member Zermeño, and carried unanimously, to adopt the following with the amendment noted above:

Ordinance 18-06, "An Emergency Ordinance of the City Council of the City of Hayward Enacting a Moratorium on the Decontrol of Rental Units Pursuant to Section 8 of the City of Hayward's Residential Rent Stabilization Ordinance"

Ordinance 18-07, "An Emergency Ordinance of the City Council of the City of Hayward Amending Section 19 of the City of Hayward Residential Rent Stabilization Ordinance Clarifying the Applicability of Section 19 to Units that are Currently Rent Controlled and Were Previously Rent Controlled Pursuant to the Ordinance"

**COUNCIL REPORTS AND ANNOUNCEMENTS**


Council Member Salinas congratulated Chabot College 2018 graduates and wished California State University East Bay students good luck on their final exams.


